- 1.6 Section 1. Minnesota Statutes 2018, section 124D.151, subdivision 6, is amended to read:
- 1.7 Subd. 6. **Participation limits.** (a) Notwithstanding section 126C.05, subdivision 1,
- 1.8 paragraph (d), the pupil units for a voluntary prekindergarten program for an eligible school
- 1.9 district or charter school must not exceed 60 percent of the kindergarten pupil units for that
- 1.10 school district or charter school under section 126C.05, subdivision 1, paragraph (e).
- 1.11 ~~(b) In reviewing applications under subdivision 5, the commissioner must limit the~~
- 1.12 ~~estimated state aid entitlement approved under this section to \$27,092,000 for fiscal year~~
