1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2020, section 15.01, is amended to read:

1.10 **15.01 DEPARTMENTS OF THE STATE.**

1.11 The following agencies are designated as the departments of the state government: the

1.12 Department of Administration; the Department of Agriculture; the Department of Commerce;

1.13 the Department of Corrections; the Department of Education; the Department of Employment

1.14 and Economic Development; the Department of Health; the Department of Human Rights;

1.15 the Department of Information Technology Services; the Department of Iron Range

1.16 Resources and Rehabilitation; the Department of Labor and Industry; the Department of

1.17 Management and Budget; the Department of Military Affairs; the Department of Natural

1.18 Resources; the Department of Public Safety; the Department of Human Services; the

1.19 Department of Revenue; the Department of Transportation; the Department of Veterans

1.20 Affairs; and their successor departments.

2.2 **16E.01 OFFICE OF MN.IT MINNESOTA DEPARTMENT OF INFORMATION**
 2.3 **TECHNOLOGY SERVICES.**

2.4 Subdivision 1. **Creation; chief information officer.** The ~~Office of MN.IT~~ Minnesota
 2.5 Department of Information Technology Services, which may also be known as Minnesota
 2.6 Information Technology Services or Minnesota IT Services, referred to in this chapter as
 2.7 the "~~office,~~" "department," is an agency in the executive branch headed by a commissioner,
 2.8 who also is the ~~state~~ chief information officer. The appointment of the commissioner is
 2.9 subject to the advice and consent of the senate under section 15.066.

2.10 Subd. 1a. **Responsibilities.** The ~~office~~ department shall provide oversight, leadership,
 2.11 and direction for information and telecommunications technology policy and the
 2.12 management, delivery, accessibility, and security of executive branch information and
 2.13 telecommunications technology systems and services in Minnesota. The ~~office~~ department
 2.14 shall manage strategic investments in information and telecommunications technology
 2.15 systems and services ~~to encourage the development of a technically literate society,~~ to ensure
 2.16 sufficient access to and efficient delivery of accessible government services, and to maximize
 2.17 benefits for the state government as an enterprise.

2.18 Subd. 2. **Discretionary powers.** The ~~office~~ department may:

2.19 (1) enter into contracts for goods or services with public or private organizations and
 2.20 charge fees for services it provides;

2.21 (2) apply for, receive, and expend money from public agencies;

2.22 (3) apply for, accept, and disburse grants and other aids from the federal government
 2.23 and other public or private sources;

2.24 (4) enter into contracts with agencies of the federal government, local governmental
 2.25 units, the University of Minnesota and other educational institutions, and private persons
 2.26 and other nongovernmental organizations as necessary to perform its statutory duties;

2.27 (5) sponsor and conduct conferences and studies, collect and disseminate information,
 2.28 and issue reports relating to information and communications technology issues;

2.29 (6) review the technology infrastructure of regions of the state and cooperate with and
 2.30 make recommendations to the governor, legislature, state agencies, local governments, local
 2.31 technology development agencies, the federal government, private businesses, and individuals
 2.32 for the realization of information and communications technology infrastructure development
 2.33 potential;

3.1 (7) sponsor, support, and facilitate innovative and collaborative economic and community
3.2 development and government services projects, including technology initiatives related to
3.3 culture and the arts, with public and private organizations; and

3.4 (8) review and recommend alternative sourcing strategies for state information and
3.5 communications systems.

3.6 Subd. 3. **Duties.** (a) The ~~office~~ department shall:

3.7 (1) manage the efficient and effective use of available federal, state, local, and
3.8 public-private resources to develop statewide information and telecommunications technology
3.9 systems and services and its infrastructure;

3.10 (2) approve state agency and intergovernmental information and telecommunications
3.11 technology systems and services development efforts involving state or intergovernmental
3.12 funding, including federal funding, provide information to the legislature regarding projects
3.13 reviewed, and recommend projects for inclusion in the governor's budget under section
3.14 16A.11;

3.15 (3) ~~ensure~~ promote cooperation and collaboration among state and local governments
3.16 in developing intergovernmental information and telecommunications technology systems
3.17 and services, ~~and define the structure and responsibilities of a representative governance~~

3.19 (4) cooperate and collaborate with the legislative and judicial branches in the development

4.16 (b) The chief information officer, in consultation with the commissioner of management
4.17 and budget, must determine when it is cost-effective for agencies to develop and use shared
4.18 information and telecommunications technology systems and services for the delivery of
4.19 electronic government services. The chief information officer may require agencies to use
4.20 shared information and telecommunications technology systems and services. The chief
4.21 information officer shall establish reimbursement rates in cooperation with the commissioner
4.22 of management and budget to be billed to agencies and other governmental entities sufficient
4.23 to cover the actual development, operating, maintenance, and administrative costs of the
4.24 shared systems. The methodology for billing may include the use of interagency agreements,
4.25 or other means as allowed by law.

4.26 (c) A state agency that has an information and telecommunications technology project
4.27 ~~with a total expected project cost of more than \$1,000,000~~, whether funded as part of the
4.28 biennial budget or by any other means, shall register with the ~~office~~ department by submitting
4.29 basic project startup documentation, as specified by the chief information officer in both
4.30 format and content, ~~before any project funding is requested or committed and before the~~
4.31 ~~project commences~~. State agency project leaders must demonstrate that the project will be
4.32 properly managed, provide updates to the project documentation as changes are proposed,
4.33 and regularly report on the current status of the project on a schedule agreed to with the

5.1 chief information officer. The chief information officer has the authority to define a project
5.2 for the purposes of this chapter.

5.3 (d) The chief information officer shall monitor progress on any active information and
5.4 telecommunications technology project with a total expected project cost of more than
5.5 \$5,000,000 and report on the performance of the project in comparison with the plans for
5.6 the project in terms of time, scope, and budget. The chief information officer may conduct
5.7 an independent project audit of the project. The audit analysis and evaluation of the projects
5.8 subject to paragraph (c) must be presented to agency executive sponsors, the project
5.9 governance bodies, and the chief information officer. All reports and responses must become
5.10 part of the project record.

5.11 (e) For any active information and telecommunications technology project with a total
5.12 expected project cost of more than \$10,000,000, the state agency must perform an annual
5.13 independent audit that conforms to published project audit principles ~~promulgated~~ adopted
5.14 by the office department.

5.15 (f) The chief information officer shall report by January 15 of each year to the chairs
5.16 and ranking minority members of the legislative committees and divisions with jurisdiction
5.17 over the ~~office~~ department regarding projects the ~~office~~ department has reviewed under
5.18 paragraph (a), clause ~~(13)~~ (10). The report must include the reasons for the determinations
5.19 made in the review of each project and a description of its current status.

5.21 **16E.016 RESPONSIBILITY FOR INFORMATION TECHNOLOGY SERVICES**
5.22 **AND EQUIPMENT.**

5.23 (a) The chief information officer is responsible for providing or entering into managed
5.24 services contracts for the provision, improvement, and development of the following
5.25 information technology systems and services to state agencies:

5.26 (1) state data centers;

5.27 (2) mainframes including system software;

5.28 (3) servers including system software;

5.29 (4) desktops including system software;

5.30 (5) laptop computers including system software;

5.31 (6) a data network including system software;

6.1 (7) database, electronic mail, office systems, reporting, and other standard software
6.2 tools;

6.3 (8) business application software and related technical support services;

6.4 (9) help desk for the components listed in clauses (1) to (8);

6.5 (10) maintenance, problem resolution, and break-fix for the components listed in clauses
6.6 (1) to (8);

6.10 (b) All state agency employees whose work primarily involves functions specified in

6.12 Information Technology Services. This includes employees who directly perform the
6.13 functions in paragraph (a), as well as employees whose work primarily involves managing,
6.14 supervising, or providing administrative services or support services to employees who
6.15 directly perform these functions. The chief information officer may assign employees of
6.16 the ~~office~~ department to perform work exclusively for another state agency.

6.17 (c) Subject to sections 16C.08 and 16C.09, the chief information officer may allow a
6.18 state agency to obtain services specified in paragraph (a) through a contract with an outside
6.19 vendor when the chief information officer and the agency head agree that a contract would
6.20 provide best value, as defined in section 16C.02, under the service-level agreement. The
6.21 chief information officer must require that agency contracts with outside vendors ensure
6.22 that systems and services are compatible with standards established by the ~~Office of MN.IT~~
6.23 Department of Information Technology Services.

6.24 (d) The Minnesota State Retirement System, the Public Employees Retirement
6.25 Association, the Teachers Retirement Association, the State Board of Investment, the
6.26 Campaign Finance and Public Disclosure Board, the State Lottery, and the Statewide Radio
6.27 Board are not state agencies for purposes of this section.

6.30 **TECHNOLOGY SERVICES; STRUCTURE AND PERSONNEL.**

6.31 Subdivision 1. **Office Department management and structure.** (a) The chief
6.32 information officer is appointed by the governor. The chief information officer serves in

7.1 the unclassified service at the pleasure of the governor. The chief information officer must
 7.2 have experience leading enterprise-level information technology organizations. The chief
 7.3 information officer is the state's chief information officer and information and
 7.4 telecommunications technology ~~advisor~~ adviser to the governor.

7.5 (b) The chief information officer may appoint other employees of the ~~office~~ department.
 7.6 The Staff of the ~~office~~ department must include individuals knowledgeable in information
 7.7 and telecommunications technology systems and services and individuals with specialized

 7.18 chief information officer must consult regularly with ~~the~~ executive branch agency
 7.19 ~~commissioners of administration, management and budget, human services, revenue, and~~
 7.20 ~~other commissioners as designated by the governor,~~ on technology projects, standards, and
 7.21 services as well as management of resources and staff utilization.

7.23 Subdivision 1. **Definitions.** (a) For the purposes of this chapter, the following terms

8.6 includes the Minnesota Office of Higher Education, but does not include the Minnesota
8.7 State Colleges and Universities unless specifically provided elsewhere in this chapter.

8.8 ~~(g)~~ (f) "Total expected project cost" includes direct staff costs, all supplemental contract
8.9 staff and vendor costs, and costs of hardware and software development or purchase.
8.10 Breaking a project into several phases does not affect the cost threshold, which must be

16E.0466 STATE AGENCY TECHNOLOGY PROJECTS.

Subdivision 1. **Consultation required.** (a) Every state agency with an information or telecommunications project must consult with the Office of MN.IT Services to determine the information technology cost of the project. Upon agreement between the commissioner of a particular agency and the chief information officer, the agency must transfer the information technology cost portion of the project to the Office of MN.IT Services. Service level agreements must document all project-related transfers under this section. Those agencies specified in section 16E.016, paragraph (d), are exempt from the requirements of this section.

(b) Notwithstanding section 16A.28, subdivision 3, any unexpended operating balance appropriated to a state agency may be transferred to the information and telecommunications technology systems and services account for the information technology cost of a specific project, subject to the review of the Legislative Advisory Commission, under section 16E.21, subdivision 3.

16E.05 GOVERNMENT INFORMATION ACCESS.

Subd. 3. **Capital investment.** No state agency may propose or implement a capital investment plan for a state office building unless:

(1) the agency has developed a plan for increasing telecommuting by employees who would normally work in the building, or the agency has prepared a statement describing why such a plan is not practicable; and

(2) the plan or statement has been reviewed by the office.

16E.071 E-GOVERNMENT ADVISORY COUNCIL.

Subdivision 1. **E-Government Advisory Council established.** The E-Government Advisory Council is established for the purpose of improving online government information services to citizens and businesses.

Subd. 2. **Membership.** The council shall consist of nine members as follows:

(1) the state chief information officer or the chief information officer's designee;

(2) one public member appointed by the speaker of the house;

(3) one public member appointed by the senate Subcommittee on Committees of the Rules and Administration Committee;

(4) five members appointed by the governor representing state executive branch agencies that are actively involved with private businesses, the private business community, or the public; and

(5) one member appointed by the governor who is knowledgeable in public access to government data.

Subd. 3. **Initial appointments and first meeting.** Appointing authorities shall make the first appointments to the council by September 1, 2013. The first member appointed by the speaker of the house shall serve until the first Monday in January 2015. The governor shall designate three initial appointees to serve until the first Monday in January 2015. The term of the other three initial appointees of the governor and the first member appointed by the senate shall be until the first Monday in January 2017. The chief information officer or the chief information officer's designee shall convene the council's first meeting by November 1, 2013, and shall act as chair until the council elects a chair at its first meeting.

Subd. 4. **Terms; removal; vacancies; compensation.** Membership terms, removal of member, and filling of vacancies are as provided in section 15.059, except that members shall not receive compensation or be reimbursed for expenses and except that terms of initial appointees are as provided in subdivision 3.

Subd. 5. **Chair.** The council shall annually elect a chair from its members.

Subd. 6. **Duties.** The council shall recommend to the office the priority of North Star projects and online government information services to be developed and supported by convenience fee receipts. The council shall provide oversight on the convenience fee and its receipts in the North Star account. The council shall by majority quorum vote to recommend to approve or disapprove establishing the convenience fee on particular types of transactions, the fee amount, and any changes in the fee amount. If the convenience fee receipts are retained by or transferred to the private entity

in lieu of deposit in the North Star account, the council may audit the private entity's convenience fee receipts, expenses paid by the receipts, and associated financial statements.

Subd. 7. **Staff.** The office shall provide administrative support to the council.

Subd. 8. **Sunset.** The council shall expire the first Monday in January 2017.

Subd. 9. **Reports.** By June 1, 2014, and every year thereafter, the council shall report to the office with its recommendations regarding establishing the convenience fee, the fee amount, and changes to the fee amount.

16E.145 INFORMATION TECHNOLOGY APPROPRIATION.

An appropriation for a state agency information and telecommunications technology project must be made to the chief information officer. The chief information officer must manage and disburse the appropriation on behalf of the sponsoring state agency. Any appropriation for an information and telecommunications technology project made to a state agency other than the Office of MN.IT Services is transferred to the chief information officer.
