INFRASTRUCTURE RESILIENCE ADVISORY TASK FORCE. 1.5 Subdivision 1. Definition. For purposes of this section, "task force" means the 1.6 Infrastructure Resilience Advisory Task Force established in this section. 1.7 Subd. 2. Establishment. The Infrastructure Resilience Advisory Task Force is established 18 to evaluate issues related to coordination, sustainability, resiliency, and federal funding on 1.9 state, local, and private infrastructure in the state. 1.10 Subd. 3. **Membership.** (a) The task force consists of the following members: 1.11 (1) two members of the senate, with one appointed by the senate majority leader and 1.12 one appointed by the senate minority leader; 1.13 (2) two members of the house of representatives, with one appointed by the speaker of 1.14 the house and one appointed by the house minority leader; 1.15 (3) the commissioner of administration; 1.16 (4) the commissioner of agriculture; 1.17 (5) the commissioner of commerce; 1.18 (6) the commissioner of employment and economic development; 1.19 (7) the commissioner of health; 1.20

	Subd. 6. Meetings. (a) The commissioner of transportation must convene the first meeting

4.1	Subd. 7. Administration. (a) The Legislative Coordinating Commission must provide
4.2	administrative support to the task force and must assist in creation of the report under
4.3	subdivision 8.
4.4	(b) Upon request of the task force, a commissioner under subdivision 3 must provide
4.5	information and technical support.
4.6	(c) Members of the task force serve without compensation.
4.7	Subd. 8. Report required. By February 1, 2024, the task force must submit a report to
4.8	the governor and the legislative committees with jurisdiction over climate, economic
4.9	development, energy, infrastructure, natural resources, and transportation. At a minimum,
4.10	the report must:
4.11	(1) summarize the activities of the task force;
4.12	(2) provide findings and recommendations adopted by the task force; and
4.13	(3) include any draft legislation to implement the recommendations.
4.14	Subd. 9. Expiration. The task force expires June 30, 2024.
4.15	EFFECTIVE DATE. This section is effective the day following final enactment.
