Subd. 5. **Ages and terms.** (a) Every child between seven and 17 18 years of age must receive instruction unless the child has graduated. Every child under the age of seven who

Section 1. Minnesota Statutes 2014, section 120A.22, subdivision 5, is amended to read:

- is enrolled in a half-day kindergarten, or a full-day kindergarten program on alternate days, or other kindergarten programs shall receive instruction. Except as provided in subdivision
- 6, a parent may withdraw a child under the age of seven from enrollment at any time.
- (b) A school district by annual board action may require children subject to this subdivision to receive instruction in summer school. A district that acts to require children to receive instruction in summer school shall establish at the time of its action the criteria for determining which children must receive instruction.
- (c) A pupil 16 years of age or older who meets the criteria of section 124D.68, subdivision 2, and under clause (5) of that subdivision has been excluded or expelled from school or under clause (11) of that subdivision has been chronically truant may be referred to an area learning center. Such referral may be made only after consulting the principal, area learning center director, student, and parent or guardian and only if, in the school administrator's professional judgment, the referral is in the best educational interest of the pupil. Nothing in this paragraph limits a pupil's eligibility to apply to enroll in other eligible programs under section 124D.68.

(a) Each year the performance of every 2.12 child ages seven through 16 and every child ages 16 through 17 18 for which an initial 2.13 report was filed pursuant to section 120A.24, subdivision 1, after the child is 16 and who 2.14 is not enrolled in a public school must be assessed using a nationally norm-referenced 2.15 standardized achievement examination. The superintendent of the district in which the 2.16 child receives instruction and the person in charge of the child's instruction must agree about 2.17 the specific examination to be used and the administration and location of the examination. 2.18 (b) To the extent the examination in paragraph (a) does not provide assessment in 2.19 all of the subject areas in subdivision 9, the parent must assess the child's performance 2.20 in the applicable subject area. Subdivision 1. **Reports to superintendent.** (a) The person or nonpublic school in charge of providing instruction to a child must submit to the superintendent of the district in which the child resides the name, birth date, and address of the child; the annual tests intended to be used under section 120A.22, subdivision 11, if required; the name of each instructor; and evidence of compliance with one of the requirements specified in section 120A.22, subdivision 10:

- (1) by October 1 of the first school year the child receives instruction after reaching the age of seven;
- (2) within 15 days of when a parent withdraws a child from public school after age seven to provide instruction in a nonpublic school that is not accredited by a state-recognized accredited agency;
 - (3) within 15 days of moving out of a district; and

- (b) The person or nonpublic school in charge of providing instruction to a child between the ages of seven and 16 and every child ages 16 through <u>17 18</u> for which an initial report was filed pursuant to this subdivision after the child is 16 must submit, by October 1 of each school year, a letter of intent to continue to provide instruction under this section for all students under the person's or school's supervision and any changes to the information required in paragraph (a) for each student.
- (c) The superintendent may collect the required information under this section through an electronic or Web-based format, but must not require electronic submission of information under this section from the person in charge of reporting under this subdivision.
- 3.24 **EFFECTIVE DATE.** This section is effective for the 2015-2016 school year and 3.25 later.

 - Subd. 12. **Termination of enrollment.** A district may terminate the enrollment of a nonresident student enrolled under this section or section 124D.08 at the end of a school year if the student meets the definition of a habitual truant under section 260C.007, subdivision 19, the student has been provided appropriate services under chapter 260A, and the student's case has been referred to juvenile court. A district may also terminate the enrollment of a nonresident student over the age of 17 18 enrolled under this section if the student is absent without lawful excuse for one or more periods on 15 school days and has not lawfully withdrawn from school under section 120A.22, subdivision 8.

and who has not lawfully withdrawn from school under section 120A.22, subdivision 8.
