Subd. 4. **Contracts; administrative services.** (a) A health maintenance organization may contract with other persons for the provision of services, including, but not limited to, managerial and administration, marketing and enrolling, data processing, actuarial analysis, and billing services. If contracts are made with insurance companies or nonprofit health service plan corporations, such companies or corporations must be authorized to transact business in this state <u>and must be incorporated as a nonprofit corporation</u>.
