1.9	certification. (a) The commissioner of human services shall issue a mental health		
1.10	certification for adult foster care homes licensed under this chapter and Minnesota Rules,		
1.11	parts 9555.5105 to 9555.6265, that serve people with a primary diagnosis of mental		
1.12	illness where the home is not the primary residence of the license holder when a provider		
1.13	is determined to have met the requirements under paragraph (b). This certification is		
1.14	voluntary for license holders. The certification shall be printed on the license, and		
1.15	identified on the commissioner's public Web site.
