- (3) analyze individual components of recyclable materials' postcollection supply chain, from transportation and storage to processing and new product development, focusing on opportunities for value-added processing opportunities;
- (4) compile a schedule that indicates when the major elements of Minnesota's recycling infrastructure are expected to reach the end of their useful life and will need to be replaced, and at what estimated cost, and include the need for and cost of recycling infrastructure in areas that are currently unserved or underserved; and
- (5) report on current and planned research to develop new products incorporating the use of recycled materials and discuss future research needs and potential funding sources.
- (b) The analysis must include policy recommendations on ways the state can advance opportunities for new product and market development and help to increase the financial investment necessary for the state to reach its established recycling goals. By February 15, 2017, the commissioner of the Pollution Control Agency shall report the findings and recommendations of the analysis to the chairs and ranking minority members of the senate and house of representatives committees with jurisdiction over economic development, workforce issues, and environment.
