383E.17 HOUSING AND REDEVELOPMENT.

Subdivision 1. Housing and redevelopment authority. There is created in the 1.8 county of Anoka a public body corporate and politic, to be known as the Anoka County 1.9 Housing and Redevelopment Authority, having. Except as otherwise provided in this 1 10 section, the Anoka County Housing and Redevelopment Authority has all of the powers 1.11 and duties of a county authority and a county housing and redevelopment authority under 1.12 the provisions of the Municipal Housing and Redevelopment Act, Minnesota Statutes 1.13 1986, sections 462.411 to 462.711. For the purposes of applying the provisions of the 1.14 Municipal Housing and Redevelopment Act to Anoka County, the county has all of the 1.15 powers and duties of a municipality, the county board has all of the powers and duties of a 1 16 governing body, the chair of the county board has all of the powers and duties of a mayor, 1 17 and the area of operation includes the area within the territorial boundaries of the county 1.18 sections 469.001 to 469.047 and any other law. 1.19 Subd. 2.
