1.2	relating to state lands; authorizing public sale of certain tax-forfeited land that

1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. PUBLIC SALE OF TAX-FORFEITED LAND BORDERING PUBLIC
1.6	WATER; GRANT COUNTY.
1.7	(a) Notwithstanding Minnesota Statutes, sections 92.45 and 282.018, subdivision 1,
1.8	Grant County may sell the tax-forfeited land bordering public water that is described in
1.9	paragraph (c) under the remaining provisions of Minnesota Statutes, chapter 282.
1.10	(b) The conveyances must be in a form approved by the attorney general. The attorney
1.11	general may make changes to the land descriptions to correct errors and ensure accuracy.
1.12	(c) The land to be sold is located in Grant County and is described as:
1.13	(1) that part of Section 13, Township 127, Range 44, commencing at a point on
1.14	the southeasterly line of Third Street where the southwesterly line of Vienna Avenue
1.15	would intersect, if extended, in the city of Herman, according to the plat thereof; thence
1.16	southeasterly along the southwesterly line of Vienna Avenue, if extended, to the lake;
