BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 13 Section 1. RELEASE OF REVERSIONARY INTEREST; ANOKA COUNTY 1.4 LAND TRANSFER. 1.5 (a) Notwithstanding Laws 1998, chapter 407, article 7, section 1, subdivision 2, 1.6 paragraph (c), or other law to the contrary, the state shall extinguish the state's reversionary 1.7 interest in land transferred by deeds according to paragraph (b), and release Anoka County 1.8 from the requirement to use the land for governmental purposes. The release must be by quit 1.9 claim deed, for no consideration, in a form approved by the attorney general.
