1.5	Section 1. FLOOD HAZARD MITIGATION GRANTS; APPROPRIATIONS.
1.6	Subdivision 1. Appropriation. (a) \$1,450,000 is appropriated from the bond proceeds
1.7	fund to the commissioner of natural resources for the state share of a flood hazard mitigation
1.8	grant to the city of Nielsville for publicly owned capital improvements to prevent or alleviate
