Subdivision 1. Early childhood mental health consultation grants. (a) \$1,000,000 in fiscal year 2017 is appropriated from the general fund to the commissioner of human services for early childhood mental health consultation grants under Minnesota Statutes, section 245.4889, subdivision 1, paragraph (b), clause (14). Grants under this section shall be awarded proportionately among current grantees under Minnesota Statutes, section 245.4889, subdivision 1, paragraph (b), clause (9), based on the number of regions served by a grantee.

(b) For purposes of the grants in paragraph (a), mental health consultation includes staff training provided by a mental health professional with early childhood competency; regular on-site consultation to staff serving high-risk and low-income families; and

referrals to clinical services for parents and children with mental health conditions.
