Minnesota Statutes 2020, section 120B.024, subdivision 1, is amended to read: 1.5 Subdivision 1. Graduation requirements. (a) Students beginning 9th grade in the 1.6 2011-2012 school year and later must successfully complete the following high school level credits for graduation: 1.8 (1) four credits of language arts sufficient to satisfy all of the academic standards in 1.9 English language arts; 1.10 (2) three credits of mathematics, including an algebra II credit or its equivalent, sufficient 1.11 to satisfy all of the academic standards in mathematics; 1.12 (3) an algebra I credit by the end of 8th grade sufficient to satisfy all of the 8th grade 1.13 standards in mathematics; 1.14 (4) three credits of science, including at least one credit of biology, one credit of chemistry 1.15 or physics, and one elective credit of science. - (b) A school district is encouraged to offer a course for credit in government and citizenship to 11th or 12th grade students who begin 9th grade in the 2020-2021 school year and later, that satisfies the government and citizenship requirement in paragraph (a), clause (5).
- (c) Students beginning 9th grade in the 2023-2024 school year and later must successfully complete a personal finance course for credit during their senior year of high school. The course must include but is not limited to the following topics: creating a household budget; 2.10 taking out loans and accruing debt, including how interest works; home mortgages; how to 2.11 file taxes; the impact of student loan debt; and how to read a paycheck and payroll deductions. 2.12 A district may provide a personal finance course through in-person instruction, distance 2.13 instruction, or a combination of in-person and distance instruction. 2.14
