## Section 1. [256E.365] JOBS AND HEALTH INNOVATION GRANT PROGRAM FOR HARD-TO-EMPLOY MINNESOTANS.

Subdivision 1. **Establishment.** The commissioner of human services shall establish a grant program with the goal of creating new jobs for long-term and chronically unemployed Minnesotans who are frequent and costly users of state and county interventions and services. The targeted population for the grant program includes individuals who rely heavily on government services, such as veterans, recently incarcerated individuals, and individuals with mental health problems and chemical addiction.

### Subd. 2. **Objectives.** The grant program shall:

- (1) provide an incentive for the private employment sector to generate new employment opportunities for the targeted population; and
- (2) foster cross-agency collaboration at the state and local levels and reduce government costs by eliminating inefficiencies and applying best practices.
- Subd. 3. Selection of grant recipients. (a) Grants under this section shall be awarded by the commissioner of human services. Before any grants are awarded, a committee consisting of representatives from the Departments of Health, Human Services, and Employment and Economic Development, and the Minnesota Housing Finance Agency, shall meet to evaluate the grant applications and make recommendations to the commissioner on awarding the grants.

Sec. 2. 2 The commissioner of human services, in consultation with the commissioner of management and budget, shall calculate the savings generated to the state through reduced state spending on government services resulting from implementation of the grant program established in Minnesota Statutes, section 256E.365, and shall examine the feasibility of replenishing funding for the grant program by utilizing the anticipated savings. The commissioner of human services must report findings under this section to the senate and house of representatives committees with jurisdiction over human services by January 15, 2016.
