1.6	Section 1. Minnesota Statutes 2012, section 204C.35, subdivision 1, is amended to read:
1.7	Subdivision 1. Automatic Publicly funded recounts. (a) In a state primary when
1.8	the difference between the votes cast for the candidates for nomination to:
1.9	(1) a state legislative office is less than one-half of one percent of the total number of
1.10	votes counted for that nomination or is ten votes or less and the total number of votes cast
1.11	for the nomination is 400 votes or less; or
1.12	(2) a statewide federal office, state constitutional office, statewide judicial office,
1.13	congressional office, state legislative office, or district judicial office:

Subdivision 1. Required Publicly funded recounts. (a) Except as provided in 3.1 paragraph paragraphs (b) and (c), a losing candidate for nomination or election to a 3.2 county, municipal, or school district office may request a recount of the votes cast for 3.3 the nomination or election to that office if the difference between the vote cast for that 3.4 candidate and for a winning candidate for nomination or election is less than one-half 3.5 one-quarter of one percent of the total votes counted for that office. In case of offices where 3.6 two or more seats are being filled from among all the candidates for the office, the one-half 3.7 one-quarter of one percent difference is between the elected candidate with the fewest votes 3.8 and the candidate with the most votes from among the candidates who were not elected. 3.9 (b) A losing candidate for nomination or election to a county, municipal, or school 3.10

district office may request a recount of the votes cast for nomination or election to that 3.11 office if the difference between the votes cast for that candidate and for a winning 3.12 candidate for nomination or election is less than one-half of one percent, and the total 3.13 number of votes cast for the nomination or election of all candidates is more than 400 3.14 but less than 50,000. (b) (c) A losing candidate for nomination or election to a county, municipal, or 3.19 school district office may request a recount of the votes cast for nomination or election 3.20 to that office if the difference between the vote cast for that candidate and for a winning 3.21 candidate for nomination or election is ten votes or less, and the total number of votes cast 3.22 3.23 for the nomination or election of all candidates is no more than 400. In cases of offices where two or more seats are being filled from among all the candidates for the office, 3.24 the ten vote difference is between the elected candidate with the fewest votes and the 3.25 candidate with the most votes from among the candidates who were not elected. 3.26
