1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2016, section 609.748, subdivision 3, is amended to read:
1.7	Subd. 3. Contents of petition; hearing; notice. (a) A petition for relief must allege
1.8	facts sufficient to show the following:
1.9	(1) the name of the alleged harassment victim;
1.10	(2) the name of the respondent; and
1.11	(3) that the respondent has engaged in harassment.
1.12	A petition for relief must state whether the petitioner has had a previous restraining order
1.13	in effect against the respondent. The petition shall be accompanied by an affidavit made
1.14	under oath stating the specific facts and circumstances from which relief is sought. The
1.15	court shall provide simplified forms and clerical assistance to help with the writing and
1.16	filing of a petition under this section and shall advise the petitioner of the right to sue in
1.17	forma pauperis under section 563.01. The court shall advise the petitioner of the right to
1.18	request a hearing. If the petitioner does not request a hearing, the court shall advise the
1.19	petitioner that the respondent may request a hearing and that notice of the hearing date and
1.20	time will be provided to the petitioner by mail at least five days before the hearing. Upon
1.21	receipt of the petition and a request for a hearing by the petitioner, the court shall order a
1.22	hearing. Personal service must be made upon the respondent not less than five days before
1.23	the hearing. If personal service cannot be completed in time to give the respondent the

notice under section 645.11, if:

(b) The court may issue an order under paragraph (a) if all of the following occur: 3.3 (1) the petitioner has filed a petition under subdivision 3; 3.4 (2) the sheriff a peace officer has served respondent with a copy of the temporary 3.5 restraining order obtained under subdivision 4, and with notice of the right to request a 3.6 hearing, or service has been made by publication under subdivision 3, paragraph (b); and 3.7 (3) the court finds at the hearing that there are reasonable grounds to believe that the 3.8 respondent has engaged in harassment. 3.9 A restraining order may be issued only against the respondent named in the petition; except 3.10 that if the respondent is an organization, the order may be issued against and apply to all of 3.11 the members of the organization. If 3.29 the court finds that the respondent named in the restraining order has met the burden of 3.30 proof, the court may vacate or modify the order. If the court finds that the respondent named 3.31 in the restraining order has not met the burden of proof, the court shall deny the request and 3.32 no request may be made to vacate or modify the restraining order until five years have 3.33
