An original electronic or facsimile 2.6 prescription may be stored in an electronic database, provided that the database provides a 2.7 means by which original prescriptions can be retrieved, as transmitted to the pharmacy, for 28 a period of not less than two years. 2.9
- (e) Every licensed pharmacy shall distinctly label the container in which a controlled
   substance is dispensed with the directions contained in the prescription for the use of

- Subd. 1a. Prescription requirements for Schedule II controlled substances. No 2.13 person may dispense a controlled substance included in Schedule II of section 152.02 2.14 without a prescription written issued by a doctor of medicine, a doctor of osteopathy 2.15 licensed to practice medicine, a doctor of dental surgery, a doctor of dental medicine, a 2.16 doctor of podiatry, or a doctor of veterinary medicine, lawfully licensed to prescribe in this 2.17 state or by a practitioner licensed to prescribe controlled substances by the state in which 2.18 the prescription is issued, and having a current federal Drug Enforcement Administration 2.19 registration number. The prescription must either be printed or written in ink and contain 2.20 the handwritten signature of the prescriber or be transmitted electronically or by facsimile 2.21 as permitted under subdivision 1. Provided that in emergency situations, as authorized 2.22 2.23 by federal law, such drug may be dispensed upon oral prescription reduced promptly to writing and filed by the pharmacist. Written or oral Prescription requirement requirements for Schedule 3.4 **III or IV controlled substances.** No person may dispense a controlled substance included 3.5 in Schedule III or IV of section 152.02 without a written or oral prescription from issued, 3.6 as permitted under subdivision 1, by a doctor of medicine, a doctor of osteopathy licensed 3.7 to practice medicine, a doctor of dental surgery, a doctor of dental medicine, a doctor of 3.8 podiatry, a doctor of optometry limited to Schedule IV, or a doctor of veterinary medicine, 3.9 lawfully licensed to prescribe in this state or from a practitioner licensed to prescribe 3.10 controlled substances by the state in which the prescription is issued, and having a current 3.11 federal drug enforcement administration registration number. Such prescription may not 3.12 be dispensed or refilled except with the written or verbal documented consent of the 3.13 prescriber, and in no event more than six months after the date on which such prescription 3.14 was issued and no such prescription may be refilled more than five times. 3.15

3.16 Subd. 2a. Federal registration number exemption. A prescription need not
3.17 bear a federal drug enforcement administration registration number that authorizes the
3.18 prescriber to prescribe controlled substances if the drug prescribed is not a controlled
3.19 substance in Schedule II, III, IV, or V. No person shall impose a requirement inconsistent
3.20 with this subdivision.

Subd. 2b. Restriction on release of federal registration number. No person or 3.21 entity may offer for sale, sell, lease, or otherwise release a federal drug enforcement 3.22 administration registration number for any reason, except for drug enforcement purposes 3.23 authorized by this chapter and the federal controlled substances registration system. For 3.24 purposes of this section, an entity includes a state governmental agency or regulatory 3.25 board, a health plan company as defined under section 62Q.01, subdivision 4, a managed 3.26 care organization as defined under section 62Q.01, subdivision 5, or any other entity 3.27 that maintains prescription data. 3.28

3.29 Subd. 2c. **Restriction on use of federal registration number.** No entity may use a 3.30 federal drug enforcement administration registration number to identify or monitor the 3.31 prescribing practices of a prescriber to whom that number has been assigned, except for 3.32 drug enforcement purposes authorized by this chapter and the federal controlled substances 3.33 registration system. 4.5 valid photographic identification, unless the person purchasing the controlled substance,
4.6 or if applicable the person for whom the controlled substance prescription is written, is

(b) This subdivision applies only to purchases of controlled substances that are
not covered, in whole or in part, by a health plan company or other third-party payor.
The Board of Pharmacy shall report to the legislature by July 1, 2009, on the effect of
this subdivision. The board shall include in the report the incidence of complaints, if any,
generated by the requirements of this subdivision and whether this subdivision is creating
barriers to pharmaccutical access.
Subd. 3. Dispensing orphan drugs. For the purpose of subdivisions 1 and 2 this
