1.1 A bill for an act

1.2 relating to insurance; making changes to the life insurance reserves; amending

1.3 Minnesota Statutes 2014, sections 61A.24, subdivision 12, by adding a

1.4 subdivision; 61A.25.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2014, section 61A.24, is amended by adding a

1.7 subdivision to read:

1.8 Subd. 1a. **Definitions.** "Operative date of the valuation manual" means January 1 of

1.9 the first calendar year that the valuation manual, as defined in section 61A.25, subdivision

1.10 1a, is effective.

1.11 Sec. 2. Minnesota Statutes 2014, section 61A.24, subdivision 12, is amended to read:

1.12 Subd. 12. **Calculation of adjusted premiums by the nonforfeiture net level**

1.13 **premium method.** (a) This subdivision applies to all policies issued on or after its

1.14 operative date. Except as provided in paragraph (g), the adjusted premiums for a policy

1.15 shall be calculated on an annual basis and shall be the uniform percentage of the respective

1.16 premiums specified in the policy for each policy year, excluding amounts payable as extra

1.17 premiums to cover impairments or special hazards and also excluding any uniform annual

1.18 contract charge or policy fee specified in the policy in a statement of the method to be

1.19 used in calculating the cash surrender values and paid-up nonforfeiture benefits, that the

1.20 present value, at the date of issue of the policy, of all adjusted premiums shall be equal to

1.21 the sum of (1) the then present value of the future guaranteed benefits provided for by the

1.22 policy; (2) one percent of either the amount of insurance, if the insurance is uniform in

1.23 amount, or the average amount of insurance at the beginning of each of the first ten policy

2.1 years; and (3) 125 percent of the nonforfeiture net level premium as hereinafter defined. In
2.2 applying the percentage specified in clause (3), no nonforfeiture net level premium shall
2.3 be deemed to exceed four percent of either the amount of insurance, if the insurance is
2.4 uniform in amount, or the average amount of insurance at the beginning of each of the
2.5 first ten policy years. The date of issue of a policy for the purpose of this section is the
2.6 date as of which the rated age of the insured is determined.

2.7 (b) The nonforfeiture net level premium shall be equal to the present value, at the
2.8 date of issue of the policy, of the guaranteed benefits provided for by the policy divided
2.9 by the present value, at the date of issue of the policy, of an annuity of one per annum
2.10 payable on the date of issue of the policy and on each anniversary of the policy on which a
2.11 premium falls due.

2.12 (c) In the case of a policy which causes, on a basis guaranteed in the policy,
2.13 unscheduled changes in benefits or premiums, or which provides an option for changes
2.14 in benefits or premiums other than a change to a new policy, the adjusted premiums and
2.15 present values shall initially be calculated on the assumption that future benefits and
2.16 premiums do not change from those stipulated at the date of issue of the policy. At the
2.17 time of the change in the benefits or premiums the future adjusted premiums, nonforfeiture
2.18 net level premiums, and present values shall be recalculated on the assumption that future
2.19 benefits and premiums do not change from those stipulated by the policy immediately
2.20 after the change.

2.21 (d) Except as otherwise provided in paragraph (g), the recalculated future adjusted
2.22 premiums for a policy shall be the uniform percentage of the respective future premiums
2.23 specified in the policy for each policy year, excluding amounts payable as extra premiums
2.24 to cover impairments and special hazards, and also excluding any uniform annual contract
2.25 charge or policy fee specified in the policy in a statement of the method to be used in
2.26 calculating the cash surrender values and paid-up nonforfeiture benefits, that the present
2.27 value, at the time of change to the newly defined benefits or premiums, of all future
2.28 adjusted premiums shall be equal to the excess of: (1) the sum of the then present value of
2.29 the then future guaranteed benefits provided for by the policy, and the additional expense
2.30 allowance, if any, over; (2) the then cash surrender value, if any, or present value of any
2.31 paid-up nonforfeiture benefit under the policy.

2.32 (e) The additional expense allowance, at the time of the change to the newly defined
2.33 benefits or premiums, shall be the sum of: (1) one percent of the excess, if positive, of
2.34 the average amount of insurance at the beginning of each of the first ten policy years
2.35 subsequent to the change over the average amount of insurance prior to the change at the
2.36 beginning of each of the first ten policy years subsequent to the time of the most recent

3.1 previous change, or, if there has been no previous change, the date of issue of the policy;
3.2 and (2) 125 percent of the increase, if positive, in the nonforfeiture net level premium.

3.3 (f) The recalculated nonforfeiture net level premium shall be equal to the result
3.4 obtained by dividing clause (1) by clause (2) where clause (1) equals the sum of the
3.5 nonforfeiture net level premium applicable prior to the change times the present value of
3.6 an annuity of one per annum payable on each anniversary of the policy on or subsequent
3.7 to the date of the change on which a premium would have fallen due had the change not
3.8 occurred, and the present value of the increase in future guaranteed benefits provided for
3.9 by the policy; and clause (2) equals the present value of an annuity of one per annum
3.10 payable on each anniversary of the policy on or subsequent to the date of change on
3.11 which a premium falls due.

3.12 (g) Notwithstanding any other provisions of this subdivision to the contrary, in the
3.13 case of a policy issued on a substandard basis which provides reduced graded amounts of
3.14 insurance so that, in each policy year, the policy has the same tabular mortality cost as
3.15 an otherwise similar policy issued on the standard basis which provides higher uniform
3.16 amounts of insurance, adjusted premiums and present values for the substandard policy
3.17 may be calculated as if it were issued to provide the higher uniform amounts of insurance
3.18 on the standard basis.

3.19 (h) All adjusted premiums and present values referred to in this subdivision shall:
3.20 for all policies of ordinary insurance be calculated on the basis of the Commissioners 1980
3.21 Standard Ordinary Mortality Table, or at the election of the company for any one or more
3.22 specified plans of life insurance, the Commissioners 1980 Standard Ordinary Mortality
3.23 Table with Ten-Year Select Mortality Factors; for all policies of industrial insurance be
3.24 calculated on the basis of the Commissioners 1961 Standard Industrial Mortality Table;
3.25 and for all policies issued in a particular calendar year be calculated on the basis of a
3.26 rate of interest not exceeding the nonforfeiture interest rate as defined in this section for
3.27 policies issued in that calendar year. However:

3.28 (1) at the option of the company, calculations for all policies issued in a particular
3.29 calendar year may be made on the basis of a rate of interest not exceeding the nonforfeiture
3.30 interest rate, as defined in this subdivision, for policies issued in the immediately
3.31 preceding calendar year;

3.32 (2) under a paid-up nonforfeiture benefit, including any paid-up dividend additions,
3.33 any cash surrender value available, whether or not required by subdivision 2, shall be
3.34 calculated on the basis of the mortality table and rate of interest used in determining the
3.35 amount of the paid-up nonforfeiture benefit and paid-up dividend additions, if any;

4.1 (3) a company may calculate the amount of a guaranteed paid-up nonforfeiture
4.2 benefit including any paid-up additions under the policy on the basis of an interest rate no
4.3 lower than that specified in the policy for calculating cash surrender values;

4.4 (4) in calculating the present value of paid-up term insurance with accompanying
4.5 pure endowment, if any, offered as a nonforfeiture benefit, the rates of mortality assumed
4.6 may be not more than those shown in the commissioners 1980 Extended Term Insurance
4.7 Table for policies of ordinary insurance and not more than the Commissioners 1961
4.8 Industrial Extended Term Insurance Table for policies of industrial insurance;

4.9 (5) for insurance issued on a substandard basis, the calculation of any adjusted
4.10 premiums and present values may be based on appropriate modifications of these tables;

4.11 (6)(i) for policies issued prior to the operative date of the valuation manual, any
4.12 commissioner's standard ordinary mortality tables, including any adopted after 1980 by
4.13 the National Association of Insurance Commissioners, that are approved by rule adopted
4.14 by the commissioner for use in determining the minimum nonforfeiture standard may
4.15 be substituted for the Commissioners 1980 Standard Ordinary Mortality Table with or
4.16 without Ten-Year Select Mortality Factors or for the Commissioners 1980 Extended
4.17 Term Insurance Table; and

4.18 (ii) for policies issued on or after the operative date of the valuation manual,
4.19 the valuation manual shall provide the commissioner's standard mortality table for use
4.20 in determining the minimum nonforfeiture standard that may be substituted for the
4.21 Commissioners 1980 Standard Ordinary Mortality Table with or without Ten-Year Select
4.22 Mortality Factors or for the Commissioners 1980 Extended Term Insurance Table. If the
4.23 commissioner approves by rule any commissioner's standard ordinary mortality table
4.24 adopted by the National Association of Insurance Commissioners for use in determining
4.25 the minimum nonforfeiture standard for policies issued on or after the operative date of
4.26 the valuation manual, then that minimum nonforfeiture standard supersedes the minimum
4.27 nonforfeiture standard provided by the valuation manual;

4.28 (7)(i) for policies issued prior to the operative date of the valuation manual, any
4.29 commissioner's standard industrial mortality tables, including any adopted after 1980 by
4.30 the National Association of Insurance Commissioners, that are approved by rule adopted
4.31 by the commissioner for use in determining the minimum nonforfeiture standard may
4.32 be substituted for the Commissioners 1961 Standard Industrial Mortality Table or the
4.33 Commissioners 1961 Industrial Extended Term Insurance Table; and

4.34 (ii) for policies issued on or after the operative date of the valuation manual,
4.35 the valuation manual shall provide the commissioner's standard mortality table for use
4.36 in determining the minimum nonforfeiture standard that may be substituted for the

5.1 Commissioners 1961 Standard Industrial Mortality Table or the Commissioners 1961
 5.2 Industrial Extended Term Insurance Table. If the commissioner approves by rule any
 5.3 commissioner's standard industrial mortality table adopted by the National Association of
 5.4 Insurance Commissioners for use in determining the minimum nonforfeiture standard for
 5.5 policies issued on or after the operative date of the valuation manual, then that minimum
 5.6 nonforfeiture standard supersedes the minimum nonforfeiture standard provided by the
 5.7 valuation manual.

5.8 (i) The nonforfeiture interest rate is defined in clauses (1) and (2):

5.9 (1) for policies issued prior to the operative date of the valuation manual, the
 5.10 nonforfeiture interest rate per annum for a policy issued in a particular calendar year shall
 5.11 be equal to 125 percent of the calendar year statutory valuation interest rate for the policy
 5.12 as defined in section 61A.25, rounded to the nearer one-quarter of one percent; provided,
 5.13 however, that the nonforfeiture interest rate shall not be less than four percent; and

5.14 (2) for policies issued on and after the operative date of the valuation manual, the
 5.15 nonforfeiture interest rate per annum for any policy issued in a particular calendar year
 5.16 shall be provided by the valuation manual.

5.17 (j) Notwithstanding any other provision in this chapter to the contrary, a refiling of
 5.18 nonforfeiture values or their methods of computation for any previously approved policy
 5.19 form which involves only a change in the interest rate or mortality table used to compute
 5.20 nonforfeiture values shall not require refiling of any other provisions of that policy form.

5.21 (k) After August 1, 1982, a company may file with the commissioner a written notice
 5.22 of its election to comply with the provision of this section after a specified date before
 5.23 January 1, 1989, which shall be the operative date of this subdivision for the company.
 5.24 If a company makes no election, the operative date of this subdivision for the company
 5.25 shall be January 1, 1989.

5.26 Sec. 3. Minnesota Statutes 2014, section 61A.25, is amended to read:

5.27 **61A.25 STANDARD VALUATION LAW.**

5.28 Subdivision 1. **Citation.** This section shall be known as the "Standard Valuation
 5.29 Law."

5.30 Subd. 1a. **Definitions.** (a) For the purposes of this section, the terms defined in this
 5.31 subdivision have the meanings given them.

5.32 (b) "Accident and health insurance" means contracts that incorporate morbidity risk
 5.33 and provide protection against economic loss resulting from accident, sickness, or medical
 5.34 conditions and as may be specified in the valuation manual.

6.1 (c) "Appointed actuary" means a qualified actuary who is appointed in accordance
6.2 with the valuation manual to prepare the actuarial opinion required in subdivision 2d.

6.3 (d) "Company" means an entity that (1) has written, issued, or reinsured life
6.4 insurance contracts, accident and health insurance contracts, or deposit-type contracts
6.5 in this state and has at least one such policy in force or on claim, or (2) has written,
6.6 issued, or reinsured life insurance contracts, accident and health insurance contracts, or
6.7 deposit-type contracts in any state and is required to hold a certificate of authority to write
6.8 life insurance, accident and health insurance, or deposit-type contracts in this state.

6.9 (e) "Deposit-type contract" means contracts that do not incorporate mortality or
6.10 morbidity risks and as may be specified in the valuation manual.

6.11 (f) "Life insurance" means contracts that incorporate mortality risk, including
6.12 annuity and pure endowment contracts, and as may be specified in the valuation manual.

6.13 (g) "NAIC" means the National Association of Insurance Commissioners.

6.14 (h) "Operative date of the valuation manual" means January 1 of the first calendar
6.15 year that the valuation manual is effective.

6.16 (i) "Policyholder behavior" means an action a policyholder, contract holder, or any
6.17 other person with the right to elect options, such as a certificate holder, may take under a
6.18 policy or contract subject to this section including, but not limited to, lapse, withdrawal,
6.19 transfer, deposit, premium payment, loan, annuitization, or benefit elections prescribed by
6.20 the policy or contract, but excluding events of mortality or morbidity that result in benefits
6.21 prescribed in their essential aspects by the terms of the policy or contract.

6.22 (j) "Principle-based valuation" means a reserve valuation that uses one or more
6.23 methods or one or more assumptions determined by the insurer and is required to comply
6.24 with subdivision 11, as specified in the valuation manual.

6.25 (k) "Qualified actuary" means an individual who is qualified to sign the applicable
6.26 statement of actuarial opinion in accordance with the American Academy of Actuaries
6.27 qualification standards for actuaries signing such statements and who meets the
6.28 requirements specified in the valuation manual.

6.29 (l) "Tail risk" means a risk that occurs either where the frequency of low probability
6.30 events is higher than expected under a normal probability distribution or where there are
6.31 observed events of significant size or magnitude.

6.32 (m) "Valuation manual" means the manual of valuation instructions adopted by the
6.33 NAIC as specified in this section or as subsequently amended.

6.34 **Subd. 2. Valuation of reserves; policies and contracts issued prior to the**
6.35 **operative date of the valuation manual.** (a) The commissioner shall cause to be valued
6.36 annually the reserve liabilities, hereinafter called reserves, for all outstanding life insurance

7.1 policies and annuity and pure endowment contracts of every life insurance company doing
7.2 business in this state, except that in the case of a foreign or alien insurer such valuation shall
7.3 be limited to its insurance transactions in the United States, ~~and may certify the amount~~
7.4 ~~of any such reserves, specifying the mortality table or tables, rate or rates of interest and~~
7.5 ~~methods (net level premium method or other) used in calculation of such reserves~~ issued on
7.6 or after the operative date of Laws 1947, chapter 182, and prior to the operative date of the
7.7 valuation manual. In calculating such reserves, the commissioner may use group methods
7.8 and approximate averages for fractions of a year or otherwise. In lieu of the valuation
7.9 of the reserves herein required of any foreign or alien company, the commissioner may
7.10 accept any valuation made, or caused to be made, by the insurance supervisory official of
7.11 any state or other jurisdiction when such valuation complies with the minimum standard
7.12 herein provided ~~and if the official of such state or jurisdiction accepts as sufficient and~~
7.13 ~~valid for all legal purposes the certificate of valuation of the commissioner when such~~
7.14 ~~certificate states the valuation to have been made in a specified manner according to which~~
7.15 ~~the aggregate reserves would be at least as large as if they had been computed in the~~
7.16 ~~manner prescribed by the law of that state or jurisdiction~~ in this section. In the case of
7.17 insurance issued by a domestic insurer upon the lives of residents of a foreign country, the
7.18 commissioner may vary the mortality standard to a standard applicable to that country.

7.19 (b) The provisions in subdivisions 3, 3a, 3b, 4, 4a, 5, 6, 7, 8, and 9 shall apply to all
7.20 policies and contracts, as appropriate, subject to this section issued on or after the operative
7.21 date of Laws 1947, chapter 182, and, prior to the operative date of the valuation manual and
7.22 the provisions in subdivisions 10 and 11, shall not apply to any such policies and contracts.

7.23 (c) The minimum standard for the valuation of policies and contracts issued prior
7.24 to the operative date of Laws 1947, chapter 182, shall be that provided by the laws in
7.25 effect immediately prior to that date.

7.26 Subd. 2a. **Actuarial opinion of reserves prior to the operative date of the**
7.27 **valuation manual; general.** (a) Every life insurance company doing business in this
7.28 state shall annually submit the opinion of a qualified actuary as to whether the reserves
7.29 and related actuarial items held in support of the policies and contracts specified by the
7.30 commissioner by rule are computed appropriately, are based on assumptions which satisfy
7.31 contractual provisions, are consistent with prior reported amounts, and comply with
7.32 applicable laws of this state. The commissioner may by rule define the specifics of this
7.33 opinion and add any other items considered to be necessary to its scope. The opinion must
7.34 be included in the company's annual statement.

7.35 (b) The requirement to annually submit the opinion of a qualified actuary applies
7.36 to service plan corporations licensed under chapter 62C, to legal service plans licensed

8.1 under chapter 62G, and to all fraternal benefit societies except those societies paying
8.2 only sick benefits not exceeding \$250 in any one year, or paying funeral benefits of not
8.3 more than \$350, or aiding those dependent on a member not more than \$350, nor any
8.4 subordinate lodge or council which is, or whose members are, assessed for benefits which
8.5 are payable by a grand body.

8.6 (c) The opinion applies to all business in force, including individual and group
8.7 health insurance plans, and must be based on standards adopted by the Actuarial Standards
8.8 Board. The opinion must be acceptable to the commissioner in both form and substance.

8.9 (d) In the case of an opinion required to be submitted by a foreign or alien company,
8.10 the commissioner may accept the opinion filed by that company with the insurance
8.11 supervisory official of another state if the commissioner determines that the opinion
8.12 reasonably meets the requirements applicable to a company domiciled in this state.

8.13 (e) For the purposes of this section, "qualified actuary" means a member in good
8.14 standing of the American Academy of Actuaries who meets the requirements specified
8.15 in the regulations.

8.16 (f) The board of directors of every insurer subject to this section shall appoint a
8.17 qualified actuary to sign its actuarial opinion. The appointment of the qualified actuary
8.18 shall be approved by the commissioner. The qualified actuary so appointed may be an
8.19 employee of the insurer. Notice of the appointment, including a copy of the board of
8.20 directors' resolution, and the date of appointment shall be filed with the commissioner.
8.21 The notice may be filed before or at the time the actuarial opinion is submitted. The
8.22 notice shall state the qualifications of the actuary. If the board appoints a new actuary to
8.23 sign actuarial opinions during the year, the commissioner shall be notified of the new
8.24 appointment and the reason for change.

8.25 (g) Except in cases of fraud or willful misconduct, the qualified actuary is not liable
8.26 for damages to any person, other than the insurance company and the commissioner, for
8.27 any act, error, omission, decision, or conduct with respect to the actuary's opinion.

8.28 (h) A memorandum, in form and substance acceptable to the commissioner based on
8.29 standards adopted by the Actuarial Standards Board and on additional standards as the
8.30 commissioner may by rule prescribe, must be prepared to support each actuarial opinion.

8.31 (i) If the insurance company fails to provide a supporting memorandum at the request
8.32 of the commissioner within a period specified by the commissioner, or the commissioner
8.33 determines that the supporting memorandum provided by the insurance company fails
8.34 to meet the standards based on standards adopted by the Actuarial Standards Board
8.35 and on additional standards as the commissioner may by rule prescribe or is otherwise
8.36 unacceptable to the commissioner, the commissioner may engage a qualified actuary at the

9.1 expense of the company to review the opinion and the basis for the opinion and prepare
9.2 the required supporting memorandum. The commissioner may only seek reimbursement
9.3 from a company for the actual expenses incurred by an actuary in reviewing or preparing a
9.4 supporting memorandum for that company.

9.5 (j) Any memorandum in support of the opinion, and any other material provided
9.6 by the company to the commissioner in connection with the memorandum, must be
9.7 kept confidential by the commissioner and must not be made public and is not subject
9.8 to subpoena, other than for the purpose of defending an action seeking damages from
9.9 any person by reason of any action required by this section or by rules promulgated
9.10 under this section. The memorandum or other material may otherwise be released by
9.11 the commissioner (1) with the written consent of the company or (2) to the American
9.12 Academy of Actuaries upon request stating that the memorandum or other material
9.13 is required for the purpose of professional disciplinary proceedings and setting forth
9.14 procedures satisfactory to the commissioner for preserving the confidentiality of the
9.15 memorandum or other material. Once any portion of the confidential memorandum is
9.16 cited by the company in its marketing or is cited before any governmental agency other
9.17 than a state insurance department or is released by the company to the news media, all
9.18 portions of the confidential memorandum are no longer confidential.

9.19 Subd. 2b. **Actuarial analysis prior to the operative date of the valuation manual.**

9.20 (a) Every life insurance company, except as exempted by or pursuant to regulation, shall
9.21 also annually include in the opinion required under subdivision 2a, paragraph (a), an
9.22 opinion of the same qualified actuary as to whether the reserves and related actuarial
9.23 items, including page 3, line 10, of the annual statement, held in support of the policies
9.24 and contracts specified by the commissioner, when considered in light of the assets held
9.25 by the company with respect to the reserves and related actuarial items, including but not
9.26 limited to the investment earnings on the assets and the considerations anticipated to be
9.27 received and retained under the policies and contracts, make adequate provision for the
9.28 company's obligations under the policies and contracts, including but not limited to the
9.29 benefits under and expenses associated with the policies and contracts.

9.30 (b) The commissioner may provide by rule for a transition period for establishing
9.31 any higher reserves which the qualified actuary may consider necessary in order to give
9.32 the opinion required under subdivision 2a.

9.33 Subd. 2c. **Valuation of reserves; policies and contracts issued on or after the**
9.34 **operative date of the valuation manual.** (a) The commissioner shall annually value,
9.35 or cause to be valued, the reserve liabilities referred to in this section as reserves for all
9.36 outstanding life insurance contracts, annuity and pure endowment contracts, accident

10.1 and health contracts, and deposit-type contracts of every company issued on or after the
10.2 operative date of the valuation manual. In lieu of the valuation of the reserves required of
10.3 a foreign or alien company, the commissioner may accept a valuation made, or caused to
10.4 be made, by the insurance supervisory official of any state or other jurisdiction when the
10.5 valuation complies with the minimum standard provided in this section.

10.6 (b) The provisions in subdivisions 10 and 11 shall apply to all policies and contracts
10.7 issued on or after the operative date of the valuation manual.

10.8 Subd. 2d. **Actuarial opinion of reserves after the operative date of the valuation**
10.9 **manual; general and actuarial analysis.** (a) Every company with outstanding life
10.10 insurance contracts, accident and health insurance contracts, or deposit-type contracts in
10.11 this state and subject to regulation by the commissioner shall annually submit the opinion
10.12 of the appointed actuary as to whether the reserves and related actuarial items held in
10.13 support of the policies and contracts are computed appropriately, are based on assumptions
10.14 that satisfy contractual provisions, are consistent with prior reported amounts, and comply
10.15 with applicable laws of this state. The valuation manual will prescribe the specifics of this
10.16 opinion, including any items deemed to be necessary to its scope.

10.17 (b) Every company with outstanding life insurance contracts, accident and health
10.18 insurance contracts, or deposit-type contracts in this state and subject to regulation by
10.19 the commissioner, except as exempted in the valuation manual, shall annually include
10.20 in the opinion required by paragraph (a) an opinion of the same appointed actuary as
10.21 to whether the reserves and related actuarial items held in support of the policies and

10.30 (1) a memorandum, in form and substance as specified in the valuation manual, and
10.31 acceptable to the commissioner, shall be prepared to support each actuarial opinion; and

10.32 (2) if the company fails to provide a supporting memorandum at the request of the
10.33 commissioner within a period specified in the valuation manual or the commissioner
10.34 determines that the supporting memorandum provided by the company fails to meet
10.35 the standards prescribed by the valuation manual or is otherwise unacceptable to
10.36 the commissioner, the commissioner may engage a qualified actuary at the expense

11.1 of the company to review the opinion and the basis for the opinion and prepare the
11.2 supporting memorandum required by the commissioner. The commissioner may only
11.3 seek reimbursement from a company for the actual expenses incurred by an actuary in
11.4 reviewing or preparing a supporting memorandum for that company.

11.25 appointed actuary for failure to satisfy the requirements of this subdivision.

20.24 disregarded in the determination of modified net premiums.

20.25 (d) For a universal life insurance policy that guarantees coverage to remain in
20.26 force as long as the accumulation of premiums paid satisfies a secondary guarantee
20.27 requirement, reserves according to the commissioners reserve valuation method may be
20.28 calculated using a lapse assumption only in accordance with and in the circumstances
20.29 described in the National Association of Insurance Commissioners' accounting practices
20.30 and procedures manual.

20.31 Subd. 4a. **Annuity and pure endowment contracts.** This subdivision shall
20.32 apply to all annuity and pure endowment contracts other than group annuity and pure
20.33 endowment contracts purchased under a retirement plan or plan of deferred compensation,
20.34 established or maintained by an employer, including but not limited to a partnership
20.35 or sole proprietorship, or by an employee organization, or by both, other than a plan

21.1 providing individual retirement accounts or individual retirement annuities under Section

21.3 Reserves according to the commissioner's annuity reserve method for benefits under

21.7 nonforfeiture benefits, provided for by the contracts at the end of each respective contract
21.8 year, over the present value, at the date of valuation, of any future valuation considerations
21.9 derived from future gross considerations, required by the terms of the contract, that
21.10 become payable prior to the end of the respective contract year. The future guaranteed
21.11 benefits shall be determined by using the mortality table, if any, and the interest rate,
21.12 or rates, specified in the contracts for determining guaranteed benefits. The valuation
21.13 considerations are the portions of the respective gross considerations applied under the
21.14 terms of the contracts to determine nonforfeiture values.

21.15 Subd. 5. **Minimum aggregate reserves.** A company's aggregate reserves for all life

23.29 Insurance Commissioners in 2009, or legislation including substantially similar terms
23.30 and provisions, has been enacted by at least 42 of the following 55 jurisdictions: the 50
23.31 states of the United States, American Samoa, the American Virgin Islands, the District of
23.32 Columbia, Guam, and Puerto Rico.

23.33 (c) Unless a change in the valuation manual specifies a later effective date, changes
23.34 to the valuation manual shall be effective on January 1 following the date when the change
23.35 to the valuation manual has been adopted by the National Association of Insurance
23.36 Commissioners by an affirmative vote representing:

24.1 (1) at least three-fourths of the members of the National Association of Insurance

24.15 (iii) minimum reserves for all other policies or contracts subject to subdivision 2c;

24.16 (2) the policies or contracts or types of policies or contracts that are subject to the
24.17 requirements of a principle-based valuation in subdivision 11, paragraph (a), and the
24.18 minimum valuation standards consistent with those requirements;

24.19 (3) for policies and contracts subject to a principle-based valuation under subdivision
24.20 11:

24.21 (i) requirements for the format of reports to the commissioner under subdivision 11,
24.22 paragraph (b), clause (3), which shall include information necessary to determine if the
24.23 valuation is appropriate and in compliance with this section;

24.24 (ii) assumptions shall be prescribed for risks over which the company does not

27.16 (5) any documents, materials, data, and other information submitted by a company

28.32 specified in paragraph (a), clauses (1) and (4):

29.24 (a) The commissioner of commerce shall consult and work in cooperation with the

29.27 training of Department of Commerce staff and reviewing opinions, memorandums, or
