(a) Unless the requirements under 2.3 paragraphs (b) to (d) have been met, a state agency and any local unit of government are 2.4 prohibited from submitting an application or request for federal funds, or entering into an 2.5 agreement that provides federal funds, for a guideway or busway capital project. 2.6 (b) The state agency or local unit of government must develop a summary financial plan 2.7 that meets the requirements under subdivision 1a, and must prepare an estimate of the transit 2.8 facility's life cycle cost that, at a minimum: 2.9 (1) identifies the comprehensive costs of (i) initial construction, including but not limited 2.10 to design, engineering, environmental analysis, land acquisition, and construction, and (ii) 2.11 2.12 capital maintenance, repair, replacement, improvements, and facility expansion; (2) uses the greater of 25 years or the design life of the facility; and 2.13 (3) is developed using a standard methodology and assumptions that are identified in 2.14 detail as part of the analysis. 2.15 (c) The state agency or local unit of government must submit the financial plan and life 2.16 cycle cost estimate to the legislative auditor.
