1.11	(a) \$474,000 the first year and \$474,000 the		
1.12	second year are for payments to county and		
1.13	district agricultural societies and associations		
1.14	under Minnesota Statutes, section 38.02,		
1.15	subdivision 1. Aid payments to county and		
1.16	district agricultural societies and associations		
1.17	shall be disbursed no later than July 15 of each		
1.18	year. These payments are the amount of aid
