1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. [13.3655] ATTORNEY GENERAL DATA CODED ELSEWHERE.
1.8	Subdivision 1. Scope. The sections referred to in this section are codified outside this
1.9	chapter. Those sections classify attorney general data as other than public, place restrictions
1.10	on access to government data, or involve data sharing.
1.11	Subd. 2. Jailhouse witnesses. Data collected and maintained by the attorney general
1.12	regarding jailhouse witnesses are governed by section 634.045.

1.15	Subdivision 1. Definitions. (a) As used in this section, the following terms have the
1.16	meanings given.
1.17	(b) "Benefit" means any plea bargain, bail consideration, reduction or modification of
1.18	sentence, or any other leniency, immunity, financial payment, reward, or amelioration of
1.19	current or future conditions of incarceration offered or provided in connection with, or in
1.20	exchange for, testimony that is offered or provided by a jailhouse witness.
1.21	(c) "Jailhouse witness" means a person who (1) while incarcerated, claims to have
1.22	obtained information from a defendant in a criminal case or a person suspected to be the

2.1	perpetrator of an offense, and (2) offers or provides testimony concerning statements made
2.2	by that defendant or person suspected to be the perpetrator of an offense. It does not mean

2.5	Subd. 2. Use of and benefits provided to jailhouse witnesses; data collection. (a)
2.6	Each county attorney shall report to the attorney general:
2.7	(1) the substance and use of any testimony of a jailhouse witness against the interest of
2.8	a suspect or defendant, regardless of whether such testimony is presented at trial; and
2.9	(2) the jailhouse witness's agreement to cooperate with the prosecution and any benefit
2.10	that the prosecutor has offered or may offer in the future to the jailhouse witness in connection
2.11	with the testimony.
2.12	(b) The attorney general shall maintain a statewide database containing the information
2.13	received pursuant to paragraph (a).
2.14	(c) Data collected and maintained pursuant to this subdivision are classified as confidential

3.12	(b) A prosecutor has a continuing duty of disclosure before and during trial. If, after the
3.13	omnibus hearing held pursuant to rule 11 of the Rules of Criminal Procedure, a prosecutor
3.14	discovers additional material, information, or witnesses subject to disclosure under this
3.15	subdivision, the prosecutor must promptly notify the court and defense counsel, or, if the
3.16	defendant is not represented, the defendant, of what was discovered. If the court finds that
3.17	the jailhouse witness was not known or that materials in paragraph (a) could not be discovered
3.18	or obtained by the state within that period with the exercise of due diligence, the court may
3.19	order that disclosure take place within a reasonable period. Upon good cause shown, the
3.20	court may continue the proceedings.
3.21	(c) If the prosecutor files a written certificate with the trial court that disclosing the
3.22	information described in paragraph (a) would subject the jailhouse witness or other persons
3.23	to physical harm or coercion, the court may order that the information must be disclosed to
3.24	the defendant's counsel but may limit disclosure to the defendant in a way that does not
3.25	unduly interfere with the defendant's right to prepare and present a defense, including limiting
3.26	disclosure to nonidentifying information.
3.27	Subd. 5. Victim notification. (a) A prosecutor shall make every reasonable effort to
3.28	notify a victim if the prosecutor has decided to offer or provide any of the following to a
3.29	jailhouse witness in exchange for, or as the result of, a jailhouse witness offering or providing
3.30	testimony against a suspect or defendant:
3.31	(1) reduction or dismissal of charges;
3.32	(2) a plea bargain;
3.33	(3) support for a modification of the amount or conditions of bail; or

(b) Efforts to notify the victim should include, in order of priority: (1) contacting the
victim or a person designated by the victim by telephone; and (2) contacting the victim by
mail. If a jailhouse witness is still in custody, the notification attempt shall be made before
the jailhouse witness is released from custody.

- (c) Whenever a prosecutor notifies a victim of domestic assault, criminal sexual conduct, or harassment or stalking under this section, the prosecutor shall also inform the victim of the method and benefits of seeking an order for protection under section 518B.01 or a restraining order under section 609.748 and that the victim may seek an order without paying a fee.
