1.3 Compensation Advisory Council; increasing amount available for remodeling  
1.4 or alteration projects; requiring rulemaking; appropriating money; amending  
1.5 Minnesota Statutes 2010, sections 14.48, subdivisions 2, 3; 14.49; 14.50;

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2010, section 14.48, subdivision 2, is amended to read:

1.10 Subd. 2. **Chief administrative law judge.** The office shall be under the direction  
1.11 of a chief administrative law judge who shall be learned in the law and appointed by the  
1.12 governor, with the advice and consent of the senate, for a term ending on June 30 of the  
1.13 sixth calendar year after appointment. Senate confirmation of the chief administrative law  
1.14 judge shall be as provided by section 15.066. The chief administrative law judge may hear  
1.15 cases and shall appoint additional administrative law judges and compensation judges to  
1.16 serve in the office as necessary to fulfill the duties ~~prescribed in chapters 14 and 176 of~~  
1.17 the Office of Administrative Hearings. The chief administrative law judge may delegate  
1.18 to a subordinate employee the exercise of a specified statutory power or duty as deemed  
1.19 advisable, subject to the control of the chief administrative law judge. Every delegation  
1.20 must be by written order filed with the secretary of state. The chief administrative law  
1.21 judge is subject to the provisions of the Minnesota Constitution, article VI, section 6, the  
1.22 jurisdiction of the Board on Judicial Standards, and the provisions of the Code of Judicial  
1.23 Conduct.

1.24 Sec. 2. Minnesota Statutes 2010, section 14.48, subdivision 3, is amended to read:

2.1 Subd. 3. **Administrative law judges and compensation judges.** (a) All  
2.2 administrative law judges and compensation judges shall be in the classified service  
2.3 except that the chief administrative law judge shall be in the unclassified service, but  
2.4 may be removed only for cause.

2.5 (b) All administrative law judges and workers' compensation judges must be learned  
2.6 in the law and must be free of any political or economic association that would impair  
2.7 their ability to function in a fair and impartial manner. Administrative law judges shall  
2.8 have demonstrated knowledge of administrative procedures and workers' compensation  
2.9 judges shall have demonstrated knowledge of workers' compensation laws.

2.10 ~~(c) The appointment of individuals as workers' compensation judges or as~~  
2.11 ~~administrative law judges does not preclude the chief administrative law judge from~~  
2.12 ~~establishing a system of training to enable them to acquire demonstrable knowledge and~~  
2.13 ~~to become qualified to conduct hearings in the area other than the area of their original~~  
2.14 ~~appointment. Only compensation judges shall conduct administrative conferences,~~  
2.15 ~~hearings, or other workers' compensation proceedings within the jurisdiction of the Office~~  
2.16 ~~of Administrative Hearings under chapter 176, unless the proceeding is required to be~~  
2.17 ~~conducted under chapter 14.~~ Conducting hearings in the ~~other~~ administrative law area  
2.18 does not affect ~~an administrative law judge's or a~~ workers' compensation judge's job  
2.19 class established pursuant to section 43A.07 or seniority within that job class. The chief  
2.20 administrative law judge shall annually notify the Department of Management and Budget  
2.21 of the amount of credit payable to the workers' compensation special fund for time spent  
2.22 by workers' compensation judges on noncompensation proceedings.

2.23 (d) Administrative law judges and compensation judges are subject to the provisions  
2.24 of the Code of Judicial Conduct. Administrative law and compensation judges may,  
2.25 however, serve as a member of a governmental board when so directed by the legislature.  
2.26 The chief administrative law judge shall provide training to administrative law and  
2.27 compensation judges about the requirements of the code and shall apply the provisions  
2.28 of the code to their actions. Only administrative law judges serving as temporary judges  
2.29 under a written contract are considered to be part-time judges for purposes of the code.  
2.30 Reports required to be filed by the code must be filed with the chief administrative law  
2.31 judge. The chief administrative law judge shall apply the provisions of the Code of Judicial  
2.32 Conduct, to the extent applicable, to the other administrative law and compensation judges  
2.33 in a manner consistent with interpretations made by the Board on Judicial Standards.  
2.34 The chief administrative law judge shall follow the procedural requirements of the  
2.35 commissioner's plan for state employees if any adverse personnel action is taken based in  
2.36 whole or in part as a violation of the Code of Judicial Conduct.

3.1 (e) In addition to other duties provided by law, workers' compensation and  
3.2 administrative law judges may mediate, arbitrate, or take other appropriate action on  
3.3 matters referred to the Office of Administrative Hearings by any member of the federal or  
3.4 state judicial branch or by the Workers' Compensation Court of Appeals.

3.5 Sec. 3. Minnesota Statutes 2010, section 14.49, is amended to read:

3.6 **14.49 TEMPORARY ADMINISTRATIVE LAW JUDGES.**

3.7 When regularly appointed administrative law judges ~~or compensation judges~~ are not  
3.8 available, the chief administrative law judge may contract with qualified individuals to  
3.9 serve as administrative law judges ~~or compensation judges~~. Such temporary administrative  
3.10 law judges ~~or compensation judges~~ shall not be employees of the state. Compensation  
3.11 judges must be employees of the state, except that when all available regularly appointed  
3.12 compensation judges are disqualified from a specific case under the Code of Judicial  
3.13 Conduct, the chief administrative law judge may contract with a workers' compensation  
3.14 attorney or former workers' compensation judge to serve as a compensation judge for  
3.15 that case.

3.17 **14.50 HEARINGS BEFORE ADMINISTRATIVE LAW JUDGE.**

3.18 All hearings of state agencies required to be conducted under this chapter shall be

3.20 or by a workers' compensation judge assigned by the chief administrative law judge as  
3.21 provided in section 14.48. All hearings required to be conducted under chapter 176 shall

5.2 Subd. 6. **Penalty.** At a conference, if the insurer does not provide a specific reason  
5.3 for nonpayment of the items in dispute, the ~~commissioner's designee~~ commissioner or  
5.4 compensation judge may assess a penalty of \$300 payable to the commissioner for deposit  
5.5 in the assigned risk safety account, unless it is determined that the reason for the lack of

5.32 Sec. 11. Minnesota Statutes 2010, section 176.106, subdivision 9, is amended to read:

6.1 Subd. 9. **Subsequent causation issues.** If initial liability for an injury has been  
6.2 admitted or established and an issue subsequently arises regarding causation between  
6.3 the employee's condition and the work injury, the commissioner or compensation judge  
6.4 may make the subsequent causation determination subject to de novo hearing by a

7.1 Sec. 15. Minnesota Statutes 2010, section 176.238, subdivision 6, is amended to read:

7.2 Subd. 6. **Expedited hearing before compensation judge.** (a) A hearing before a  
7.3 compensation judge shall be held within 60 calendar days after the office receives the file  
7.4 from the commissioner if:

7.5 (1) an objection to discontinuance has been filed under subdivision 4 within 60  
7.6 calendar days after the notice of discontinuance was filed and where no administrative  
7.7 conference has been held;

7.8 (2) an objection to discontinuance has been filed under subdivision 4 within 60  
7.9 calendar days after ~~the commissioner's~~ an interim administrative decision under this  
7.10 section has been issued;

7.11 (3) a petition to discontinue has been filed by the insurer in lieu of filing a notice of  
7.12 discontinuance; or

7.13 (4) a petition to discontinue has been filed within 60 calendar days after the  
7.14 ~~commissioner's~~ interim administrative decision under this section has been issued.

7.20 The hearing shall be limited to the issues raised by the notice or petition unless all parties  
7.21 agree to expanding the issues. If the issues are expanded, the time limits for hearing and  
7.22 issuance of a decision by the compensation judge under this subdivision shall not apply.

7.23 (c) Once a hearing date has been set, a continuance of the hearing date will be  
7.24 granted only under the following circumstances:

7.25 (1) the employer has agreed, in writing, to a continuation of the payment of benefits  
7.26 pending the outcome of the hearing; or

7.27 (2) the employee has agreed, in a document signed by the employee, that benefits  
7.28 may be discontinued pending the outcome of the hearing.

7.29 (d) Absent a clear showing of surprise at the hearing or the unexpected unavailability  
7.30 of a crucial witness, all evidence must be introduced at the hearing. If it is necessary  
7.31 to accept additional evidence or testimony after the scheduled hearing date, it must be  
7.32 submitted no later than 14 days following the hearing, unless the compensation judge, for

7.34 (e) When a compensation judge issued the interim administrative decision, the de  
7.35 novo hearing under paragraph (a), clauses (2) and (4), must be held before a compensation

8.4 Subdivision 1. **Hearings on petitions.** The petitioner shall serve a copy of the  
8.5 petition on each adverse party personally or by first class mail. A clear copy suitable  
8.6 for imaging shall be filed with the commissioner together with an appropriate affidavit  
8.7 of service. ~~When any petition has been filed with the Workers' Compensation Division,~~

8.19 All parties must appear at the settlement conference, either personally or by

9.5 determination of each issue. If a party fails to appear at the conference, all issues may  
9.6 be determined contrary to the absent party's interest, provided the party in attendance  
9.7 presents a prima facie case.

9.8            The summary decision is final unless a written request for a formal hearing is served  
9.9 on all parties and filed with the commissioner within 30 days after the date of service

9.16            The chief administrative law judge ~~must~~ may assign workers' compensation cases to  
9.17 compensation judges using a block system type of assignment that, among other things,  
9.18 ensures that a case will remain with the same judge from commencement to conclusion  
9.19 ~~unless, except that the judge is~~ must be removed from the case by exercise of when:

9.20            (1) a party exercises a legal right of a party or by incapacity to do so;

9.21            (2) the judge is incapacitated or is otherwise unable to hold a hearing; or

9.22            (3) assignment of a different judge is required by section 176.106, subdivision

9.29            Subd. 4. **Continuances.** Only the chief administrative law judge or designee, on a  
9.30 showing of good cause, may grant a continuance of a hearing at the office. Except in cases  
9.31 of emergency or other good cause shown, any request for a continuance must be signed by  
9.32 both the party and the attorney seeking the continuance.

9.33            A continuance of a hearing will be granted only upon a showing of good cause.  
9.34 Good cause is established when the underlying eventuality is unforeseen, is not due to

10.1 lack of preparation, is relevant, is brought to the chief administrative law judge's attention  
10.2 in a timely manner and does not prejudice the adversary.

10.3 Continuances will not be granted for the reason that an attorney for one of the parties

10.10 judge, the calendar judge, or other presiding officer assigned to the prehearing or
