1.5	Section 1. PUBLIC SALE OF TAX-FORFEITED LANDS BORDERING PUBLIC
1.6	WATER; BLUE EARTH COUNTY.
1.7	(a) Notwithstanding Minnesota Statutes, sections 92.45 and 282.018, subdivision 1, Blue
1.8	Earth County may sell the tax-forfeited lands bordering public water that are described in
1.9	paragraph (c) under the remaining provisions of Minnesota Statutes, chapter 282.
1.10	(b) The conveyances must be in a form approved by the attorney general. The attorney
1.11	general may make changes to the land descriptions to correct errors and ensure accuracy.
