1.9	Section 1. Minnesota Statutes 2020, section 245A.05, is amended to read:
1.10	245A.05 DENIAL OF APPLICATION.
1.11	(a) The commissioner may deny a license if an applicant or controlling individual:
1.12	(1) fails to submit a substantially complete application after receiving notice from the
1.13	commissioner under section 245A.04, subdivision 1;
1.14	(2) fails to comply with applicable laws or rules;
1.15	(3) knowingly withholds relevant information from or gives false or misleading

The applicant may 2.19 appeal the denial by notifying the commissioner in writing by certified mail or personal 2.20 service. If mailed, the appeal must be postmarked and sent to the commissioner within 20 2.21 calendar days after the applicant received the notice of denial. If an appeal request is made 2.22 by personal service, it must be received by the commissioner within 20 calendar days after 2.23 the applicant received the notice of denial.
