1.13 **178.01 PURPOSES.**

The purposes of this chapter are: to open to young all people regardless of race, 1.14 sex, creed, color or national origin, the opportunity to obtain training and on-the-job 1.15 learning that will equip them for profitable employment and citizenship; to establish as 1.16 a means to this end, a program of voluntary apprenticeship under approved apprentice 1 17 apprenticeship agreements providing facilities for their training and guidance in the arts, 1.18 skills, and crafts of industry and trade or occupation, with concurrent, supplementary 1.19 instruction in related subjects; to promote apprenticeship opportunities under conditions 1.20 providing adequate training and on-the-job learning and reasonable earnings; to relate the 1.21 supply of skilled workers to employment demands; to establish standards for apprentice 1.22 training; to establish an Apprenticeship Board and apprenticeship committees to assist in 1.23 effectuating the purposes of this chapter; to provide for a Division of Labor Standards 1.24 and Apprenticeship within the Department of Labor and Industry; to provide for reports 1.25 to the legislature regarding the status of apprentice training in the state; to establish a 1.26

Sec. 2. Minnesota Statutes 2010, section 178.03, subdivision 3, is amended to read: 2.3 Subd. 3. Duties and functions.
