1.3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.4	Section 1. SCHOOL SAFETY FACILITY GRANTS.
1.5	(a) A school district may apply for a school safety facility grant in the form and manner
1.6	specified by the commissioner of education.
1.7	(b) After consultation with the Department of Public Safety's Minnesota School Safety
1.8	Center, the commissioner of education may award to a school district a school safety facility
1.9	grant of no more than \$500,000 for each qualifying school building. The commissioner
1.10	must award grants for projects that meet the requirements of this subdivision on a first-come,
1.11	first-served basis. At least half of the grants must be awarded to school districts with
