4.1	Subdivision 1. Suitability standard. In recommending under sections 72A.20,
4.2	subdivision 34, and 60K.46, subdivision 4, to a consumer the purchase of an annuity or the
4.3	exchange of an annuity that results in another insurance transaction or series of insurance
4.4	transactions, the insurance producer, or the insurer where no producer is involved, shall
4.5	have reasonable grounds for believing, after a reasonable inquiry, that the recommendation
4.6	is suitable for the consumer, under the totality of the circumstances based on the facts
4.7	disclosed by the consumer as to the consumer's investments and other insurance products
4.8	and as to the consumer's financial situation and needs, including the consumer's suitability
4.9	information, and that there is a reasonable basis to believe all of the following:
4.10	(1) the consumer has been reasonably informed of various features of the annuity,
4.11	such as the potential surrender period and surrender charge, potential tax penalty if the
4.12	consumer sells, exchanges, surrenders, redeems, or annuitizes the annuity, mortality and
4.13	expense fees, investment advisory fees, potential charges for and features of riders,
4.14	limitations on interest returns, insurance and investment components, and market risk;
4.15	(2) the consumer would receive a tangible net benefit from the transaction;
4.16	(3) for the particular consumer based on the consumer's suitability information:
4.17	(i) the particular annuity as a whole, the underlying subaccounts to which funds
4.18	are allocated at the time of purchase or exchange of the annuity, and riders and similar
4.19	product enhancements, if any, are suitable; and
4.20	(ii) in the case of an exchange or replacement, the transaction as a whole is suitable
4.21	taking into account, among other things, the age of the consumer; and
4.22	(4) in the case of an exchange or replacement of an annuity, the exchange or
4.23	replacement is suitable including taking into consideration all of the following:
4.24	(i) the consumer will incur a surrender charge; be subject to the commencement of a
4.25	new surrender period; lose existing benefits, such as death, living, or other contractual
4.26	benefits; or be subject to increased fees, investment advisory fees, or charges for riders
4.27	and similar product enhancements;
4.28	(ii) the consumer would receive a tangible net benefit from the transaction, and
4.29	in the case of a person 65 years of age or older, neither a producer nor an insurer shall
4.30	recommend a replacement or exchange of an annuity that requires the insured to pay
4.31	a surrender charge for the annuity being replaced or exchanged if the replacement or
4.32	exchange does not confer a substantial financial benefit over the life of the annuity to the
4.33	consumer so that a reasonable person would believe the purchase is unnecessary; and
4.34	(iii) the consumer has had another annuity exchange or replacement and, in
4.35	particular, an exchange or replacement within the preceding 60 months.

5.1	Subd. 2. Obtaining suitability information. Before the execution of a purchase,
5.2	exchange, or replacement of an annuity resulting from a recommendation, an insurance
5.3	producer, or an insurer where no producer is involved, shall make reasonable efforts to
5.4	obtain the consumer's suitability information, and record this information on a form,
5.5	inventory, or similar record. The producer, upon request, shall provide to the consumer or
5.6	their legal representative a copy of the information used in the making of the suitability
5.7	determination.
5.8	Subd. 3. Restriction on issuance of annuity. Except as permitted under subdivision

6.15	elevated review shall be conducted by a natural person or persons;
6.16	(5) the insurer shall maintain reasonable procedures to detect recommendations
6.17	that are not suitable. This may include, but is not limited to, confirmation of consumer
6.18	suitability information, systematic customer surveys, interviews, confirmation letters,
6.19	and programs of internal monitoring. Nothing in this clause prevents an insurer from
6.20	complying with this clause by applying sampling procedures, or by confirming suitability
6.21	information after issuance or delivery of the annuity; and

8.2	Subdivision 1. Requirement. An insurance producer shall not solicit the sale of an
8.3	annuity product unless the insurance producer has adequate knowledge of the product to
8.4	recommend the annuity and the insurance producer is in compliance with the insurer's
8.5	standards for product training. An insurance producer may rely on insurer-provided
8.6	product-specific training standards and materials to comply with this subdivision.
8.7	Subd. 2. Initial training. (a) An insurance producer who is otherwise entitled to
8.8	engage in the sale of annuity products shall complete a onetime four-credit training course
8.9	approved by the commissioner and provided by a continuing education provider approved
8.10	by the commissioner prior to commencing the transaction of annuities.
8.11	Insurance producers who hold a life insurance line of authority on the effective

8.35	must be an approved continuing education provider in this state and comply with the
8.36	requirements applicable to insurance producer continuing education courses.
