A bill for an act 1.1 relating to game and fish; allowing persons age 60 or over to use muzzleloader 12 with scope during muzzleloader season; amending Minnesota Statutes 2014, 1.3 section 97B.031, subdivision 5, by adding a subdivision. 1.4

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.5

- Section 1. Minnesota Statutes 2014, section 97B.031, subdivision 5, is amended to read: 1.6 Subd. 5. Scopes; visually impaired hunters. (a) Notwithstanding any other law 1.7 to the contrary, the commissioner may issue a special permit, without a fee, to use a 1.8 muzzleloader with a scope to take deer during the muzzleloader season to a person who is 1.9 under age 60, who obtains the required licenses, and who has a visual impairment. The 1.10 scope may not have magnification capabilities. 1.11
- (b) The visual impairment must be to the extent that the applicant is unable 1.12 to identify targets and the rifle sights at the same time without a scope. The visual 1.13 impairment and specific conditions must be established by medical evidence verified in 1.14 writing by (1) a licensed physician or a certified nurse practitioner or certified physician 1.15 assistant acting under the direction of a licensed physician; (2) a licensed ophthalmologist; 1.16 or (3) a licensed optometrist. The commissioner may request additional information from 1.17 1.18 the physician if needed to verify the applicant's eligibility for the permit. (c) A permit issued under this subdivision may be valid for up to five years, based 1 19 on the permanence of the visual impairment as determined by the licensed physician, 1.20
- ophthalmologist, or optometrist. 1.21
- (d) The permit must be in the immediate possession of the permittee when hunting 1 22 under the special permit. 1.23

- (e) The commissioner may deny, modify, suspend, or revoke a permit issued under 2.1 this subdivision for cause, including a violation of the game and fish laws or rules. 2.2 (f) A person who knowingly makes a false application or assists another in making 2.3 a false application for a permit under this subdivision is guilty of a misdemeanor. A 2.4 physician, certified nurse practitioner, certified physician assistant, ophthalmologist, or 2.5 optometrist who fraudulently certifies to the commissioner that a person is visually 2.6 impaired as described in this subdivision is guilty of a misdemeanor. 2.7 (g) A permit is not required under this subdivision to use an electronic range finder 2.8 according to section 97B.081, subdivision 3, paragraph (c). 2.9 Sec. 2.
