BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

A bill for an act

Section 1. FINDINGS AND PURPOSE.

The legislature finds and declares that the goal of housing stability for all Minnesotans is consistent with the state's responsibility to protect the health, safety, and welfare of its citizens. Homelessness is the most serious form of housing instability. The legislature finds and declares that a unique opportunity exists to build upon its past investments and to advance proven and innovative strategies to prevent and end homelessness for thousands of Minnesotans by funding the construction of an opportunity center as part of a broad and comprehensive public-private partnership.

Sec. 2. APPROPRIATION; OPPORTUNITY CENTER.

\$12,000,000 is appropriated from the bond proceeds fund to the commissioner of human services for a grant to the city of St. Paul to predesign, design, construct, furnish, and equip an opportunity center to serve as an integrated one-stop delivery system connecting persons at risk of becoming homeless and persons working to move up and out of homelessness to services that improve their health, income, housing stability, or well-being. This appropriation may be used to acquire property for these purposes. This appropriation is not available until the commissioner of management and budget has determined that at least an equal amount has been committed to the project from nonstate sources.
