4655.9320 FINES FOR UNCORRECTED DEFICIENCIES IN NURSING HOMES.

Subpart 1. Application. The provisions of parts 4655.9320 to 4655.9342 establish the schedule of fines to be assessed against nursing homes for the failure to comply with a correction order. Penalty assessments are issued under the provisions of Minnesota Statutes, section 144A.10, subdivision 6 and will accrue on a daily basis. This part supersedes those provisions contained in parts 4655.9200 to 4655.9300 which establish a schedule of fines applicable to nursing homes. The provisions of parts 4655.9200 to 4655.9300 which establish fines applicable to boarding care homes remain unchanged.

Subp. 2. Statutory authority. Pursuant to the provisions of Minnesota Statutes, section 144A.10, subdivision 6, the commissioner of health shall impose penalty assessments in the amounts specified in parts 4655.9320 to 4655.9342.
