

USER'S GUIDE FOR RULES INDEX

The index to Minnesota Rules 1986 Supplement Number 2 includes references to rules adopted after April 8, 1985 and before July 29, 1986. References are to rule part numbers.

For newly adopted rule parts the index coverage is complete. For amended parts a reference is included only if the existing references in the main volume index are inadequate to cover the amendments. Therefore, it is suggested that the user always begin an index search with the volume 10 index of Minnesota Rules 1985.
