USER'S GUIDE FOR TABLE OF AMENDMENTS OF RULES

The table of amendments lists the rule parts affected in Minnesota Rules 2021 that were adopted or enacted between November 23, 2020, and November 29, 2021. It also lists a citation to either the State Register in which the rule part's notice of adoption was published, or to Laws of Minnesota if the rule part was subject to legislative action.

The table consists of two columns. The first column lists the rules in decimal order. The second column contains the State Register cite where the notice of adoption of the action taken on a rule was published, or the citation to text in Laws of Minnesota that directed a change.

Example:

1230.0150 42 SR 543

This example shows that action was taken on Minnesota Rules, part 1230.0150 and that the notice of adoption appeared on page 543 of volume 42 of the State Register.

Example:

9505.0275 L 2021 1Sp7 art 1 s 40

This example shows that action was taken on Minnesota Rules, part 9505.0275, as directed by L 2021 1Sp7 art 1 s 40.
