

**USER'S GUIDE FOR TABLE OF  
STATE REGISTER CITATIONS**

The table of State Register citations lists the dates for each State Register citation. Currently, the State Register citation can be found either in the historical note at the end of each part where changes were adopted on or after August 1, 1983, or in the third column of the table of amendments for changes made since the last edition of Minnesota Rules.

After locating a State Register citation, the user can consult this table to determine the date the changes were adopted and the approximate effective date of the adoption (usually 5 working days after adoption, unless specifically stated otherwise in the text of the rule or in a note following the rule). The first column of the table lists a range of State Register citations and the second column lists the date that those pages were published.

Example:

31 SR 927 to 948 ..... January 22, 2007

This example shows that any changes adopted with a State Register citation in the range of 31 SR 927 to 31 948 were adopted on January 22, 2007; therefore, a user can determine that those changes were effective on January 29, 2007, unless otherwise indicated.
