- 8 11 MCAR S 1.0020 Purpose and authority. The purpose of 11 MCAR
- 9 SS 1.0020-1.0024 is to establish rules governing the issuance
- 10 and display of school bus inspection certificates, consistent
- 11 with the provisions of Minn. Stat. S 169.451, and to establish a
- 12 point system to evaluate the effect on safety operation of any
- 13 variance from law detected during school bus inspection,
- 14 consistent with the mandate of the legislature.
- 15 11 MCAR S 1.0021 Definitions. For the purposes of 11 MCAR SS
- 16 1.0020-1.0024, the following terms shall have the meanings given
- 17 them:
- 18 A. State patrol. "State patrol" means the Minnesota State
- 19 Patrol, or an individual state trooper thereof or a State Patrol
- 20 Law Compliance Representative II (LCR II) employed pursuant to
- 21 Minn. Stat. S 299D.06.
- B. Certificate. "Certificate" means a school bus inspection
- 23 certificate required by the provisions of Minn. Stat. S 169.451,
- 24 subd. 2.
- 25 C. Temporary certificate. "Temporary certificate" means a
- 26 distinctive certificate indicating a school bus was found to
- 27 have deficiencies of a nature not substantially affecting safety
- 28 of operation.
- D. Rejection sticker. "Rejection sticker" means a sticker
- 30 signifying the vehicle to which it is affixed is not to be used
- 31 for school bus purposes. The size of the rejection sticker may
- 32 not be larger than the inspection certificate.
- 33 11 MCAR S 1.0022 Issuance of certificate. The certificate shall
- 34 be issued for an individual bus on an annual basis when the
- 35 state patrol has inspected the vehicle and the inspection

- 1 indicates that the school bus adequately complies with laws and
- 2 rules relating to construction, design, equipment and color of
- 3 school bus.
- 4 11 MCAR S 1.0023 Display of certificate.
- 5 A. Certificate to be affixed. The certificate issued for
- 6 each individual school bus shall be immediately affixed to the
- 7 school bus by the inspecting state patrol trooper or LCR II.
- 8 B. Certificate must be current. Only the certificate that
- 9 is valid for the current time period may be displayed.
- 10 C. Where displayed. The certificate shall be affixed in the
- 11 lower left corner of the main windshield of the school bus.
- D. Rejection sticker, display, removal. A rejection sticker
- 13 shall be affixed to the lower left corner of the windshield of a
- 14 school bus that fails a school bus inspection. The sticker
- 15 shall be removed only upon authorization from a LCR II or
- 16 trooper who has determined that the defects that caused the
- 17 rejection have been corrected.
- 18 11 MCAR S 1.0024 Method of inspection.
- 19 A. Scheduled inspection. All school buses shall be
- 20 inspected for compliance with applicable laws and with rules of
- 21 the State Board of Education as stated in rules EDU 240-265 of.
- 22 the State Board of Education.
- B. Other inspections. In addition to scheduled annual
- 24 inspections and reinspections scheduled for the purpose of
- 25 verifying that deficiencies have been corrected, a trooper or
- 26 LCR II may conduct an unannounced inspection of any school bus
- 27 at the location where the bus is kept when not in operation.
- 28 This paragraph shall not be construed to limit the right or duty
- 29 of any law enforcement officer to inspect any vehicle upon
- 30 reasonable cause.
- 31 C. Point system, passing scores. The point system contained
- 32 in E. shall be used to assess the safety operation of all types
- 33 of school buses. Each bus will start with 100 points and each
- 34 defect shall be cause for points to be deducted in accordance
- 35 with point values established in E.

- 1. Any school bus with an inspection score of 96 to 100
- 2 shall be identified by affixing a distinctive school bus
- 3 inspection certificate to the windshield. Where an inspection
- 4 score of 96 is achieved, no inspection certificate shall be
- 5 affixed to the bus at the next annual inspection unless the
- 6 inadequacies from the previous inspection have been corrected.
- 7 2. Any school bus with an inspection score of 80 to 95
- 8 points shall pass the inspection and receive a temporary bus
- 9 inspection certificate of contrasting color or design or both.
- 10 This temporary certificate will be valid for 14 days following
- 11 inspection and all defects must be corrected. Pending
- 12 reinspection and certification of the bus by a trooper or LCR
- 13 II, a bus bearing a temporary certificate may be used to
- 14 transport pupils beyond the 14-day period if the inspection
- 15 sheet is signed by the owner or his designee certifying that all
- 16 of the defects are corrected. The signed inspection sheet shall
- 17 be carried in the first aid kit in the bus.
- D. Non-passing scores. Any school bus with less than 80
- 19 points shall be deemed unsafe for the transportation of school
- 20 children. Any school bus which fails the inspection shall not
- 21 be used to transport school children until the defects are
- 22 corrected and an inspection certificate is issued and affixed to
- 23 the bus. Pending reinspection and certification of the bus by a
- 24 trooper or LCR II, a bus bearing a rejection sticker may be used
- 25 to transport pupils if the inspection sheet is signed by the
- 26 owner or his designee certifying that all of the defects are
- 27 corrected. The signed inspection sheet shall be carried in the
- 28 first aid kit in the bus.
- 29 E. Point system. In accordance with C., defects in the
- 30 equipment of a school bus listed in the left column will cause
- 31 the number of points specified in the right column to be
- 32 deducted from the starting score of 100.
