9	7890.0100 DEFINITIONS.
10	
	Subpart 1. Scope. The terms used in this chapter shall
11	have the meanings given them in this part.
L2	Subp. 2. Analgesic. "Analgesic" is a substance used to
L3	relieve pain.
14	Subp. 3. Anesthetic. "Anesthetic" is a substance used to
15	effect a loss of feeling or sensation in any part of the body.
L6	Subp. 4. Bleeder. "Bleeder" means, according to its
17	context, either:
L8	\underline{A} . a horse which during a race or exercise is
L9	observed by the commission veterinarian or stewards his or her
20	desginee to be shedding blood from one or both nostrils or-which
21	is-suspected-of-having-bled-and-is-so-confirmed-by-an-endoscopic

33	Subp. 5. Bleeder list. "Bleeder list" means a tabulation
34	of all bleeders maintained by the commission veterinarian.
35	Subp. 6. Bute. "Bute" means phenylbutazone or

- Subp. 7. Chemist. "Chemist" means any official racing
- 3 chemist designated by the commission.
- 4 Subp. 8. Depressant. "Depressant" is a substance used to
- 5 diminish the function of the body, including the cardiovascular
- 6 system, pulmonary system, urinary system, nervous system,
- 7 musculo-skeletal system, or any other functions systemic
- 8 function of the body.
- 9 Subp. 9. Detention barn. "Detention barn" means a secured
- 10 structure designated by the commission.
- 11 Subp. 10. DMSO. "DMSO" means dimethylsulfoxide.
- 12 Subp. 11. Horse. "Horse" includes all horses registered
- 13 for racing under the jurisdiction of the commission and, for
- 14 purposes of this chapter, includes a stallion, colt, gelding,
- 15 ridgling, filly, or mare.
- 16 Subp. 12. Lasix®. "Lasix®" means furosemide
- 17 (4-chloro-N-furfuryl-5-sulfamoylanthranilic acid).
- Subp. 13. Medication. "Medication" is a substance,
- 19 compound, or element, or combination thereof, which is or can be
- 20 administered to a horse for the purpose of preventing, curing,
- 21 or alleviating the effects of any disease, condition, ailment,
- 22 or infirmity, or symptom thereof, or for altering in any way the
- 23 behavior, attitude, temperament, or performance of a horse,
- 24 including athletic performance. The term medication includes
- 25 all analgesics, anesthetics, depressants, narcotics, stimulants,
- 26 tranquilizers, and other classifications of medications.
- 27 Nothing herein shall be deemed to include:
- A. Bute, provided that the test sample does not
- 29 contain more than three micrograms of the substance or
- 30 metabolites thereof per milliliter of blood plasma.
- 31 B. Lasix®, provided, however, that if it is
- 32 administered to a confirmed bleeder on a day it is entered to
- 33 race, it must be given intravenously under the visual
- 34 supervision of the commission veterinarian and at a dose level
- 35 not to exceed 250 milligrams (five milliliters of a
- 36 50 milligrams/milliliter or five percent

- 1 solution) per administration.
- C. Topical applications, such as antiseptics,
- 3 ointments, salves, DMSO, leg rubs, and leg paints which may
- 4 contain antibiotics (excluding procaine, penicillin, and
- 5 chloranphenicol) but which may not contain benzocaine, steroids,

- 7 D. Food additives, such as vitamins and electrolytes,
- 8 provided such additives are administered orally and do not

- 10 Subp. 14. Narcotic. "Narcotic" is a substance used to
- 11 induce a sleep or stupor and at the same time relieve pain.
- 12 Subp. 15. Positive test. "Positive test" means the
- 13 detection of any medication or metabolites thereof in a test
- 14 sample or a test level of Bute above the allowed level.
- 15 Subp. 16. Stimulant. "Stimulant" is a substance used to
- 16 increase or excite the function of the body, including the
- 17 cardiovascular system, pulmonary system, urinary system, nervous
- 18 system, musculo-skeletal system, or any other systemic function
- 19 of the body.
- 20 Subp. 17. Test level. "Test level" means the
- 21 concentration of Bute found in a test sample.
- 22 Subp. 18. Test sample. "Test sample" means any bodily
- 23 substance including blood, urine, saliva, or other substance
- 24 designated by the commission, taken from a horse under the
- 25 supervision of the commission veterinarian for the purpose of
- 26 analysis.
- 27 Subp. 19. Tranquilizer. "Tranquilizer" is a substance
- 28 used to alter the psychic state.
- 29 Subp. 20. Veterinarian. "Veterinarian" means a doctor of
- 30 veterinary medicine licensed by the commission to practice at a
- 31 Minnesota racetrack.
- 32 Subp. 21. Veterinarian's list. "Veterinarian's list"
- 33 means a tabulation of horses maintained by the commission
- 34 veterinarian that are prohibited from entering a race for a
- 35 minimum of five calendar days and not until such time as the
- 36 commission veterinarian deems the horse in fit condition to race.

- 1 7890.0110 MEDICATIONS PROHIBITED.
- 2 No person shall administer or cause to be administered to a
- 3 horse within 48 hours of a race in which it is scheduled to run
- 4 any medication (except as permitted by part 7890.0100, subpart
- 5 13, items A to D) by injection, oral or topical administration,
- 6 rectal infusion or suppository, or by inhalation.
- 7 7890.0120 REPORTING PROCEDURES.
- 8 Subpart 1. Veterinarians must keep records. Veterinarians
- 9 must submit daily to the commission veterinarian on a prescribed
- 10 form a report of all medications and other substances (as
- 11 provided in part 7890.0100, subpart 13, items A to D) which the
- 12 veterinarian prescribed, administered, or dispensed for horses
- 13 registered at a current race meeting. A logbook detailing other
- 14 professional services performed while on the grounds of an
- 15 association must be kept by veterinarians and shall be made
- 16 immediately available to the commission veterinarian or the
- 17 stewards upon request.
- 18 Subp. 2. Administration of Bute to be reported. The

- 27 from a horse registered to use such substance, disciplinary
- 28 action shall be initiated against the attending trainer and, if
- 29 applicable, the assistant trainer or substitute trainer.
- 30 7890.0130 FINDINGS OF CHEMIST.
- 31 Subpart 1. Prima facie evidence. A finding by a chemist
- 32 that any medication or Bute exceeding the allowable test level
- 33 provided in part 7890.0100, subpart 13, item A, shall be
- 34 considered prima facie evidence that such medication or

- 1 substance was administered and carried in the body of the horse
- 2 while participating in a race. Such finding shall also be
- 3 considered prima facie evidence that the trainer and, if
- 4 applicable, the assistant trainer or substitute trainer was
- 5 negligent in the handling or care of the horse.
- 6 Subp. 2. Distributed purse money. The fact that purse
- 7 money has been distrubuted prior to the issuance of the
- 8 chemist's report shall not be deemed a finding that no
- 9 medication or Bute exceeding allowable level was administered to
- 10 the horse earning such purse money in violation of this chapter.
- 11 7890.0140 BLEEDERS.
- 12 Subpart 1. Maintenance: -- An-up-to-date-bleeder-list-shall
- 13 be-posted-in-the-office-of-the-racing-secretary Examination of
- 14 bleeders. A horse which is alleged to have bled in Minnesota
- must be physically examined by the commission veterinarian in
- 16 order to confirm its inclusion on the bleeder list,
- 17 veterinarian's list, or both. The examination must be performed
- 18 within 1-1/2 hours following the finish of a race or exercise in
- 19 which the horse has participated. At the time of the physical
- 20 examination the commission veterinarian may also require an
- 21 endoscopic examination to confirm the source of hemorrhage. The
- 22 endoscopic examination shall be conducted by a veterinarian
- 23 employed by the horse's owner or his or her agent, and shall be
- 24 conducted in the presence of and in consultation with the
- 25 commission veterinarian. The commission veterinarian shall
- 26 decide, based upon his or her experience and professional
- 27 training, whether the amount of hemmorhage is sufficient to
- 28 cause such horse to be certified as a bleeder.
- 29 Subp. 2. Horses-placed-on-bleeder-list.--Bleeders-shall-be
- 30 placed-on-the-bleeder-list-and-veterinarian-s-list-and-shall-be
- 31 ineligible-to-be-entered-in-a-race-pursuant-to-subpart
- 32 5 Confirmation of bleeder must be certified. The confirmation
- 33 of a bleeder examined pursuant to subpart 1 must be certified in
- 34 writing by the commission veterinarian and such horse must be
- 35 included on the bleeder list. Upon request, a copy of the

- 1 certification shall be provided to the owner of the horse or his
- 2 or her agent.
- 3 Subp. 3. Endoscopic-examination: -- Within-one-hour-of-the
- 4 finish-of-the-race-or-exercise-in-which-a-horse-has
- 5 participated, the commission-veterinarian-may-require-an
- 6 endoscopic-examination-in-order-to-confirm-the-horse's-inclusion
- 7 on-the-bleeder-list.--The-endoscopic-examination-shall-be
- 8 conducted-by-a-veterinarian-employed-by-the-horse's-owner-or-his
- 9 or-her-agenty-and-shall-be-conducted-in-the-presence-of-and-in
- 10 consultation-with-the-commission-veterinarian. -- The-commission
- 11 veterinarian-shall-decide;-based-upon-his-or-her-experience-and
- 12 professional-training,-whether-the-amount-of-hemmorhage-is
- 13 sufficient-to-cause-such-horse-to-be-certified-as-a
- 14 bleeder Bleeders imported from other jurisdictions. A horse
- 15 shipped into Minnesota from another jurisdiction may be

- 18 documentation to that effect is transmitted to and accepted by
- 19 the commission veterinarian at the Minnesota racetrack to which

- 22 Subp. 4. Confirmation-of-bleeder-must-be-certified.--The
- 23 confirmation-of-a-bleeder-must-be-certified-in-writing-by-the
- 24 commission-veterinarian-and-such-horse-must-be-included-on-the
- 25 bleeder-list:--Upon-request;-a-copy-of-such-certification-shall
- 26 be-provided-to-the-owner-of-the-horse-or-his-or-her-agent Horses
- 27 placed on bleeder list. Bleeders shall be placed on a bleeder
- 28 list and the list shall be posted in the office of the racing
- 29 secretary. Horses certified as having bled in Minnesota shall
- 30 also be placed on the veterinarian's list at the time of the
- 31 observed bleeding and shall be ineligible to be entered in a
- 32 race pursuant to subpart 5.
- 33 Subp. 5. Restrictions on confirmed bleeders. Confirmed
- 34 bleeders shall be subject to the following restrictions:

- 36 horse shall be placed on the bleeder list and the veterinarian's

- 1 list and shall not be removed from the veterinarian's list for
- 2 at-least-14-days,-and-not-until-the-commission-veterinarian-has
- 3 approved-its-removal without the approval of the commission
- 4 veterinarian. Such a horse shall be ineligible to race for at
- 5 least 16 days following the observed bleeding.
- 6 B. When a horse has been observed bleeding for the
- 7 second time in Minnesota, the horse shall be placed on the
- 8 veterinarian's list and shall not be removed from the list for
- 9 at-least-28-days,-and-not-until-the-commission-veterinarian-has
- 10 approved-its-removal without the approval of the commission
- 11 veterinarian. Such a horse shall be ineligible to race for at
- 12 least 30 days following the observed bleeding.
- C. When a horse has been observed bleeding for the
- 14 third time in Minnesota, the horse shall be placed on the
- 15 veterinarian's list and shall not be removed from the list for
- 16 at least six months, and not until the commission veterinarian
- 17 has approved its removal.
- D. When a horse is observed bleeding a fourth time in
- 19 Minnesota, the horse shall be barred from further pari-mutuel
- 20 racing in Minnesota.
- 21 Subp. 6. Bleeders-imported-from-other-jurisdictions---A
- 22 horse-shipped-into-Minnesota-from-another-jurisdiction-may-be
- 23 considered-a-bleeder-provided-there-is-compliance-with-the
- 24 following-procedures:
- 25 A:--the-jurisdiction-from-which-it-was-shipped
- 26 considered-the-horse-a-bleeder,-and-documentation-to-that-effect
- 27 is-immediately-transmitted-to-the-stewards-and-the-commission
- 28 veterinarian-at-the-Minnesota-racetrack-to-which-it-is-shipped;
- 29 and
- 30 B:--the-commission-veterinarian-certifies-the-horse-as
- 31 a-bleeder Lasix® may be administered to certified bleeders.
- 32 Upon request, any horse placed on the bleeder list shall, in its
- 33 next race, be permitted the use of Lasix®. Once a horse has
- 34 raced with Lasix®, it must continue to race with Lasix® in all
- 35 subsequent races unless a request is made to discontinue the
- 36 use. If the use of Lasix® is discontinued, the horse shall be

- 1 prohibited from again racing with Lasix® unless it is later
- 2 observed to be bleeding pursuant to subpart 1 or meets the
- 3 requirements of subpart 3. Requests for the use of or
- 4 discontinuance of Lasix® must be made to the commission
- 5 veterinarian by the horse's trainer or assistant trainer on a
- 6 form prescribed by the commission on or before the day of entry
- 7 into the race for which the request is made.
- 8 Subp. 7. Bleeders-confined Confinement to security stall.
- 9 Once a horse is-placed-on-the-bleeder-list has been permitted
- 10 the use of Lasix®, it must be in brought to the detention barn
- 11 for treatment not less than four hours prior to scheduled post
- 12 time for the race in which it is entered to start. Once at the
- 13 detention barn, a horse shall remain there until it is taken to
- 14 the paddock to be saddled or harnessed for a race.
- 15 Subp. 8. Deadline for Lasix®. Bieeders-entered-to-race
- 16 A horse entered to race with Lasix® must be treated at least
- 18 a-blood-sample-shall-be-taken-by-the-commission-veterinarian-for
- 19 analysis.
- 20 Subp. 9. Administration of Lasix®. Lasix® shall be
- 21 administered intravenously by a veterinarian employed by the
- 22 owner or trainer of the horse or-his-or-her-agent under the
- 23 visual supervision of the commission veterinarian and-at-a-dose
- 24 level-not-to. The practicing veterinarian must deposit with the
- 25 commission veterinarian at the detention barn an unopened supply
- 26 of Lasix® and sterile hypodermic needles and syringes to be used
- 27 for the administrations. The dose level of Lasix® must not
- 28 exceed 250 milligrams (five milliliters of a
- 29 50 milligrams/milliliter or five percent
- 30 solution) per administration.
- 31 Subp. 10. Responsibility of trainer. While in the
- 32 detention barn, the horse shall be in the care, custody, and
- 33 under the control of the trainer or a licensed person assigned
- 34 by the trainer. The trainer shall be responsible for the
- 35 condition, care, and handling of the horse while it remains in
- 36 the security area.

- 3 race day use of Lasix® must be identified in the daily racing

- 5 racing for the first time using Lasix®, must be so identified in
- 6 the daily racing program.
