7 9525.1210 DEFINITIONS.

8 Subpart 1. to 10. [Unchanged.]

9 Subp. 12a. Prevocational services. "Prevocational
10 services" means services directed toward developing and
11 maintaining the skills and overall functioning of clients in
12 areas such as compliance with task instructions, prompt
13 attendance at scheduled activities, task completion, problem
14 solving, social appropriateness, and safety. Training must be
15 conducted using materials, tasks, situations, and settings that
16 are age-appropriate and enhance the clients' self esteem.

17 Adults will typically receive prevocational training on work and
18 work-related tasks, tasks related to community participation
19 such as travel and shopping, home care, and self care. Wages
20 may be paid to clients.

23 9525.1250 REIMBURSABLE SERVICES.

24 Subpart 1. Types of services. Day training and
25 habilitation services are reimbursable under the medical
26 assistance program when the services are provided for the
27 development and maintenance of life skills. Reimbursable
28 services include transportation to and from the service site and
29 supervision, assistance, and training in one or more of the
30 following when they are provided to promote age-appropriate
31 outcomes and community integration:

32 A. prevocational services, if the services meet all
33 of the following requirements:

34 (1) the documented goals of the service do not
35 include placement within one year in either a sheltered

1 workshop's transitional employment program or unsupervised
2 competitive employment in the general work force. In this
3 subitem, "unsupervised" means not directly supervised by a
4 provider or a vocational service agency; and

5 (2) the client receives ongoing supervision from
6 the provider while participating in the training activities.

7 B. to H. [Unchanged.]

8 Subp. 2. Service requirements. Day training and
9 habilitation services are reimbursable under the medical
10 assistance program if the services provided are in compliance
11 with subpart 1 and the conditions listed in items A to F are met.

12 A. to E. [Unchanged.]

13 F. Day training and habilitation services must not
14 include:

15 (1) special education and related services as
16 defined in the Education of the Handicapped Act, United States
17 Code, title 20, chapter 33, section 1401, clauses (6) and (17),
18 as amended through October 8, 1986, which otherwise are
19 available through a local educational agency; or

20 (2) vocational services funded under section 110
21 of the Rehabilitation Act of 1973, United States Code, title 29,
22 section 720, as amended through October 21, 1986, which
23 otherwise are available from a local vocational rehabilitation
24 agency.
