- 7 REGISTRATION OF SPEECH-LANGUAGE PATHOLOGISTS
- 8 AND AUDIOLOGISTS
- 9 4750.0010 SCOPE.
- 10 Parts 4750.0020 4750.0010 to 4750.0700 apply only to
- 11 persons who are applicants for registration, who are registered,
- 12 who use protected titles, or who represent that they are
- 13 registered. Parts 4750.0010 to 4750.0700 do not apply to school
- 14 personnel licensed by the Board of Teaching under part
- 15 8700.5505, provided that school personnel practicing within the
- 16 scope of their licensed occupation preface titles protected in
- 17 part 4750.0030 with the words "school" or "educational."
- 18 4750.0020 DEFINITIONS.
- 19 Subpart 1. Scope. For the purpose of parts 4750.0010 to
- 20 4750.0700, the following terms have the meanings given to them.
- 21 Subp. 2. Accredited educational institution. "Accredited
- 22 educational institution" means a university, college, or other
- 23 postsecondary educational institution that offers
- 24 speech-language pathology or audiology training and that is
- 25 accredited by the American Speech-Language-Hearing Association
- 26 or the National Council for Accreditation of Teacher Education.
- 27 Subp. 3. Advisory council. "Advisory council" means the
- 28 Minnesota Speech-Language Pathologist and Audiologist Advisory
- 29 Council established under Minnesota Statutes, section 214.13,
- 30 subdivision 4.
- 31 Subp. 4. Applicant. "Applicant" means a person who
- 32 applies to the commissioner for registration or registration
- 33 renewal.
- 34 Subp. 5. Approved continuing education sponsor. "Approved
- 35 continuing education sponsor" means an organization that offers

- 1 a learning experience designed to promote continuing competency
- 2 in the procedures and techniques of the practice of
- 3 speech-language pathology or audiology as defined in subparts 7
- 4 and 17, and that meets the criteria in part 4750.0400, subpart
- 5 3, or is a preapproved sponsor listed in part 4750.0400, subpart
- 6 2.
- 7 Subp. 6. Audiologist. "Audiologist" means a natural
- 8 person who engages in the practice of audiology as defined in
- 9 subpart 7, meets the qualifications required by parts 4750.0010
- 10 to 4750.0700, and registers as an audiologist with the
- 11 commissioner. As used in parts 4750.0010 to 4750.0700,
- 12 audiologist also means a natural person using any descriptive
- 13 word with the title audiologist.
- Subp. 7. The practice of audiology. "The practice of
- 15 audiology" means:
- A. screening, identification, assessment and
- 17 interpretation, diagnosis, rehabilitation, and prevention of
- 18 hearing disorders;
- B. conservation of the auditory system function;
- 20 development and implementation of hearing conservation programs;
- C. measurement, assessment, and interpretation of
- 22 auditory and vestibular function;
- D. selecting, fitting, and dispensing of assistive
- 24 listening devices, alerting and amplification devices and
- 25 systems for personal and public use, including hearing aids and
- 26 devices, and providing training in their use;
- 27 E. aural habilitation and rehabilitation and related
- 28 counseling for hearing impaired individuals and their families;
- F. screening of speech, language, voice, or fluency
- 30 for the purposes of audiologic evaluation or identification of
- 31 possible communication disorders; or
- 32 G. teaching of, consultation or research about, or
- 33 supervision of the functions in items A to F.
- 34 Subp. 8. Commissioner. "Commissioner" means the
- 35 commissioner of the Department of Health or a designee.
- 36 Subp. 9. Contact hour. "Contact hour" means an

- 1 instructional session of 50 consecutive minutes, excluding
- 2 coffee breaks, registration, meals with-or without a speaker,
- 3 and social activities.
- 4 Subp. 10. Continuing education. "Continuing education" is
- 5 a planned learning experience in speech-language pathology or
- 6 audiology not including the basic educational program leading to
- 7 a degree if the education is used by the registrant for credit
- 8 to achieve a baccalaureate or master's degree in speech-language
- 9 pathology or audiology.
- 10 Subp. 11. Credential. "Credential" means a license,
- 11 permit, certification, registration, or other evidence of
- 12 qualification or authorization to engage in the practice of
- 13 speech-language pathology or audiology issued by any authority.
- 14 Subp. 12. Individual. "Individual" means a person over
- 15 whom the commissioner has jurisdiction under parts 4750.0010 to
- 16 4750.0700. Individual includes an applicant, registrant, or
- 17 person who uses any title protected by part 4750.0030, whether
- 18 or not authorized to do so by parts 4750.0010 to 4750.0700.
- 19 Subp. 13. Register or registered. "Register" or
- 20 "registered" means the act or status of a natural person who
- 21 meets the requirements of parts 4750.0010 to 4750.0700 and who
- 22 is authorized by the commissioner to use the titles in part
- 23 4750.0030.
- Subp. 14. Registrant. "Registrant" means a person who
- 25 meets the requirements of parts 4750.0010 to 4750.0700 and is
- 26 authorized by the commissioner to use the titles in part
- 27 4750.0030.
- 28 Subp. 15. Registration. "Registration" is the system of
- 29 regulation defined in Minnesota Statutes, section 214.001,
- 30 subdivision 3, paragraph (c), and is the process specified in
- 31 parts 4750.0010 to 4750.0700.
- 32 Subp. 16. Speech-language pathologist. "Speech-language
- 33 pathologist" means a person who practices speech-language
- 34 pathology as defined in subpart 17, meets the qualifications in
- 35 parts 4750.0010 to 4750.0700, and registers with the
- 36 commissioner. Speech-language pathologist also means a natural

- l person using, as an occupational title, a term identified in
- 2 part 4750.0030.
- 3 Subp. 17. The practice of speech-language pathology. "The
- 4 practice of speech-language pathology" means:
- 5 A. screening, identification, assessment and
- 6 interpretation, diagnosis, habilitation, rehabilitation,
- 7 treatment and prevention of disorders of speech, articulation,
- 8 fluency, voice, and language;
- B. screening, identification, assessment and
- 10 interpretation, diagnosis, habilitation, and rehabilitation of
- 11 disorders of oral-pharyngeal function and related disorders;
- 12 C. screening, identification, assessment and
- 13 interpretation, diagnosis, habilitation, and rehabilitation of
- 14 communication disorders associated with cognition;
- D. assessing, selecting, and developing augmentative
- 16 and alternative communication systems and providing training in
- 17 their use;
- 18 E. aural habilitation and rehabilitation and related
- 19 counseling for hearing impaired individuals and their families;
- 20 F. enhancing speech-language proficiency and
- 21 communication effectiveness;
- 22 G. audiometric screening for the purposes of
- 23 speech-language evaluation or for the identification of possible
- 24 hearing disorders; or
- 25 H. teaching of, consultation or research about, or
- 26 supervision of the functions in items A to G.
- 27 Subp. 18. Supervisee. "Supervisee" means an individual
- 28 who, under the direction or evaluation of a supervisor, is:
- 29 A. engaging in the supervised practice of
- 30 speech-language pathology or audiology;
- 31 B. performing a function of supervised clinical
- 32 training as a student of speech-language pathology or audiology;
- 33 or
- C. performing a function of supervised postgraduate
- 35 clinical experience in speech-language pathology or audiology.
- 36 Subp. 19. Supervision. "Supervision" means the direct or

- l indirect evaluation or direction of:
- 2 A. a practitioner of speech-language pathology or
- 3 audiology;
- B. a person performing a function of supervised
- 5 clinical training as a student of speech-language pathology or
- 6 audiology; or
- 7 C. a person performing a function of supervised
- 8 postgraduate clinical experience in speech-language pathology or
- 9 audiology.
- 10 Subp. 20. Supervisor. "Supervisor" means a person who has
- 11 the authority to direct or evaluate a supervisee and who is:
- 12 A. a registered speech-language pathologist or
- 13 audiologist; or
- B. when the commissioner determines that supervision
- 15 by a registered speech-language pathologist or audiologist as
- 16 required in item A is unobtainable, and in other situations
- 17 considered appropriate by the commissioner, a person practicing
- 18 speech-language pathology or audiology who holds a current
- 19 certificate of clinical competence from the American
- 20 Speech-Language-Hearing Association.
- 21 4750.0030 PROTECTED TITLES AND RESTRICTIONS ON USE.
- 22 Subpart-1:--Protected-titles: A person shall not use a
- 23 title relating to speech-language pathology or audiology, except
- 24 as provided in items A to-B and B.
- 25 A. Use of the following titles terms or initials
- 26 which represent the following terms, alone or in combination
- 27 with any word or words, by any person to form an occupational

- 17 4750.0040 GENERAL REGISTRATION REQUIREMENTS; PROCEDURES AND
- 18 QUALIFICATIONS.
- 19 Subpart 1. General registration procedures. An applicant
- 20 for registration must:
- 21 A. submit an application as required in part
- 22 4750.0200, subpart 1; and
- B. submit all fees required under part 4750.0500.
- 24 Subp. 2. General registration qualifications. An
- 25 applicant for registration must possess the qualifications
- 26 required in one of the following items:
- A. A person who applies for registration before
- 28 January 1, 1993, must meet the requirements in part 4750.0050.
- B. A person who applies for registration on or after
- 30 January 1, 1993, must meet the requirements in part 4750.0060.
- 31 C. A person who applies for registration and who has
- 32 a current certificate of clinical competence issued by the
- 33 American Speech-Language-Hearing Association must meet the
- 34 requirements of part 4750.0070.
- 35 D. A person who applies for registration by

- 1 reciprocity must meet the requirements in part 4750.0080.
- 2 4750.0050 QUALIFICATIONS FOR REGISTRATION BEFORE JANUARY 1, 1993.
- 3 Subpart 1. Applicability. Except as provided under parts
- 4 4750.0070, 4750.0080, and 4750.0100, an applicant who applies
- 5 for registration before January 1, 1993, must meet the
- 6 requirements in this part.
- 7 Subp. 2. Master's degree or equivalent required. An
- 8 applicant must possess a master's degree or its equivalent, as
- 9 approved by the commissioner, in speech-language pathology or
- 10 audiology from an accredited educational institution offering
- 11 speech-language pathology or audiology training.
- 12 A. Until January 1, 1993, an applicant may qualify as
- 13 holding an equivalent to a master's degree if the applicant
- 14 holds a bachelor's degree from a regionally accredited
- 15 educational institution and provides evidence of at least 42
- 16 postbaccalaureate semester credits or 63 quarter credits or
- 17 their equivalent in courses that are acceptable toward a
- 18 graduate degree by the educational institution in which they are
- 19 taken. Thirty semester credits or 45 quarter credits or their
- 20 equivalent must be in the areas of speech-language pathology,
- 21 audiology, or speech-language and hearing science. At least 21
- 22 of the 42 semester credits or 31 of the 63 quarter credits or
- 23 their equivalent must be obtained from a single educational
- 24 institution. None of the applicable credits may have been
- 25 completed earlier than ten years before the date of
- 26 application. No more than six semester credits or nine quarter
- 27 credits or their equivalent may be credit received for clinical
- 28 training. An applicant seeking to obtain registration by
- 29 establishing an equivalent to a master's degree must submit an
- 30 application to the commissioner before January 1, 1993.
- 31 B. The master's degree training must meet the
- 32 following criteria:
- 33 (1) A minimum of 90 quarter credits or 60
- 34 semester credits or their equivalent must deal with normal
- 35 aspects of human communication, development and disorders of

- l communication, and clinical techniques for evaluation and
- 2 management of such disorders.
- 3 (2) Eighteen of the 90 quarter credits or 12 of
- 4 the 60 semester credits or their equivalent must be obtained in
- 5 courses that pertain to normal development and use of speech,
- 6 language, and hearing. The applicant must show evidence of
- 7 obtaining at least three quarter credits or two semester credits
- 8 in each of the following areas:
- 9 (a) the anatomic/physiologic bases for
- 10 normal development and use of speech, language, and hearing;
- 11 (b) physical bases and processes of the
- 12 production and perception of speech, language, and hearing; and
- 13 (c) linguistic and psycholinguistic
- 14 variables related to normal development and use of speech,
- 15 language, and hearing.
- 16 (3) Forty-five of the 90 quarter credits or 30 of
- 17 the 60 semester credits or their equivalent must be in courses
- 18 that provide information relative to communication disorders and
- 19 information about and training in evaluation and management of
- 20 speech, language, and hearing disorders. A minimum of 45 of the
- 21 90 quarter credits or 30 of the 60 semester credits or their
- 22 equivalent must be at the graduate level. Thirty-one and
- 23 one-half of the 45 quarter credits or 21 of the 30 semester
- 24 credits or their equivalent taken at the graduate level must be
- 25 within the 36 quarter credits or the 24 semester credits or
- 26 their equivalent required in the area for which registration is
- 27 sought as described in paragraphs (a) and (b).
- 28 (a) Applicants seeking registration as
- 29 speech-language pathologists must complete 36 quarter credits or
- 30 24 semester credits or their equivalent in courses pertaining to
- 31 speech and language disorders and nine quarter credits or six
- 32 semester credits or their equivalent in courses in the area of
- 33 audiology.
- i. The 36 quarter credits or 24
- 35 semester credits or their equivalent in speech and language
- 36 disorders must include at least nine quarter credits or six

- 1 semester credits or their equivalent in speech disorders and
- 2 nine quarter credits or six semester credits or their equivalent
- 3 in language disorders.
- ii. The nine quarter credits or six
- 5 semester credits or their equivalent in the area of audiology
- 6 must include at least 4.5 quarter credits or three semester
- 7 credits or their equivalent in auditory pathology and 4.5
- 8 quarter credits or three semester credits or their equivalent in
- 9 habilitation and rehabilitation.
- 10 iii. No more than nine quarter credits
- 11 or six semester credits or their equivalent may be in courses
- 12 that provide credit for clinical training obtained during
- 13 academic training.
- 14 (b) Applicants seeking registration as
- 15 audiologists must complete 36 quarter credits or 24 semester
- 16 credits or their equivalent of coursework in audiology and nine
- 17 quarter credits or six semester credits or their equivalent in
- 18 the area of speech-language pathology.
- i. The 36 quarter credits or 24
- 20 semester credits or their equivalent in audiology must include
- 21 at least nine quarter credits or six semester credits or their
- 22 equivalent in auditory pathology and nine quarter credits or six
- 23 semester credits or their equivalent in habilitation and
- 24 rehabilitation.
- 25 ii. The nine quarter credits or six
- 26 semester credits or their equivalent in speech-language
- 27 pathology must include at least 4.5 quarter credits or three
- 28 semester credits or their equivalent in speech disorders and at
- 29 least 4.5 quarter credits or three semester credits or their
- 30 equivalent in language disorders.
- 31 iii. No more than nine quarter credits
- 32 or six semester credits or their equivalent may be in courses
- 33 that provide credit for clinical training obtained during
- 34 academic training.
- 35 (c) Applicants seeking registration as both
- 36 a speech-language pathologist and an audiologist must complete a

- 1 minimum of 22.5 quarter credits or 15 semester credits or their
- 2 equivalent at the graduate level in each area of speech-language
- 3 pathology and audiology.
- Subp. 3. Supervised clinical training required. An
- 5 applicant must complete no fewer than 300 hours of supervised
- 6 clinical training as a student in an accredited educational
- 7 institution in speech-language pathology or audiology, according
- 8 to items A to C.
- 9 A. Supervision in the student's clinical training
- 10 must include evaluation and management of persons with disorders
- ll of hearing, language, and speech. At least half of the hours
- 12 must be obtained during graduate study. All of the hours must
- 13 be obtained within an accredited educational institution or in
- 14 one of its cooperating programs. A minimum of 50 hours must be
- 15 spent in at least two separate clinical settings. The first 25
- 16 hours of the clinical training must be supervised by the
- 17 educational institution's professional staff. A minimum of
- 18 one-half of each evaluation session must be supervised. The
- 19 applicant's clinical training must include work with
- 20 individuals, groups, children, and adults.
- B. An applicant for registration as a speech-language
- 22 pathologist shall complete:
- 23 (1) a minimum of 200 hours in speech-language
- 24 pathology as follows:
- 25 (a) 50 hours in evaluation of speech and
- 26 language problems;
- 27 (b) 75 hours in treatment of language
- 28 disorders;
- 29 (c) 25 hours in treatment of voice
- 30 disorders;
- 31 (d) 25 hours in treatment of articulation;
- 32 and
- (e) 25 hours in treatment of fluency
- 34 disorders; and
- 35 (2) a minimum of 35 hours in audiology as follows:
- 36 (a) 15 hours in assessment or treatment of

- l speech or language problems associated with hearing impairment.
- 2 Additional hours may be counted toward minimum hours with
- 3 language and speech disorders;
- 4 (b) 15 hours in assessment of auditory
- 5 disorders; and
- 6 (c) five hours in audiology within the
- 7 applicant's discretion.
- 8 C. An applicant for registration as an audiologist
- 9 shall complete:
- 10 (1) a minimum of 200 hours in audiology as
- ll follows:
- 12 (a) 50 hours in identification and
- 13 evaluation of hearing impairment;
- (b) 50 hours in habilitation or
- 15 rehabilitation of the hearing impaired; and
- 16 (c) 100 hours in audiology within the
- 17 applicant's discretion; and
- 18 (2) a minimum of 35 hours in speech-language
- 19 pathology in evaluation and treatment of speech and language
- 20 problems not related to hearing impairment.
- 21 Subp. 4. Supervised postgraduate clinical experience
- 22 required. An applicant must complete no less than nine months
- 23 or its equivalent of full-time supervised postgraduate clinical
- 24 experience according to this part.
- 25 A. Supervision in the postgraduate clinical
- 26 experience includes both on-site observation and other
- 27 monitoring activities. On-site observation must involve the
- 28 supervisor, the supervisee, and the client receiving
- 29 speech-language pathology or audiology services. On-site
- 30 observation must include direct observation by the supervisor of
- 31 treatment given by the supervisee. Other monitoring activities
- 32 may be executed by correspondence and include, but are not
- 33 limited to, conferences with the supervisee, evaluation of
- 34 written reports, and evaluations by professional colleagues.
- 35 Other monitoring activities do not include the client receiving
- 36 speech-language pathology or audiology services but must involve

- 1 direct or indirect evaluative contact by the supervisor of the
- 2 supervisee.
- B. The applicant must, as part of the postgraduate
- 4 clinical experience, be supervised by an individual who meets
- 5 the definition of part 4750.0020, subpart 20.
- 6 (1) When registration as a speech-language
- 7 pathologist is sought, the supervisor must be a registered
- 8 speech-language pathologist or hold a current certificate of
- 9 clinical competence in speech-language pathology from the
- 10 American Speech-Language-Hearing Association.
- 11 (2) When registration as an audiologist is
- 12 sought, the supervisor must be a registered audiologist or hold
- 13 a current certificate of clinical competence in audiology from
- 14 the American Speech-Language-Hearing Association.
- 15 C. The applicant may not begin the postgraduate
- 16 clinical experience until the applicant has completed the
- 17 academic coursework and clinical training in subparts 2 and 3.
- D. To be considered full time, at least 30 hours per
- 19 week must be spent over a nine-month period in clinical work.
- 20 Equivalent time periods may include part-time professional
- 21 employment as follows:
- 22 (1) 12 months of at least 25 hours per week;
- 23 (2) 15 months of at least 20 hours per week; or
- 24 (3) 18 months of at least 15 hours per week.
- 25 E. The applicant's postgraduate clinical experience
- 26 must include direct clinical experience with patients,
- 27 consultations, report writing, record keeping, or other duties
- 28 relevant to clinical work. A minimum of 80 percent of the
- 29 clinical experience must be in direct contact with persons who
- 30 have communication handicaps. If the applicant uses part-time
- 31 employment to fulfill the postgraduate clinical experience
- 32 requirement, all of the minimum required hours of the part-time
- 33 work week requirement must be spent in direct professional
- 34 experience.
- F. The applicant must complete the postgraduate
- 36 clinical experience within a maximum of 36 consecutive months

- l and must be supervised in no less than 36 activities, including
- 2 18 one-hour on-site observations. A maximum of six hours can be
- 3 accrued in one day. A minimum of six one-hour on-site
- 4 observations must be accrued during each one-third of the
- 5 experience.
- 6 G. The applicant must complete 18 other monitored
- 7 activities and complete at least one monitored activity each
- 8 month of the postgraduate clinical experience. Alternatives to
- 9 on-site observation and monitoring activities include activities
- 10 supervised by correspondence, evaluation of written reports, and
- ll evaluation by professional colleagues.
- 12 Subp. 5. Qualifying examination score required. An
- 13 applicant must achieve a qualifying score on the National
- 14 Examination in Speech-Language Pathology or Audiology (NESPA),
- 15 administered by NTE Programs, Educational Testing Service.
- 16 A. The commissioner shall determine the qualifying
- 17 scores for both the speech-language pathology and audiology
- 18 examinations based on guidelines provided by the advisory
- 19 council or the American Speech-Language-Hearing Association.
- 20 B. The applicant is responsible for:
- 21 (1) making arrangements to take the examination
- 22 described in this item;
- 23 (2) bearing all expenses associated with taking
- 24 the examination;
- 25 (3) having the examination scores sent directly
- 26 to the commissioner from the educational testing service; and
- 27 (4) including a copy of the scores along with the
- 28 original registration application.
- 29 C. The applicant must receive a qualifying score on
- 30 the examination within three years after the applicant applies
- 31 for registration under part 4750.0200. If the applicant does
- 32 not receive a qualifying score on the examination within three
- 33 years after the applicant applies for registration, the
- 34 applicant may apply to the commissioner in writing for
- 35 consideration to submit a new application for registration under
- 36 part 4750.0200.

- 3 Subpart 1. Applicability. Except as provided in parts
- 4 4750.0070, 4750.0080, and 4750.0100, an applicant who applies
- 5 for registration on or after January 1, 1993, must meet the
- 6 requirements in this part.
- 7 Subp. 2. Master's or doctoral degree required. An
- 8 applicant must possess a master's or doctoral degree that meets
- 9 the requirements of this part.
- 10 A. If an applicant's registration application is
- 11 postmarked on or after January 1, 1994, all of the applicant's
- 12 graduate coursework and clinical practicum required in the
- 13 professional area for which registration is sought must have
- 14 been initiated and completed at an institution whose program was
- 15 accredited by the educational standards board of the American
- 16 Speech-Language-Hearing Association in the area for which
- 17 registration is sought.
- 18 B. The master's degree training must include a
- 19 minimum of 112.5 quarter credits or 75 semester credits or their
- 20 equivalent of academic coursework that includes basic science
- 21 coursework and professional coursework.
- 22 C. Applicants for registration in either
- 23 speech-language pathology or audiology must complete 40.5
- 24 quarter credits of the 112.5 quarter credits or 27 of the 75
- 25 semester credits or their equivalent in basic science
- 26 coursework, distributed as follows:
- 27 (1) nine quarter credits or six semester credits
- 28 or their equivalent must be in biological or physical sciences
- 29 and mathematics;
- 30 (2) nine quarter credits or six semester credits
- 31 or their equivalent must be in behavioral or social sciences,
- 32 including normal aspects of human behavior and communication;
- 33 (3) 22.5 quarter credits or 15 semester credits

- 17 registration must be renewed under part 4750.0300, subpart 4.
- Subp. 2. Annual registration fee. The fee for initial
- 19 registration and annual registration renewal is \$80.
- 20 Subp. 3. Annual registration fee for dual registration as
- 21 a speech-language pathologist and audiologist. The fee for
- 22 initial registration and annual registration renewal is \$80.
- Subp. 4. Penalty fee for late renewals. The penalty fee
- 24 for late submission of a renewal application is \$15.
- Subp. 5. Surcharge. In addition to the other applicable
- 26 fees, an applicant must pay a surcharge fee of \$21. The
- 27 surcharge fee applies to all registrants during the first five
- 28 years following the effective date of parts 4750.0010 to
- 29 4750.0700.
- 30 Subp. 6. Nonrefundable fees. All fees are nonrefundable.
- 31 4750.0600 INVESTIGATION PROCESS AND GROUNDS FOR DISCIPLINARY
- 32 ACTION.
- 33 Subpart 1. Investigations of complaints. The commissioner
- 34 or advisory council may initiate an investigation upon receiving
- 35 a complaint or other oral or written communication that alleges

- 1 or implies that an individual has violated parts 4750.0010 to
- 2 4750.0700. The investigation may proceed on an oral complaint
- 3 but disciplinary action may proceed only on a signed complaint.
- 4 According to Minnesota Statutes, section 214.13, subdivision 6,
- 5 in the receipt, investigation, and hearing of a complaint that
- 6 alleges or implies an individual has violated parts 4750.0010 to
- 7 4750.0700, the commissioner shall follow the procedures in
- 8 Minnesota Statutes, section 214.10.
- 9 Subp. 2. Rights of applicants and registrants. The rights
- 10 of an applicant denied registration are stated in part
- 11 4750.0200, subpart 2, item C. A registrant shall not be
- 12 subjected to disciplinary action under this part without first
- 13 having an opportunity for a contested case hearing under
- 14 Minnesota Statutes, chapter 14.
- Subp. 3. Grounds for disciplinary action by commissioner.
- 16 The commissioner may take any of the disciplinary actions listed
- 17 in subpart 4 on proof that the individual has:
- 18 A. intentionally submitted false or misleading
- 19 information to the commissioner or the advisory council;
- B. failed, within 30 days, to provide information in
- 21 response to a written request by the commissioner or advisory
- 22 council;
- 23 C. performed services of a speech-language
- 24 pathologist or audiologist in an incompetent or negligent
- 25 manner;
- 26 D. violated parts 4750.0010 to 4750.0700;
- 27 E. failed to perform services with reasonable
- 28 judgment, skill, or safety due to the use of alcohol or drugs,
- 29 or other physical or mental impairment;
- F. been-convicted-within-the-last-five-years-of
- 31 violating-any-laws-of-the-United-States,-or-any-state-or
- 32 territory-of-the-United-States violated any state or federal
- 33 law, rule, or regulation, and the violation is a felony or
- 34 misdemeanor, an essential element of which is dishonesty, or
- 35 which relates directly or indirectly to the practice of
- 36 speech-language pathology or audiology7. Conviction for

- l violating any state or federal law which relates to
- 2 speech-language pathology or audiology is necessarily considered
- 3 to constitute a violation, except as provided in Minnesota

- 5 G. aided or abetted another person in violating any
- 6 provision of parts 4750.0010 to 4750.0700;
- 7 H. been or is being disciplined by another
- 8 jurisdiction, if any of the grounds for the discipline is the

- 10 4750.0700;
- I. not cooperated with the commissioner or advisory
- 12 council in an investigation conducted according to subpart 1;
- J. advertised in a manner that is false or
- 14 misleading;
- 15 K. engaged in conduct likely to deceive, defraud, or
- 16 harm the public; or demonstrated a willful or careless disregard
- 17 for the health, welfare, or safety of a client;
- 18 L. failed to disclose to the consumer any fee
- 19 splitting or any promise to pay a portion of a fee to any other
- 20 professional other than a fee for services rendered by the other
- 21 professional to the client;
- 22 M. engaged in abusive or fraudulent billing
- 23 practices, including violations of federal Medicare and Medicaid
- 24 laws, Food and Drug Administration regulations, or state medical
- 25 assistance laws;
- N. obtained money, property, or services from a
- 27 consumer through the use of undue influence, high pressure sales
- 28 tactics, harassment, duress, deception, or fraud;
- O. violated-any-state-or-federal-law,-rule-or
- 30 regulation-which-relates-directly-or-indirectly-to-the-practice
- 31 of-speech-language-pathology-or-audiology;
- 32 P- performed services for a client who had no
- 33 possibility of benefiting from the services;
- Q. P. failed to refer a client for medical evaluation
- 35 or to other health care professionals when appropriate or when a
- 36 client indicated symptoms associated with diseases that could be

- l medically or surgically treated; or
- 2 R. Q. if the individual is a seller of hearing
- 3 instruments as defined by Minnesota Statutes, section 153A.13,
- 4 subdivision 5, had the permit required by Minnesota Statutes,
- 5 chapter 153A, denied, suspended, or revoked according to chapter
- 6 4692.
- 7 Subp. 4. Disciplinary actions. If the commissioner finds
- 8 that an individual should be disciplined according to subpart 3,
- 9 the commissioner may take any one or more of the following
- 10 actions:
- A. refuse to grant or renew registration;
- B. suspend registration for a period not exceeding
- 13 one year;
- C. revoke registration for-a-period-not-exceeding
- 15 three-years; or
- D. take any reasonable lesser action against an

- 19 Subp. 5. Consequences of disciplinary action. Upon the

- 2 Advisory Council.
- 3 A. The seven persons must include:
- 4 (1) Two public members, as defined in Minnesota
- 5 Statutes, section 214.02. The public members shall be either
- 6 persons receiving services of a speech-language pathologist or
- 7 audiologist, or family members of or caregivers to such persons.
- 8 (2) Two speech-language pathologists registered
- 9 under parts 4750.0010 to 4750.0700, one of whom is currently and
- 10 has been, for the five years immediately preceding the
- 11 appointment, engaged in the practice of speech-language
- 12 pathology in Minnesota and each of whom is employed in a
- 13 different employment setting including, but not limited to,
- 14 private practice, hospitals, rehabilitation settings,
- 15 educational settings, and government agencies.
- 16 (3) One speech-language pathologist registered
- 17 under parts 4750.0010 to 4750.0700, who is currently and has
- 18 been, for the five years immediately preceding the appointment,
- 19 employed by a Minnesota public school district or a Minnesota
- 20 public school district consortium that is authorized by
- 21 Minnesota Statutes and who is licensed in communication
- 22 disorders by the Minnesota Board of Teaching.
- 23 (4) Two audiologists registered under parts
- 24 4750.0010 to 4750.0700, one of whom is currently and has been,
- 25 for the five years immediately preceding the appointment,
- 26 engaged in the practice of audiology in Minnesota and each of
- 27 whom is employed in a different employment setting including,
- 28 but not limited to, private practice, hospitals, rehabilitation
- 29 settings, educational settings, industry, and government
- 30 agencies.
- 31 Subp. 2. Organization. The advisory council shall be
- 32 organized and administered under Minnesota Statutes, section
- 33 15.059.
- 34 Subp. 3. Duties. The advisory council shall:
- 35 A. advise the commissioner regarding speech-language
- 36 pathologist and audiologist registration standards;

- B. advise the commissioner on enforcement of parts
- 2 4750.0010 to 4750.0700;
- 3 C. provide for distribution of information regarding
- 4 speech-language pathologist and audiologist registration
- 5 standards;
- 6 D. review applications and make recommendations to
- 7 the commissioner on granting or denying registration or
- 8 registration renewal;
- 9 E. review reports of investigations relating to
- 10 individuals and make recommendations to the commissioner as to
- 11 whether registration should be denied or disciplinary action
- 12 taken against the individual;
- 13 F. advise the commissioner regarding approval of
- 14 continuing education sponsors using the criteria in part
- 15 4750.0400, subpart 3; and
- G. perform other duties authorized for advisory
- 17 councils by Minnesota Statutes, chapter 214, or as directed by
- 18 the commissioner.
