"Grant" means a disbursement of funds to 22 an eligible applicant under the program. Subp. 6. Mental illness. "Mental illness" has the meaning 23 24 given in Minnesota Statutes, section 245.462, subdivision 20. 25 Subp. 7. Program. "Program" means the rental housing program for persons with mental illness as authorized by 26 Minnesota Statutes, section 462A.21, subdivision 8c. 27 28 Subp. 8. Project. "Project" means the proposed use of 29 grant funds as described by the applicant in the program 30 application. 31 4900.3020 ELIGIBLE RECIPIENTS. 32 To be eligible for selection as a recipient of a grant

6 4900.3030 ELIGIBLE APPLICATIONS.

7 The applicant must provide an application in the form
8 prescribed by the agency. At a minimum, this application shall
9 include the following:

A. a description of the proposed use of the funds;
B. a description of appropriate supportive services
available to the recipient;

13 C. a description of the intended target group;

D. a proposed administrative structure to efficiently provide the funds to the landlord on behalf of an individual recipient; and

E. a description of the applicant's organization including the organization's past experience in providing housing or support services to persons with mental illness, the structure of the organization, and the types of services provided.

22 4900.3040 ELIGIBLE USES OF GRANT FUNDS.

Grants may be awarded to fund direct rental subsidies for housing. Funds shall be advanced by the agency to the provider who will provide the subsidy to the landlord on behalf of the individual recipient.

27 4900.3050 SELECTION CRITERIA.

The agency shall take the following criteria into consideration when determining which applications will be selected for a grant under the program:

A. the applicant's prior experience in working with
persons with mental illness and prior experience providing
supportive services;
