7 4830.0100 DEFINITIONS FOR HIGHER EDUCATION PROGRAMS.

8 [For text of subpart 1, see M.R.]

9 Subp. 1a. **Academic year.** "Academic year" means a period
10 of time in which a full-time student is expected to complete:

11 A. the equivalent of at least two semesters, two
12 trimesters, or three quarters at an institution that measures
13 academic progress in credit hours and uses a semester,
14 trimester, or quarter system;

15 B. before July 1, 1992, at least 24 semester hours or
16 36 quarter hours at an institution that measures academic
17 progress in credit hours but does not use a semester, trimester,
18 or quarter system;

19 C. after June 30, 1992, at least 30 semester hours or
20 45 quarter hours at an institution that measures academic
21 progress in credit hours but does not use a semester, trimester,
22 or quarter system; or

23 D. at least 900 clock hours at an institution that
24 measures academic progress in clock hours.

26 Subp. 2a. **Certificate program.** After June 30, 1992,
27 "certificate program" means a program that is:

28 A. offered by an eligible school as defined in part
29 4830.0300, subpart 1;

30 B. at least 12 quarter credits or the equivalent, or
31 300 clock hours for clock hour schools; and

32 C. at least eight weeks long.

34 Subp. 3a. **Designated rural area.** "Designated rural area"
35 means the area outside the cities of Duluth, Mankato, Moorhead,

1 Rochester, St. Cloud, and outside the counties of Anoka, Carver,
2 Dakota, Hennepin, Ramsey, Scott, and Washington.

4 Subp. 5. **Eligible student.** "Eligible student" means a
5 student who meets, at a minimum, all of the following
6 requirements:

8 E. is in good standing and making satisfactory
9 academic progress, as defined in Minnesota Statutes, section
10 136A.101, subdivision 10;

13 Subp. 8a. **Full-time.** "Full-time" means the enrollment
14 level defined in Minnesota Statutes, section 136A.101,
15 subdivision 7a, except that for purposes of work-study grants
16 administered under parts 4830.2000 to 4830.2600, "full-time"
17 means enrollment in a minimum of 12 credits per quarter or
18 semester, or the equivalent.

20 Subp. 10. **Minnesota resident.** "Minnesota resident" means:

22 C. a student who graduated from a Minnesota high
23 school, unless the student is a resident of a bordering state
