7 8740.0185 DUPLICATE LICENSE.

8 A duplicate license may be issued for the fee set in part
9 8740.0290, item E, when the licensee notifies the board by
10 certified statement that the original license was lost, stolen,
11 or destroyed. The duplicate license shall be marked "duplicate"
12 and the date of its issuance indicated. If the licensee has a
13 name change, the board shall issue a new license when the
14 licensee provides verification of the name change, surrenders
15 the original license, and pays a duplicate license fee.

16 8740.0205 REINSTATEMENT OF EXPIRED LICENSE.

17 Subpart 1. Guidelines for reinstatement. An expired
18 license shall be reinstated if no fact, circumstance, or
19 condition exists to justify revocation or suspension under part
20 8740.0250; if the individual meets the education and supervision
21 requirements of Minnesota Statutes, section 148B.21; if the
22 individual passes the examination required in part 8740.0140;
23 and if the individual pays the fees required in part 8740.0290,
24 item B.

26 8740.0220 INACTIVE LICENSE STATUS.

27 Subpart 1. Application. An application for an inactive
28 license must be submitted before the expiration of the license
29 period. Upon receiving notice of the board's approval of the
30 application, the licensee must discontinue practicing social
31 work, cease displaying the license, and pay the inactive status
32 fee in part 8740.0290, item F.

34 8740.0290 FEES.

1 The fees in items A to G shall be paid by cash, personal
 2 check, bank draft, cashier's check, or money order made payable
 3 to the Board of Social Work. All fees are nonrefundable.
