3 Adopted Permanent Rules Relating to Graduation Standards

- 5 Rules as Adopted
- 6 3501.0010 PURPOSE.
- 7 The purpose of parts 3501.0010 to 3501.0180 is to establish
- 8 statewide standards that define what a Minnesota public high
- 9 school graduate should know and be able to do to function
- 10 effectively as a purposeful thinker, effective communicator,
- 11 self-directed learner, productive group participant, and
- 12 responsible citizen.
- 13 3501.0020 SCOPE.
- 14 Parts 3501.0010 to 3501.0180 govern the graduation
- 15 standards that Minnesota public schools must require for a high
- 16 school diploma for all students who enter ninth grade in 1996 or
- 17 a subsequent year.
- 18 3501.0030 DEFINITIONS.
- 19 Subpart 1. Scope. The terms used in parts 3501.0010 to
- 20 3501.0180 have the meanings given them in this part.
- 21 Subp. 2. Accommodation. "Accommodation" means an
- 22 adjustment in a testing condition, such as the setting for or
- 23 scheduling of the test, or a change in the method of
- 24 administering a test. An accommodation does not compromise the
- 25 security or the confidentiality of the test, does not alter the
- 26 meaning of the score, or render the student's score incomparable
- 27 to the scores of those students who took the test under standard
- 28 conditions. Among accommodations is providing a student with
- 29 the same test in a large-print version.
- 30 Subp. 3. Degrees of Reading Power Index of Readability or
- 31 DRP. The "Degrees of Reading Power Index of Readability" or
- 32 "DRP" means the Degrees of Reading Power Index of Readability
- 33 described in the DRP Teacher's Manual: Primary and Standard
- 34 Test Forms issued by Touchstone Applied Science Associates

- 1 (TASA), Inc. (Brewster, New York, 1989). This document is
- 2 incorporated by reference and is available through the Minitex
- 3 interlibrary loan system. This index is not subject to frequent
- 4 change.
- 5 Subp. 4. Department. "Department" means the Department of
- 6 Children, Families, and Learning.
- 7 Subp. 5. District. "District" means a school district.
- 8 Subp. 6. Exemption. "Exemption" means a temporary or
- 9 permanent waiver of the requirement that a student take a test
- 10 in the basic requirements.
- 11 Subp. 7. Individualized education plan or IEP.
- 12 "Individualized education plan" or "IEP" means a written
- 13 statement developed for a student eligible for special education
- 14 and services pursuant to Minnesota Statutes, section 120.17 and
- 15 Public Law Number 101-476, the Individuals with Disabilities
- 16 Education Act.
- 17 Subp. 8. Locally adopted tests. "Locally adopted tests"
- 18 means a test of a basic requirement that is written according to
- 19 the specifications for the state test and adopted by a school
- 20 district as the local test of the basic requirement.
- 21 Subp. 9. Modification. "Modification" means an adjustment
- 22 of a test that results in changing the standard for a particular
- 23 student. Among adjustments are: a modification of only part of
- 24 a test, a change in test questions, and a change in the
- 25 performance standard.
- 26 Subp. 10. Parent. "Parent" means the-person-or-persons
- 27 having-legal-custody-of-a-child., for a student under age 18,
- 28 the mother, father, guardian, person acting as the parent of the
- 29 child, conservator, or surrogate parent who has been appointed
- 30 in accordance with parts 3525.2435 to 3525.2455. For a pupil
- 31 age 18 or over, parent or parents also includes the pupil unless
- 32 a guardian or conservator has been appointed, in which case it
- 33 means the guardian or conservator. When the parents are
- 34 separated or divorced, it means the parent who has the legal
- 35 right, by court decree or agreement, to determine the pupil's
- 36 education, even though the pupil may be living with the other

- 1 parent.
- 2 Subp. 11. Public schools. "Public schools" means all
- 3 public schools as defined in Minnesota Statutes, section 120.05,
- 4 and includes, but is not limited to, public school districts,
- 5 charter schools, the state academies for the deaf and the blind,
- 6 and the Center for Arts Education.
- 7 Subp. 12. Section 504 accommodation plan. "Section 504
- 8 accommodation plan" means the defined appropriate accommodations
- 9 or modifications that must be made in the school environment to
- 10 address the needs of an individual student with disabilities.
- 11 This section of the federal Rehabilitation Act of 1973, Public
- 12 Law Number 91-230 as amended in Public Law Number 101-476,
- 13 extends protection to a much broader student population than
- 14 just those students with IEPs.
- 15 Subp. 13. State test. "State test" means a test of a
- 16 basic requirement that has been developed using the
- 17 specifications created for a statewide standard in reading or
- 18 mathematics. The test shall be designated by the department as
- 19 the official state test which serves as the basis for validating
- 20 all other testing options.
- 21 Subp. 14. Statewide standards. "Statewide standards"
- 22 means statements of what a student should know and be able to do.
- 23 Statewide standards are concerned with the knowledge that a
- 24 student should acquire, the concepts and processes a student
- 25 should master, and the minimum level of competency a student
- 26 should develop in the course of the student's prekindergarten
- 27 through grade 12 experience.
- Subp. 15. Student. "Student" means a person admitted to a
- 29 public school as defined in Minnesota Statutes, section 120.05,
- in accordance with Minnesota Statutes, section 120.06.
- 31 Subp. 16. Test specifications. "Test specifications"
- 32 means statements of the basic requirements that tests must
- 33 include and how tests are designed. The specifications define
- 34 the required content, format, level of difficulty, types of
- 35 items, and length of the tests.

- 1 3501.0040 STATEWIDE GRADUATION STANDARDS.
- 2 Subpart 1. Basic requirements. The basic requirements for
- 3 mathematics and reading are established in this chapter. The
- 4 statewide standards for mathematics are specified in subpart 2
- 5 and the statewide standards for reading are specified in subpart
- 6 3.
- 7 To qualify for a high school diploma, a student shall
- 8 demonstrate competency in the statewide standards for
- 9 mathematics and reading through one of the testing options in
- 10 this chapter except for decisions consistent with parts
- 11 3501.0090 and 3501.0100. School districts may require higher
- 12 standards in mathematics and reading than the statewide
- 13 standards.
- 14 Subp. 2. Statewide standard in mathematics. To meet the
- 15 basic requirement in mathematics, a student shall demonstrate
- 16 the ability to solve mathematical problems derived from
- 17 situations commonly encountered in adult life. Among common
- 18 situations is the estimation of distance traveled when the
- 19 elapsed time and average rate are known.
- 20 Subp. 3. Statewide standard in reading. To meet the basic
- 21 requirement in reading, a student shall demonstrate the ability
- 22 to read and comprehend English passages representative of widely
- 23 circulated material commonly encountered in adult life. Among
- 24 widely circulated material is a newspaper feature article.
- 25 3501.0050 TESTING FOR STATEWIDE STANDARDS IN BASIC REQUIREMENTS.
- 26 Subpart 1. School district testing options. A school
- 27 district shall test for competency in the statewide standards in
- 28 basic requirements by using:
- 29 A. a state test;
- 30 B. one of the state-approved nationally normed,
- 31 commercially published tests; or
- 32 C. a local test.
- 33 The district shall use one particular form of a test no
- 34 more frequently than once in three school years for the same
- 35 group of students.

- 1 Subp. 2. Offering tests in basic requirements. A district
- 2 shall not offer the test of a basic requirement before grade 8
- 3 but shall offer it no later than grade 10. Once a test has
- 4 first been offered to a group of students, the district shall
- 5 continue to offer a test of that basic requirement to that group
- 6 of students at least once a year.
- 7 Subp. 3. Additional testing opportunities. A district
- 8 shall establish a process for additional testing of students,
- 9 who by April 1 of their anticipated graduation year have not
- 10 passed one or more of the basic requirement tests.
- 11 The process shall include:
- 12 A. how a parent, student, or both can request:
- 13 (1) an additional opportunity to take basic
- 14 requirement tests; and
- 15 (2) testing accommodations;
- 16 B. the procedure that a district shall use to act on
- 17 a request in item A; and
- 18 C. how a parent, student, or both can appeal the
- 19 district's action under item B.
- In addition to the regularly scheduled annual availability
- 21 of the state tests, the state tests shall also be made available
- 22 by the department at a district's request for one additional
- 23 retesting of seniors.
- 24 Subp. 4. Transfer students. A student transferring into a
- 25 district shall not be required to take a test of a basic
- 26 requirement if the student's former school record verifies that
- 27 the student has already passed a test of that basic requirement
- 28 consistent with this part. This subpart applies even if the
- 29 student transfers into a district that has higher standards than
- 30 the statewide standard in the basic requirement.
- 31 3501.0060 STATE TEST OPTION.
- 32 Subpart 1. District use of state test.
- 33 A. The department shall establish and maintain state
- 34 tests in the basic requirements.
- 35 B. When a district uses a state test, it shall:

- (1) accept as final and conclusive the
- 2 department's determination on the content of the test, the
- 3 scoring of the answers, and the determination of the minimum
- 4 passing score; a district may use other test options on
- 5 subsequent testing occasions;
- 6 (2) administer the state test according to the
- 7 standard conditions for administration that shall be provided to
- 8 the district with each state test of basic requirements;
- 9 (3) return the administered state test to the
- 10 state for scoring; and
- 11 (4) adopt a passing score no lower than the
- 12 passing score given in part 3501.0180 for that basic
- 13 requirement test.
- 14 Subp. 2. Specifications for state test of mathematics.
- 15 The state test of mathematics shall assess the statewide
- 16 standard in mathematics by including the topics described in
- 17 items A to H:
- 18 A. problems involving whole numbers, fractions,
- 19 decimals, and integers; for example, finding the change from a
- 20 \$20 bill after purchasing two items of known cost;
- 21 B. problems involving percents, rate, ratios, and
- 22 proportions; for example, determining which size of a grocery
- 23 item represents the best buy;
- C. problems using concepts of number sense, place
- 25 value, and number relationships to compare, order, and determine
- 26 equivalence of whole numbers, fractions, decimals, percents, and
- 27 integers; for example, determining which of two numbers is
- 28 larger if one is in fraction form and one in decimal form;
- D. problems using estimation; for example, estimating
- 30 the approximate distance traveled when the elapsed time and
- 31 average rate are known;
- 32 E. problems applying measurement concepts; for
- 33 example, using a ruler to determine the length of the side of a
- 34 figure;
- 35 F. problems in reading, interpreting, and using one-
- 36 and two-dimensional graphic forms to analyze data, identify

- 1 patterns, and make predictions; for example, using a table to
- 2 determine in which month a show had the highest attendance;
- 3 G. problems using elementary concepts of probability
- 4 and statistics; for example, finding the average of five bowling
- 5 scores; and
- 6 H. problems applying geometric and spatial
- 7 relationships; for example, finding the total number of boxes
- 8 stacked in a display.
- 9 A student shall be permitted to use a calculator on the
- 10 state test of mathematics.
- 11 Subp. 3. Specifications for state test of reading. The
- 12 state test shall assess the statewide standard in reading. The
- 13 test shall be written according to items A to D.
- 14 A. Test questions shall test reading comprehension as
- 15 an integrated skill, with no testing of subskills or strategies.
- 16 B. The test shall be composed of passages of English
- 17 nonfiction prose that are either narrative or expository.
- 18 C. Passages shall be selected from published readings
- 19 commonly used by adults as sources of information.
- 20 D. Passages shall have a level of difficulty measured
- 21 by the Degrees of Reading Power Index of Readability. The total
- 22 test shall have an average difficulty of at least 64 DRP units.
- 23 3501.0070 NATIONALLY NORMED, COMMERCIALLY PUBLISHED TEST OPTION.
- A. A district may choose a test from the nationally
- 25 normed, commercially published tests that have been reviewed and
- 26 approved by the department according to the criteria in item D.
- 27 The department shall publish the list of approved tests annually
- 28 by August 1.
- 29 B. A district shall set the passing score on the
- 30 selected nationally normed, commercially published test to be
- 31 comparable to the state set passing score on the state test in
- 32 the same basic requirement as follows:
- 33 (1) the first time the commercially published
- 34 test is given to students, the state test in the same basic
- 35 requirement shall also be given within the same school year to

- 1 the same students;
- 2 (2) the state test shall be scored by the state;
- 3 (3) the statistical correlation of scores of
- 4 students in that district who have taken both tests shall be no
- 5 less than .70;
- 6 (4) the passing score of the commercially
- 7 published test shall be set at the point at which the percent of
- 8 the students who pass the commercially published test is the
- 9 same as or less than the percent of students who have passed the
- 10 state test;
- 11 (5) if the state or the commercially published
- 12 test changes, a district shall repeat the steps in subitems (1)
- 13 to (4) the next time the commercially published test is
- 14 administered to a new group of students; and
- 15 (6) at a district's request, the department shall
- 16 assist a district with less than 200 scores at a grade level
- 17 with the statistical analysis required in subitem (3) by
- 18 combining those scores with similar sets of scores from other
- 19 districts to create a large enough number of scores to analyze.
- 20 C. A district may choose to recognize as passing a
- 21 score at or above the 75th national percentile on any of the
- 22 nationally normed, commercially published tests on the
- 23 state-approved list.
- D. The following criteria shall be used by the state
- 25 to review and approve nationally normed, commercially published
- 26 tests in mathematics or reading:
- 27 (1) 75 percent of the specifications for the
- 28 state test in mathematics under part 3501.0060, subpart 2, are
- 29 met by the commercially published mathematics test or 75 percent
- 30 of the test items on the commercially published reading test
- 31 meet the specifications for the state test in reading under part
- 32 3501.0060, subpart 3, items A and B;
- 33 (2) the publisher's stated intention for the
- 34 instrument conforms with the district's use of the instrument;
- 35 (3) there is published evidence of instrument
- 36 reliability of at least .80 or higher;

- 1 (4) there is published evidence for the
- 2 commercially published test of instrument validity that cites
- 3 research and development processes that support or contribute to
- 4 construct validity;
- 5 (5) there is published evidence of norming data
- 6 and procedures to show that the norming population was
- 7 appropriate for the type of students taking the test; and
- 8 (6) there is a current technical report or manual
- 9 on development of the testing instrument, the uses of the
- 10 instrument and analyses of instrument data.
- 11 3501.0080 LOCAL TEST OPTION.
- 12 Subpart 1. Adoption of local test. A district may adopt
- 13 its own test for the statewide standards in the basic
- 14 requirements providing that the conditions in subpart 2 are met.
- 15 Subp. 2. Local test. The local test must measure the
- 16 standards for mathematics and reading as specified in part
- 17 3501.0040, subparts 2 and 3, respectively.
- 18 A. The test must be written according to state test
- 19 specifications for the content and level of difficulty of the
- 20 test items in mathematics and reading specified in part
- 21 3501.0060, subparts 2 and 3, respectively.
- 22 (1) The state test specifications for local tests
- 23 of mathematics shall include those specified in part 3501.0060,
- 24 subpart 2, and the following:
- 25 (a) the total test shall contain at least 40
- 26 items;
- 27 (b) test items shall represent applications
- 28 to realistic situations;
- 29 (c) tests may be multiple choice or may
- 30 require students to supply answers;
- 31 (d) incorrect options on multiple choice
- 32 items shall reflect plausible errors in concept or procedures,
- 33 represented by the problem; and
- 34 (e) the use of a calculator by the student
- 35 may be permitted.

_	(2) The state test specifications for focal tests
2	of reading include those specified in part 3501.0060, subpart 3,
3	and the following:
4	(a) each passage shall contain at least 500
5	words;
6	(b) each passage shall represent a
7	difficulty level of at least 60 DRP units;
8	(c) each test shall contain at least four
9	reading passages and no fewer than 40 questions;
10	(d) narrative passages shall not compose
11	more than 25 percent of the passages in each test;
12	(e) at least 60 percent of the test
13	questions shall require a student to show knowledge of material
14	that is explicitly stated in the test. This category shall
15	include questions on main ideas, supporting ideas, and may
16	include meanings of words from context. At least 30 percent of
17	the test questions shall require students to draw understanding
18	that is not explicitly stated in the text, but must be inferred
19	by the reader. This category may include identifying the
20	author's perspective, drawing conclusions, or distinguishing
21	between facts and opinions; and
22	(f) the questions and answers options must
23	be phrased in words different from those of the reading passage.
24	B. The passing score on the local test is determined
25	through the process established in subitems (1) to (4) for
26	determining a score comparable to the passing score on the state
27	test in the same basic requirement. The district shall set the
28	passing score on the local test as follows:
29	(1) the first time the local test is given to
30	students, the state test in the same basic requirement shall
31	also be given in the same school year to the same students;
32	(2) the state test shall be scored by the state;
33	(3) the statistical correlation of scores of
34	students in that district who have taken both tests shall be no
35	less than .70;
36	(4) the passing score of the local test shall be

- 1 set at the point at which the percent of students who pass the
- 2 local test is the same as or less than the percent of students
- 3 who have passed the state test; and
- 4 (5) if the state test changes or if a district
- 5 changes its local test, a district shall repeat the steps in
- 6 subitems (1) to (4), at the next time the local test is
- 7 administered to a new group of students.
- 8 Subp. 3. Level of knowledge. The district may require
- 9 more knowledge, a higher level of difficulty, or both, than the
- 10 state test specifications if the district has established
- 11 graduation standards that are higher than the statewide
- 12 graduation standards.
- 13 3501.0090 STUDENTS WITH INDIVIDUALIZED EDUCATION PLANS OR
- 14 SECTION 504 ACCOMMODATION PLANS.
- 15 Subpart 1. Considerations for students with IEPs or
- 16 section 504 accommodation plans.
- 17 A. The IEP or section 504 accommodation plan for a
- 18 student with a disability shall identify one of the following
- 19 decisions for each of the basic requirements:
- 20 (1) the student is expected to achieve the
- 21 statewide standard with or without testing accommodations;
- 22 (2) the student is expected to achieve the
- 23 statewide standard at an individually modified level of
- 24 difficulty; or
- 25 (3) the student is exempt from the statewide
- 26 standard.
- 27 An exemption from the statewide standard shall be granted
- 28 to a special needs student when the student cannot demonstrate
- 29 the required degree of learning with appropriate accommodations
- 30 or modifications if:
- 31 (a) the student's IEP or section 504
- 32 accommodation plan does not and never has included the
- 33 requirements on which the tests are based; or
- 34 (b) the student is enrolled in special
- 35 education classes for the subject matter included in the test,

- 1 but the student's IEP or section 504 accommodation plan does not
- 2 include a majority of concepts tested.
- B. Adoption of modifications or exemptions for a
- 4 student as stated in item A, shall occur concurrently with the
- 5 adoption of transition goals and objectives as required in
- 6 Minnesota Statutes, section 120.17, subdivision 3a, clause (1).
- 7 Subp. 2. Testing students with IEPs or section 504
- 8 accommodation plans.
- 9 A. All students shall be tested under standard
- 10 conditions as specified by the developer of the test except
- 11 those students whose IEPs specify other decisions consistent
- 12 with subpart 1, item A.
- B. Decisions regarding appropriate testing conditions
- 14 including a decision to provide accommodations for a student
- 15 with special needs shall be made by the local school district
- 16 through the IEP process or the section 504 accommodation plan
- 17 process and shall be reviewed annually.
- 18 C. Where subpart 1, item A, subitem (2), applies, the
- 19 student's IEP or section 504 accommodation plan shall define an
- 20 appropriate assessment of the statewide standard at a modified
- 21 level of difficulty. Achievement of the individually modified
- 22 standard shall be certified only through documented student
- 23 performance of the defined assessment.
- 24 3501.0100 TESTING CONSIDERATIONS FOR LIMITED ENGLISH PROFICIENT
- 25 (LEP) STUDENTS.
- 26 Subpart 1. Scope. This part applies to individuals whose
- 27 first language is not English and whose test performance may be
- 28 negatively impacted by lack of English language proficiency.
- 29 Subp. 2. District process. Each district shall establish
- 30 a process for determining whether individual students whose
- 31 first language is not English shall take basic requirements
- 32 tests under standard test conditions, with language
- 33 accommodations, with language translation of the mathematics
- 34 test, or be temporarily exempted from testing. Parents of LEP
- 35 students, teachers of LEP students, and district personnel

- 1 responsible for testing shall be involved in establishing this
- 2 process.
- 3 Subp. 3. Temporary exemption. A student may be
- 4 temporarily exempted from participation in testing if the
- 5 student has been enrolled for three or fewer years in a school
- 6 in which the primary language of instruction is English. If the
- 7 student is temporarily exempted, the exemption shall be reviewed
- 8 annually according to the process in subpart 2.
- 9 Subp. 4. Test of reading. Language accommodations and
- 10 language translations to basic requirements tests shall not be
- 11 applied to the testing of reading. Students shall demonstrate
- 12 English language competence in the testing of reading.
- 13 Subp. 5. Language translations. A district may translate
- 14 the mathematics test into a language other than English.
- Subp. 6. Learning opportunities. Part 3501.0110 applies
- 16 to students granted considerations under this part.
- 17 3501.0110 OPPORTUNITIES TO LEARN AND REMEDIATION.
- 18 A school district's curriculum shall include opportunities
- 19 for all students to learn the basic requirements. At least two
- 20 years before the anticipated date of the student's graduation,
- 21 the district shall develop a plan for remediation for students
- 22 who have not passed one or more basic requirements tests except
- 23 for exempt students under part 3501.0090, subpart 1, item A,
- 24 subitem (3).
- 25 3501.0120 REQUIRED NOTIFICATION TO PARENTS AND STUDENTS.
- 26 Subpart 1. Written notice. A school district shall
- 27 establish and maintain a system to provide written notice to
- 28 parents and students about graduation requirements.
- 29 Subp. 2. Notice of graduation requirements. No later than
- 30 30 working days after the date of the entrance into the 9th
- 31 grade or transfer of a student into the district during or after
- 32 9th grade, the school district shall provide to the parents and
- 33 the student written notice of:
- 34 A. the graduation requirements; and
- 35 B. the grade in which the student shall have the

- l first opportunity to take a test in basic requirements.
- 2 Subp. 3. Notice of test results and remediation
- 3 opportunities. The school district shall provide no later than
- 4 90 days after a student takes a test of basic requirements,
- 5 written notice to parents and the student of:
- 6 A. basic requirement test results; and
- 7 B. consistent with part 3501.0050, subpart 3, if the
- 8 student is in the graduating year:
- 9 (1) the process by which a parent or student can
- 10 request additional testing and testing accommodations after
- ll April 1; and
- 12 (2) how a parent or student can appeal the
- 13 district's decision in subitem (1).
- 14 3501.0130 STUDENT RECORDKEEPING.
- 15 Subpart 1. Test results. The district shall keep a record
- 16 on each student that includes:
- 17 A. the basic requirement tests taken; and
- 18 B. the results of the most recent basic requirement
- 19 tests given.
- 20 Subp. 2. Student progress. Individual student progress
- 21 shall be reported on a student record as described in items A to
- 22 D.
- A. "Pass-state level" shall be noted on the record of
- 24 a student who passes a basic requirement test under standard
- 25 conditions or with an accommodation. The records for students
- 26 passing with an accommodation shall not be different from the
- 27 records of students passing the test under standard conditions.
- 28 B. "Pass-individual level" shall be noted on the
- 29 record of a student who passes a basic requirement test with a
- 30 modification established in the IEP or section 504 accommodation
- 31 plan in accordance with part 3501.0090.
- 32 C. "Pass-translation" shall be noted on the record of
- 33 a student who passes a basic requirement test that has been
- 34 translated into a language other than English and has not been
- 35 validated by the state as a state test with a set passing score.

- 1 D. "Exempt" shall be noted on the record of a student
- 2 who has been exempted from a basic requirement test.
- 3 3501.0140 TEST ADMINISTRATION.
- 4 Subpart 1. Testing conditions. The school district shall
- 5 administer the test that the district chooses from the options
- 6 given in part 3501.0060 for testing a basic requirement under
- 7 standard testing conditions defined by the developer of the
- 8 particular test using the directions provided with the test.
- 9 Test administration with accommodations or modifications to
- 10 standard testing conditions shall occur only in accordance with
- 11 part 3501.0090 or 3501.0050, subpart 3.
- 12 Subp. 2. District testing plan. The district board shall
- 13 annually adopt and publish a basic requirement test
- 14 administration plan. The plan shall be filed with the
- 15 department and delivered to all households in the district by
- 16 October 15 of each year. At a minimum, the plan shall include:
- 17 A. the graduation requirements;
- 18 B. the test options that the district chooses to use
- 19 to test the basic requirements;
- 20 C. in what grade the test of a basic requirement
- 21 shall first be offered;
- D. how many opportunities a student shall have to
- 23 retake tests of basic requirements during each year;
- 24 E. the opportunities for remediation for a student
- 25 who has not passed tests of the basic requirements;
- 26 F. the process used by the district for reviewing the
- 27 test items of a local test in a basic requirement to determine
- 28 that the material does not offend or disadvantage any particular

- 33 basic requirements;
- 34 H. the process for appealing the district's response

- 1 I. how to report breaches in test security procedures
- 2 to the district and the department.
- 3 3501.0150 TEST SECURITY.
- 4 Subpart 1. Security requirements. When administering
- 5 tests for the basic requirements, the district shall observe the
- 6 following test security measures:
- 7 A. all test booklets, answer sheets, and test
- 8 materials shall be placed in locked storage before and after the
- 9 test administration;
- 10 B. the tests, testing materials, and answer sheets
- 11 are nonpublic data under Minnesota Statutes, section 13.34;
- 12 C. no copies of test booklets or answer sheets shall
- 13 be made; and
- D. school districts shall report any known violations
- 15 of test security to the department. The department shall
- 16 receive reports of violations of test security from anyone with
- 17 knowledge of such an incident.
- 18 Subp. 2. Security violations. The department shall
- 19 investigate any reported incidents of breaches in test security.
- 20 The consequences of a violation in test security may include:
- 21 A. the invalidation of test scores if a violation is
- 22 found to justify serious questions about the integrity of the
- 23 results of the test administration; or
- 24 B. other reasonable sanctions that are necessary to
- 25 preserve the security and confidentiality of future tests and
- 26 test administrations.
- 27 3501.0160 DISTRICT REPORTING REQUIREMENTS.
- A. The district shall report the information in item
- 29 C to the department annually by October 15 in a format to be
- 30 determined by the department.
- 31 B. The district shall prepare and disseminate
- 32 annually by October 15 a public report of the information in
- 33 item C, through the newspaper officially designated for school
- 34 district notices or through publication sent to all households
- 35 in the district.

- 1 C. The reports required in items A and B shall
- 2 include:
- 3 (1) the number of students enrolled at each grade
- 4 level 9 through 12 according to the end of the year Minnesota
- 5 Automated Reporting Student System (MARSS) report;

- 7 through 12 passing each basic requirement at the state standard

- 9 (3) the number of students at each grade level 9
- 10 through 12 passing each basic requirement at an individualized
- 11 level under an IEP and a section 504 accommodation plan;
- 12 (4) the number of students at each grade level 9
- 13 through 12 passing tests in each basic requirement that has been
- 14 translated into a language other than English;
- 15 (5) the number of students at each grade level 9
- 16 through 12 exempt from testing in each basic requirement; and
- 17 (6) for grade 12 of the previous year only, the
- 18 number of students currently denied a high school diploma
- 19 because of not passing the state standard for a basic
- 20 requirement when all other graduation requirements have been met.
- 21 3501.0170 REQUIRED DOCUMENTATION FOR PROGRAM AUDIT.
- 22 The school district shall maintain records necessary for
- 23 program audits conducted by the department. The records must
- 24 include documentation that:
- A. tests used for the basic requirements comply with
- 26 parts 3501.0060 to 3501.0080;
- 27 B. the process that the district used to set the
- 28 passing scores on approved commercially published tests or local
- 29 tests meets the requirements of parts 3501.0070 and 3501.0080,
- 30 respectively;
- 31 C. required notifications to parents and students
- 32 meet the requirements of part 3501.0120;
- 33 D. required student records meet the requirements of
- 34 part 3501.0130;
- 35 E. the district's process for additional testing of

- 1 students meets the requirements of part 3501.0050;
- F. test security procedures comply with part
- 3 3501.0150;
- 4 G. local district decisions regarding testing
- 5 accommodations, modifications, and granting exemptions are in
- 6 compliance with parts 3501.0090 and 3501.0100;
- 7 H. the school district's curriculum and instruction
- 8 provides appropriate learning opportunities in the basic
- 9 requirements in compliance with part 3501.0110;
- 10 I. remediation plans for students are on file
- 11 consistent with part 3501.0110;
- J. the basic requirement test administration plan
- 13 complies with part 3501.0140, subpart 2;
- 14 K. the documentation for students granted
- 15 accommodations or exempted from testing complies with part
- 16 3501.0090;
- 17 L. the assessments and documentation of performance
- 18 for students granted modifications of statewide standards comply
- 19 with part 3501.0090, subpart 2, item C; and
- 20 M. the district's process for testing considerations
- 21 for LEP students complies with part 3501.0100.
- 22 3501.0180 PASSING SCORES FOR STATE TESTS OF BASIC REQUIREMENTS.
- 23 Subpart 1. Setting scores. The scores in this part are
- 24 established for each grade 9 class beginning with the class
- 25 entering in 1996. Once set, the basic requirements passing
- 26 scores shall not change for a particular group of entering grade
- 27 9 students.
- 28 Subp. 2. Mathematics. The passing score for the state
- 29 test of mathematics is 70 percent for students entering grade 9
- 30 in 1996; is 75 percent for students entering grade 9 in 1997;
- 31 and is 80 percent for students entering grade 9 in 1998 and
- 32 thereafter.
- 33 Subp. 3. Reading. The passing score for the state test of
- 34 reading is 70 percent for students entering grade 9 in 1996; is
- 35 75 percent for students entering grade 9 in 1997; is 80 percent

1 for students entering grade 9 in 1998 and thereafter.
