 2 **Adopted Permanent Rules Relating to Wildlife**

3 **6133.0075 GRAY WOLVES.**

4 The restitution value for gray wolves is \$2,000.

5 **6230.0200 SPECIAL PROVISIONS FOR WILDLIFE MANAGEMENT AREAS.**

6 [For text of subps 1 and 2, see M.R.]

7 Subp. 3. **Areas closed to migratory waterfowl hunting.** The Gordon F. Yeager
 8 wildlife management area and the Eastside wildlife management area in Olmsted
 9 county and the Carl Schmidt wildlife management area in Morrison county are closed to
 10 the taking of migratory waterfowl.

11 [For text of subps 4 to 10, see M.R.]

12 Subp. 11. **Areas with other restrictions.**

13 A. The Schrafel wildlife management area in Mower county is closed to trapping
 14 and firearms hunting. It is open to archery deer hunting.

15 B. The Hvoslef wildlife management area in Fillmore county is open to archery
 16 hunting only from September 1 to October 31 and during the spring wild turkey
 17 seasons. Firearms hunting, except the use of centerfire rifles, is allowed from November
 18 1 to December 15.

19 Subp. 12. **Sanctuary areas open to hunting.** The following sanctuary areas of wildlife
 20 management areas posted with "Wildlife Sanctuary Do Not Trespass" signs are open for
 21 hunting as specified:

22 A. The Talcot Lake wildlife management area sanctuary is open for deer hunting
 23 by persons with disabilities at designated stands, by permit, during the established state
 24 seasons.

25 B. The Carlos Avery wildlife management area sanctuaries are open for:

1 (1) deer hunting by persons with disabilities at designated stands, by permit,
2 during the dates provided by rule; and

3 (2) taking wild turkeys during the spring wild turkey season in those portions of
4 the sanctuaries that lie within an open spring wild turkey hunting zone.

5 **6230.0250 GENERAL PROVISIONS FOR USE OF WILDLIFE MANAGEMENT**
6 **AREAS.**

7 Subpart 1. **Waterfowl season, defined.** For the purposes of this part, "waterfowl
8 season" means any day that there is an open season for the taking of migratory
9 waterfowl.

11 Subp. 5. **Entry and hours of use.** A person may not enter a portion of a wildlife
12 management area posted closed to trespass, except as posted or as otherwise authorized
13 by an agent of the commissioner. Wildlife management areas may not be entered or
14 used during closed hours posted at the major access points, except by permit.

16 Subp. 7. **Overnight use.** A person may not camp on or remain in a vehicle overnight
17 in any wildlife management area, except by permit or where posted for this use by the
18 commissioner. A person may not leave a vehicle, trailer, or tent overnight within a
19 wildlife management area, except by permit or in areas and at times designated by signs
20 for overnight use. A vehicle, trailer, or tent lawfully left overnight must be occupied or
21 attended.

23 Subp. 9. **Use of motorboats.** Motorboat use is prohibited within a wildlife
24 management area, except where posted or as provided in this subpart. For purposes of
25 this chapter, "motorboat" includes motorboats as defined in Minnesota Statutes, section
26 86B.005, subdivision 9, and duckboats with motors attached.

2 E. Roseau River wildlife management area in Roseau county: motorboats may be
3 used in the main channel and oxbows of the Roseau River. Motorboats of ten
4 horsepower or less may be used elsewhere within the area only during a waterfowl
5 season.

7 J. Swamp River wildlife management area in Cook county: motorboats may be
8 used with no limit on size.

10 **6230.0400 SPECIAL PROVISIONS FOR STATE GAME REFUGES.**

11 [For text of subps 1 to 20, see M.R.]

12 Subp. 21. **Lac qui Parle game refuge, Chippewa and Lac qui Parle counties.** The
13 following special provisions apply to the Lac qui Parle game refuge, Chippewa, and Lac
14 qui Parle counties:

15 [For text of items A to C, see M.R.]

16 D. Designated hunting stations within the refuge must be spaced no less than 200
17 yards apart and must be no more than 125 yards inside the refuge, as measured from
18 the posted boundary.

19 [For text of subps 22 to 29, see M.R.]

20 Subp. 30. **Moscow game refuge, Freeborn county.** The Moscow game refuge in
21 Freeborn county is open to:

22 A. small game hunting, except ducks and mergansers;

23 B. trapping;

24 C. deer and bear hunting by firearms; and

25 D. deer and bear hunting by archery.

1 Subp. 31. **Nerstrand Woods game refuge, Rice county.** That portion of the Nerstrand
 2 Woods game refuge in Rice county that is within the Nerstrand Big Woods State Park
 3 and the Prairie Creek Woods Scientific and Natural Area is open to deer hunting by
 4 muzzleloader special permit only. The remainder of the refuge is open to:

- 5 A. trapping;
- 6 B. deer and bear hunting by firearms; and
- 7 C. deer and bear hunting by archery.

9 Subp. 50. **Whitewater game refuge, Winona county.** The Whitewater game refuge in
 10 Winona county is open to:

- 11 A. small game hunting, except waterfowl;
- 12 B. trapping by permit; and
- 13 C. firearms deer hunting only by permit.

15 Subp. 53. **Austin game refuge, Mower county.** The Austin game refuge in Mower
 16 county is open to deer hunting by archery.

17 **6230.0500 GENERAL REGULATIONS FOR CONTROLLED HUNTING ZONES.**

18 The following regulations apply to all persons within a controlled hunting zone
 19 during the open Canada goose seasons or as otherwise specified in parts 6230.0600 to
 20 6230.1100:

21 [For text of items A to C, see M.R.]

22 D. A person may not leave any refuse, offal, or feathers on public lands in the
 23 controlled hunting zone or in any parking lot.

24 E. Alcoholic beverages may not be consumed or possessed at any of the hunting
 25 stations on public lands.

1 F. A person may not loiter in areas between the designated hunting stations on
2 public lands.

3 G. On public lands, dogs must be on a leash except within ten feet of stations or
4 while retrieving, and must be under control at all times.

5 H. On public lands, after each party member has bagged a limit of Canada geese,
6 or expended a limit of shells, the party must promptly leave the station.

8 **6230.0700 THIEF LAKE (EARLY) AND LAC QUI PARLE SPECIAL PROVISIONS.**

9 [For text of subpart 1, see M.R.]

10 Subp. 2. **Hunting stations.** Waterfowl and small game hunters may reserve
11 designated hunting stations in accordance with regulations available at the Thief Lake
12 and Lac qui Parle wildlife management area headquarters. Reservation dates may not
13 be changed. Only one hunting group, consisting of no more than three hunters, may
14 occupy a designated hunting station at one time. At Lac qui Parle, not more than six
15 hunting groups per day may occupy a designated hunting station.

16 Subp. 3. **Back tag permit required.** On public lands, a person may not hunt migratory
17 waterfowl or small game in the controlled hunting zone without first registering at the
18 check station and obtaining a back tag permit. Back tags must be worn as specified on
19 the permit. Hunters age 18 or older will be charged a \$3 daily fee for the Lac qui Parle
20 back tag permit. Failure to comply with the provisions of the permit or special
21 provisions relating to the controlled hunt will result in immediate revocation of the
22 permit for that day.

24 Subp. 6. **Actions after taking bag limit.** Within one hour of hunt completion each
25 party member must submit any geese taken for inspection at the Lac qui Parle wildlife
26 management area headquarters and, if hunting on public lands, personally return their
27 entry permit to the check station.

6230.1600 AIRBOAT USE ON DESIGNATED WILDLIFE MANAGEMENT LAKES.

The use of airboats is prohibited at all times on the lakes listed below that have been designated for wildlife management purposes, except as otherwise authorized by posting or permit:

12 **6232.1250 TAKING DEER BY ARCHERY UNDER INTENSIVE HARVEST PERMITS.**

13 [For text of subpart 1, see M.R.]

14 Subp. 2. **Restrictions.** Intensive harvest permits may be used to take antlerless deer
 15 only or antlerless deer and adult bucks in antlerless permit areas and special hunt areas
 16 prescribed by the commissioner.

17 **6232.2200 ARMS USE AREAS AND RESTRICTIONS FOR MUZZLELOADERS.**

18 Only legal muzzleloaders with open or peep type sights may be used for taking deer
 19 during the muzzleloader season.

20 **6232.2800 GENERAL REGULATIONS FOR TAKING BEARS.**

21 [For text of subps 1 to 3, see M.R.]

22 Subp. 4. **Tagging and license validation.** Persons taking a bear must affix a tag and
 23 validate their license at the site of kill as provided below:

24 A. Persons killing a bear must affix to the carcass the site tag provided with their
 25 bear hunting license. The tag must be fastened around the bear's sternum (breast bone),
 26 through an ear, or around a leg bone or tendon so that the tag cannot be readily
 27 removed. A hunter may not possess or use the site tag of another, except when
 28 transporting a bear as provided by Minnesota Statutes, section 97A.535.

1 Subp. 6. **Registration.** Every person taking a bear must present it for registration at a
2 designated bear registration station or, in the case of a nuisance bear authorization, to
3 the authorizing wildlife manager or officer, within 48 hours after taking and obtain a big
4 game possession tag. Prior to transporting the bear from the registration station, the
5 possession tag must be attached to the bear in the same manner as the site tag provided
6 with the license.

8 Subp. 8. **White bears protected.** A person may not take a white bear.

9 **6232.2900 BEAR PERMIT PROCEDURES.**

10 [For text of subpart 1, see M.R.]

11 Subp. 2. **Drawings.** Drawings will be conducted by the department to determine
12 those eligible to purchase a bear license within the bear quota areas. Preference in the
13 drawings will be given to applicants based upon the number of times they have
14 correctly applied for a license in a quota area in previous years but have not been
15 selected. Upon issuance of a quota area license, all accumulated preference will be lost.
16 Obtaining a no-quota bear license will have no effect upon eligibility or preference in
17 the drawings. In quota areas with fewer applicants than available licenses, the
18 remaining available licenses may be issued to unsuccessful applicants for other quota
19 areas on a first-come, first-served basis. Individuals who purchase these remaining
20 available licenses will retain their accumulated preference.

22 **6232.3300 NUISANCE BEARS.**

23 Nuisance bears may be taken by licensed bear hunters from July 1 to August 31 under
24 the conditions in this part.

25 A. Wildlife managers or conservation officers may authorize licensed hunters to
26 take nuisance bears after the manager or officer has verified that a nuisance problem
27 exists.

2 C. A licensee taking a nuisance bear prior to the season must register it with the
3 authorizing wildlife manager or conservation officer within 48 hours after taking.

7 Subp. 20. **Moose Zone 21.** Moose Zone 21 consists of that portion of the state lying
8 within the following described boundary:

9 Beginning at the junction of State Trunk Highway (STH) 169 and the Superior
10 National Forest boundary in Township 62 North, Range 13 West, Sections 3
11 and 4; thence south along said boundary to Muckwa lake; thence along the
12 west shore of Muckwa lake to the Superior National Forest boundary; thence
13 along said boundary to Bear Island lake; thence along the west shore of Bear
14 Island lake to the public access on the south shore; thence southerly along
15 County State Aid Highway (CSAH) 490, St. Louis county; thence along CSAH
16 490 to CSAH 904, St. Louis county; thence along CSAH 904 to CSAH 21, St.
17 Louis county; thence along CSAH 21 to CSAH 70, St. Louis county; thence
18 along CSAH 70 to Forest Road (FR) 112; thence along FR 112 to FR 424;
19 thence along FR 424 to the Erie Mining Company railroad; thence along said
20 railroad to FR 116; thence along FR 116 to FR 114; thence along FR 114 to FR
21 112; thence along FR 112 to FR 1431; thence along FR 1431 to FR 424; thence
22 along FR 424 to FR 178; thence along FR 178 to FR 1860; thence along FR 1860
23 to the shore of Birch lake; thence along the east shore of Birch lake to the
24 South Kawishiwi river; thence along the east and south shore of said river to
25 the Kawishiwi river; thence westerly along the southerly shores of said river
26 to Farm lake; thence along the east and south shores of Farm lake to the boat
27 ramp on the west shore of Farm lake; thence along the boat ramp road to
28 Section Thirty Road; thence along said road to STH 169; thence along STH
29 169 to the point of beginning.

31 Subp. 24a. **Moose Zone 26.** Moose Zone 26 consists of that portion of the state lying
32 within the following described boundary:

33 Beginning where the Horse river meets the Canadian border near the
34 southeastern tip of Crooked lake; thence southwesterly along the Horse river
35 to Horse lake; thence along the east shore of Horse lake to the portage to Tin
36 Can Mike lake; thence along the portage and streams connecting Tin Can

1 Mike, Sandpit, and Range lakes to the access trail on the south shore of Range
2 lake; thence southerly along the access trail to the Range lake access road;
3 thence along the Range lake access road to Forest Road (FR) 1036; thence
4 along FR 1036 to FR 459; thence along FR 459 to County State Aid Highway
5 (CSAH) 116 (Echo Trail), St. Louis county; thence along CSAH 116 to CSAH
6 88, St. Louis county; thence along CSAH 88 to State Trunk Highway (STH)
7 169; thence along STH 169 to CSAH 58, St. Louis county; thence along CSAH
8 58 to CSAH 16, Lake county (Section Thirty Road); thence along CSAH 16 to
9 the public access on Farm lake; thence along the east shore of Farm lake to the
10 North Kawishiwi river; thence easterly along the North Kawishiwi river to
11 the public access on Lake One and the junction with CSAH 18, Lake county
12 (Fernberg Road); thence along CSAH 18 to the former access point for Forest
13 Trail (FT) 147 (Kekekabic Trail); thence northeasterly along FT 147 to the
14 portage between Strup and Kekekabic lakes; thence to Kekekabic lake and
15 along the south shore of said lake and a swampy flowage to Grubstake lake;
16 thence through Grubstake lake and north to Skoota lake; thence overland in a
17 northerly direction to Knife lake and the Canadian border; thence westerly
18 along the Canadian border to the point of beginning.

19 Subp. 24b. **Moose Zone 27.** Moose Zone 27 consists of that portion of the state lying
20 within the following described boundary:

21 Beginning at the junction of County State Aid Highway (CSAH) 116, St. Louis
22 county (Echo Trail) and Forest Road (FR) 459; thence along CSAH 116 to
23 CSAH 88, St. Louis county; thence along CSAH 88 to State Trunk Highway
24 (STH) 169; thence along STH 169 to Old STH 169; thence northwesterly along
25 Old STH 169 for 0.7 miles to a point south of Armstrong Bay of Lake
26 Vermillion; thence north to said bay; thence along the east and north shore of
27 Lake Vermillion to the portage to Trout lake; thence along the portage and
28 the east shore of Trout and Little Trout lakes to the portage to the Little
29 Indian Sioux river; thence along the portage and the Little Indian Sioux river
30 to Otter lake; thence through Otter and Cummings lakes to Forest Trail (FT)
31 163; thence easterly along FT 163 to CSAH 644, St. Louis county; thence along
32 CSAH 644 to CSAH 116, St. Louis county; thence along CSAH 116 to the
33 point of beginning.

34 Subp. 24c. **Moose Zone 28.** Moose Zone 28 consists of that portion of the state lying
35 within the following described boundary:

36 Beginning at the intersection of County State Aid Highway (CSAH) 2, Lake
37 county and Superior National Forest Road (NFR) 122; thence along NFR 122
38 to CSAH 44, St. Louis county; thence along CSAH 44 to County Road (CR)
39 266 (Fox Farm Road), St. Louis county; thence along CR 266 to the North
40 Shore snowmobile trail; thence in a northeasterly direction along the North
41 Shore snowmobile trail to CSAH 2, Lake county; thence along CSAH 2 to the
42 point of beginning.

2 Subp. 27. **Moose Zone 31.** Moose Zone 31 consists of that portion of the state lying
3 within the following described boundary:

4 Beginning at the intersection of State Trunk Highway (STH) 1 and County
5 State Aid Highway (CSAH) 4, Lake county; thence in a southwesterly
6 direction along CSAH 4 to CSAH 3, Lake county; thence along CSAH 3 to
7 Silver Creek Township Road (TR) 24 (Alger Grade); thence along TR 24 to
8 CSAH 2, Lake county; thence along CSAH 2 to Forest Road (FR) 104; thence
9 along FR 104 to FR 102; thence along FR 102 to the Erie Mining Company
10 railroad; thence along the Erie Mining Company railroad to STH 1; thence
11 along STH 1 to the point of beginning.

12 Subp. 28. **Moose Zone 32.** Moose Zone 32 consists of that portion of the state lying
13 within the following described boundary:

14 Beginning on the Little Indian Sioux river at its intersection with County State
15 Aid Highway (CSAH) 116 (Echo Trail) St. Louis county; thence in a northerly
16 direction along the Little Indian Sioux river to Lower Pauness lake; thence
17 along the east shore of Lower Pauness lake to the portage to Shell lake; thence
18 along said portage and the south shore of Shell lake to the portage to Little
19 Shell lake; thence through Little Shell lake to the portage to Lynx lake; thence
20 along the portage and through Lynx lake to the portage to Ruby lake; thence
21 along the portage and east and north along the south shore of Ruby lake to
22 the portage to Hustler lake; thence along the portage and the south shore of
23 Hustler lake to the portage to Oyster lake; thence along the portage and the
24 south shore of Oyster lake to the portage to Oyster river; thence along the
25 portage and southerly along the Oyster river to its junction with the Nina
26 Moose river; thence east along the Nina Moose river to its confluence with
27 Lake Agnes; thence along the south shore of Lake Agnes to the portage to
28 Boulder river; thence along the portage to and easterly along the Boulder
29 river to its confluence with the Dahlgren river; thence southerly along the
30 Dahlgren river to its confluence with Stuart lake; thence along the south shore
31 of Stuart lake to the portage to Nibin lake; thence along the portage and along
32 the south shore of Nibin and Bibon lakes to the portage to Sterling lake;
33 thence along the portage and the south shore of Sterling lake to Sterling
34 creek; thence easterly along Sterling creek to its confluence with the Beartrap
35 river; thence easterly and southerly along the Beartrap river through Sunday
36 lake to Beartrap lake; thence along the south shore of Beartrap lake to
37 Thunder lake; thence south along the west shore of Thunder lake to the
38 portage to Mud Hole lake; thence along the portage and through Mud Hole
39 lake to the portage to Gull lake; thence along the portage and the north shore
40 of Gull lake to the portage to Gun lake; thence along the portage and the west
41 shore of Gun lake to the portage to Fairy lake; thence along the portage and

1 the west shore of Fairy lake to the portage to Boot lake; thence along the
2 portage and the west and south shores of Boot lake to the portage to
3 Fourtown lake; thence along the portage and the west, south, and east shores
4 of Fourtown lake to the portage to Horse lake; thence along the portage and
5 the west shore of Horse lake to the portage to Tin Can Mike lake; thence
6 along the portage to Tin Can Mike lake; thence in a southwesterly direction
7 across all portages and along all streams connecting Tin Can Mike, Sandpit,
8 and Range lakes, thence to the access trail on the south shore of Range lake;
9 thence in a southerly direction along the access trail to the Range lake access
10 road; thence along said road in a southwesterly direction to Forest Road (FR)
11 1036; thence along FR 1036 to FR 459; thence along FR 459 to CSAH 116 (Echo
12 Trail), St. Louis county; thence along CSAH 116 to the point of beginning.

13 [For text of subps 29 to 29b, see M.R.]

14 Subp. 29c. **Moose Zone 36.** Moose Zone 36 consists of that portion of the state lying
15 within the following described boundary:

16 Beginning at the south tip of Horse lake, St. Louis county; thence along the
17 east shore of Horse lake to the Horse river; thence along the Horse river to the
18 Canadian border; thence along the Canadian border through Crooked, Iron,
19 Bottle, Lac La Croix, and Loon lakes to the confluence with the Little Indian
20 Sioux river; thence along the Little Indian Sioux river to Lower Pauness lake;
21 thence along the east shore of Lower Pauness lake to the portage to Shell lake;
22 thence along said portage and the south shore of Shell lake to the portage to
23 Little Shell lake; thence through Little Shell lake to the portage to Lynx lake;
24 thence along the portage and through Lynx lake to the portage to Ruby lake;
25 thence along the portage and east and north along the south shore of Ruby
26 lake to the portage to Hustler lake; thence along the portage and the south
27 shore of Hustler lake to the portage to Oyster lake; thence along the portage
28 and the south shore of Oyster lake to the portage to Oyster river; thence along
29 the portage and southerly along the Oyster river to its junction with the Nina
30 Moose river; thence east along the Nina Moose river to its confluence with
31 Lake Agnes; thence along the south shore of Lake Agnes to the portage to
32 Boulder river; thence along the portage to and easterly along the Boulder
33 river to its confluence with the Dahlgren river; thence southerly along the
34 Dahlgren river to its confluence with Stuart lake; thence along the south shore
35 of Stuart lake to the portage to Nibin lake; thence along the portage and along
36 the south shore of Nibin and Bibon lakes to the portage to Sterling lake;
37 thence along the portage and the south shore of Sterling lake to Sterling
38 creek; thence easterly along Sterling creek to its confluence with the Beartrap
39 river; thence easterly and southerly along the Beartrap river through Sunday
40 lake to Beartrap lake; thence along the south shore of Beartrap lake to
41 Thunder lake; thence south along the west shore of Thunder lake to the
42 portage to Mud Hole lake; thence along the portage and through Mud Hole
43 lake to the portage to Gull lake; thence along the portage and the north shore

8 device, except that a hearing aid or other device designed to enhance hearing may be
9 used.

11 Subp. 4. **Game refuges open to taking turkeys.** The Lost Lake refuge in Fillmore
12 county, the Whitewater state game refuge in Winona county, the Minnetonka game
13 refuge in Carver and Hennepin counties, the Albert Lea and Moscow state game refuges
14 in Freeborn county, the Linn Lake state game refuge in Chisago county, the Rochester
15 state game refuge in Olmsted county, the Stearns county state game refuge in Stearns
16 county, the Claremont state game refuge in Dodge county, and the St. Croix River and
17 Stillwater game refuges in Washington county are open for the taking of turkeys during
18 open wild turkey seasons in the zones in which they are located.

 16 Watonwan county are open to goose hunting during the first three days of the regular

 19 the end of the goose season in the zone in which it is located, except there is no goose
 20 hunting within 100 yards of Fox and Temperence lakes.

21 C. The Harstad Slough waterfowl refuge in Stevens county is open to Canada
 22 goose hunting during the early September goose season. The Mud-Bardwell waterfowl
 23 refuge in Martin county is open to Canada goose hunting from November 1 to the end
 24 of the regular goose season, except there is no goose hunting within 100 yards of Mud
 25 and Bardwell lakes.

1 rights-of-way is prohibited in the Twin Cities Metro Canada Goose Zone during the late

4 Zone and the Fergus Falls/Alexandria Goose Zone and in Olmsted county during the
5 ten-day period beginning the second Saturday in December. Taking Canada geese on or
6 within 100 yards of all surface waters, excluding ice, is prohibited in the Twin Cities
7 Metro Canada Goose Zone during the late season.

8 **6240.2300 COMMON CROW SEASON.**

9 Subpart 1. **Open dates.** Common crows may be taken from July 15 through October
10 15 and from March 1 through March 31.
