1.2 **Adopted Permanent Rules Relating to License Reinstatement from the Minnesota**
1.3 **Board of Chiropractic Examiners**

1.4 **2500.1900 LICENSE REINSTATEMENT.**

1.5 A license terminated by reason of the licensee's failure to comply with the continuing
1.6 education requirements of parts 2500.1200 to 2500.2000, or failure to submit a completed
1.7 application for license renewal as prescribed by the board, may be reinstated or restored to
1.8 full status by following one of the applicable procedures in items A to E.

1.9 A. An applicant whose license has been terminated for a period of less than
1.10 five years, and who can verify continual practice elsewhere during that time, ~~may~~ shall be
1.11 reinstated by completing all interim continuing education and paying all interim licensure
1.12 fees that would have been required for continual licensure, paying any accrued penalty
1.13 fees established in part 2500.1100, subpart 3, and repairing any other deficiencies that led
1.14 to the termination.

1.15 B. An applicant whose license has been terminated for a period of greater
1.16 than five years and who can verify continual practice elsewhere during that time must,
1.17 in addition to following the procedures in item A, complete the board's jurisprudence
1.18 examination.

1.19 C. An applicant whose license has been terminated for a period of less than five
1.20 years, and who cannot verify continual practice during that time, ~~may~~ shall be reinstated
1.21 by completing all interim continuing education that would have been required for
1.22 continual licensure, completing an additional ten units of approved continuing education
1.23 for each intervening renewal year, paying all accrued penalty fees and interim licensure
1.24 fees required for continual licensure, and repairing any other deficiencies that led to the
1.25 termination.

2.1 D. An applicant whose license has been terminated for a period of greater
2.2 than five years, and who cannot verify continual practice during that time, ~~may~~ shall be
2.3 reinstated by paying all accrued penalty fees and interim licensure fees that would have
2.4 been required for continual licensure, repairing any other deficiencies that led to the
2.5 termination, taking the board's jurisprudence examination, and completing the Special
2.6 Purposes Examination in Chiropractic administered by the National Board of Chiropractic
2.7 Examiners, or other examination approved by the board.

2.8 E. At the election of the applicant, the board shall waive any of the continuing
2.9 education requirements in items A to C upon successful completion of the Special
2.10 Purposes Examination in Chiropractic administered by the National Board of Chiropractic
2.11 Examiners, or any other examination approved by the board, within 12 months preceding
2.12 the application.

2.13 Any continuing education units acquired in another jurisdiction for the purposes of
2.14 license renewal may be applied to item A, B, or C. None of the continuing education units
2.15 obtained for the purpose of reinstating a terminated license apply to the current annual
2.16 requirement. Applicants must complete a board-approved application for reinstatement.

2.17 **2500.2040 REINSTATEMENT OF INACTIVE LICENSE.**

2.18 An inactive license may be reinstated to an active license according to items A to E:

2.20 **2500.2110 REINSTATEMENT OF VOLUNTARILY RETIRED LICENSE.**

2.21 A. An applicant who has voluntarily retired a license may be reinstated or
2.22 restored to full status by:

2.23 (1) completing a board-approved application of reinstatement;

2.24 (2) paying a reinstatement fee in the amount of \$100;

3.1 (3) submitting a certification of good standing from each state the doctor
3.2 was granted a license; and

3.3 (4) following one of the applicable procedures in items B to F.

3.4 B. An applicant who has been voluntarily retired for a period of less than five
3.5 years, and who can verify continual practice elsewhere during that time, ~~may~~ shall be
3.6 reinstated by completing all interim continuing education and paying all accrued penalty
3.7 fees and interim licensure fees which would have been required for continual licensure,
3.8 and repairing any deficiencies that occurred prior to retirement.

3.9 C. An applicant who has been voluntarily retired for a period of greater
3.10 than five years who can verify continual practice elsewhere during that time must, in
3.11 addition to following the procedures in items A and B, complete the board's jurisprudence
3.12 examination.

3.13 D. An applicant who has been voluntarily retired for a period of less than five
3.14 years, and who cannot verify continual practice during that time, ~~may~~ shall be reinstated
3.15 by completing all interim continuing education that would have been required for
3.16 continual licensure, completing an additional ten units of approved continuing education
3.17 for each intervening renewal year, paying all accrued penalty fees and interim licensure
3.18 fees that would have been required for continual licensure, and repairing any deficiencies
3.19 that occurred prior to retirement.

3.20 E. An applicant who has been voluntarily retired for a period of greater than
3.21 five years, and who cannot verify continual practice during that time, ~~may~~ shall be
3.22 reinstated by paying all accrued penalty fees and interim licensure fees that would have
3.23 been required for continual licensure, repairing any other deficiencies that may have
3.24 occurred prior to retirement, taking the board's jurisprudence examination, and completing
3.25 the Special Purposes Examination in Chiropractic administered by the National Board of
3.26 Chiropractic Examiners, or any other examination the board may deem appropriate.

4.1 F. At the election of the applicant, the board shall waive any of the continuing
4.2 education requirements in items B to ~~E~~ D, upon successful completion of the Special
4.3 Purposes Examination in Chiropractic administered by the National Board of Chiropractic
4.4 Examiners, or other examination the board may deem appropriate, within the 12 months
4.5 preceding the application.

4.6 Any ~~hours~~ continuing education units acquired in another jurisdiction, for the
4.7 purposes of license renewal, may be applied to items B, C, and D. None of the continuing
4.8 education units obtained for the purpose of reinstating a voluntarily retired license apply to
4.9 the current annual requirement. Applicants must complete a board-approved application
4.10 of reinstatement.

4.14 Subp. 3. **Reinstatement.** Reinstatement of an emeritus status to an active license
4.15 status shall be done according to the reinstatement provisions of a voluntarily retired
4.16 license in part 2500.2110.
