1.6 or for electors for president and vice-president may vote by absentee ballot or in person
1.7 at the auditor's office in the county where the person formerly resided. The certificate of
1.8 eligibility on the back of the absentee ballot return envelope must be printed in the form
1.9 shown in subpart 2.

2.18 The envelope in which the absentee balloting materials are transmitted to the voter must

2.19 have the following printed on it: "Read and follow the enclosed instruction sheet to help

2.22 Subpart 1. **Required instructions.** Instructions to the absent voter shall be

2.23 transmitted with the absentee ballot materials sent or delivered to the absent voter. The

2.24 instructions shall be in the form in subparts 2, 3, or 4 or 5 and 6. The instruction headings

2.25 with numbers must be in no smaller than 12-point type and the rest of the text must be

2.26 in no smaller than 10-point type, except for the confidentiality notice, which may be

2.27 in 7-point type. The instructions must explain how to correctly mark the ballot. The

3.1 instructions must inform the voter of the effect of casting multiple votes for an office and,
 3.2 in the case of a partisan primary, the effect of voting for candidates of more than one
 3.3 party. The instructions must include information on how to correct a ballot before it is
 3.4 cast and counted, including instructions on how to request a replacement ballot if the
 3.5 voter is unable to change the ballot or correct an error. The instructions must include a
 3.6 graphic depiction of the absentee ballot materials and how they are to be completed and
 3.7 assembled by the voter. The secretary of state must provide each county auditor with
 3.8 sample instructions with graphic depictions.

32.16 must make a subsequent mailing of ballots to those voters who register to vote after the
32.17 initial mailing but before the 20th day before the election.

32.18 No ballot may be mailed to a challenged voter. A challenged voter may apply for
32.19 an absentee ballot.

32.20 The mail balloting process for voters whose registrations are incomplete under
32.21 Minnesota Statutes, section 201.061, subdivision 1a, or 201.121, must be administered
32.22 as if the voter were not registered to vote.

32.23 Ballots must be sent by nonforwardable mail. Ballots for eligible voters who reside in
32.24 health care facilities may be delivered as provided in Minnesota Statutes, section 203B.11.
32.25 The ballot mailing must be addressed to the voter at the voter's residence address as shown
32.26 on the registration file unless the voter completes an absentee ballot request as provided in
32.27 Minnesota Statutes, section 203B.04 or 203B.16.

33.1 A return envelope, a ballot secrecy envelope, and instructions for marking and
33.2 returning mail ballots must be included with the ballots. The instructions must include a

33.3 telephone number or electronic mail address which voters can call or write for help in mail
 33.4 voting. At the request of the secretary of state, a survey card that the voter can return to
 33.5 the secretary of state must also be included. The ballot return envelope must be printed
 33.6 with the mail voter's certificate. The ballot return envelope must be addressed for return to
 33.7 the county auditor, municipal clerk, or school district clerk that is conducting the election.

36.19 Subp. 5. **Nonregistered eligible voters.** An eligible voter who was not registered
 36.20 on the 21st day prior to the election may apply for and receive an absentee ballot.
 36.21 Absentee voting in precincts using mail balloting must be conducted under Minnesota
 36.22 Statutes, chapter 203B, except that the time for applying for, receiving, and returning
 36.23 absentee ballots is extended until 8:00 p.m. on the day of the election. The instructions
 36.24 to absentee voters must be those specified in part 8210.0500, subpart 3. The statement
 36.25 of absentee voter must be that specified in part 8210.0600, subpart 1b, or 8210.0800,

 37.5 to the voter at the address of registration must be securely retained. If the auditor,
 37.6 municipal clerk, or school district clerk is able to verify the voter's residence at that
 37.7 address, the ballot may be reissued. A ballot undeliverable to the voter at the address of

37.8 registration must be considered a returned notice of verification and the voter's registration
37.9 must be treated as provided in Minnesota Statutes, section 201.12. The official conducting
37.10 the election shall maintain a record of all undeliverable ballots.

37.11 If the ballot is returned by the post office with notification of the voter's new address

37.17 Subp. 8. **Returning ballots.** Mail ballots may be returned to the official conducting
37.18 the election by mail, in person, or by designated agent. The official conducting the
37.19 election must accept ballots returned in person, or by designated agent, until 8:00 p.m.
37.20 on the day of the election. An individual shall not be the designated agent of more than
37.21 three absentee or mail voters in one election.

37.22 Subp. 9. **Polling place and election judges.** The only polling place required for mail
37.23 balloting is the office of the election official conducting the election. The number of
37.24 voting stations set up in the office of the official conducting the election must be sufficient
37.25 to accommodate the number of voters expected to vote in person on election day. On
37.26 election day, the official conducting the election shall provide one or more secure drop
38.1 boxes where voters can deposit return envelopes containing ballots. The governing body
38.2 of the jurisdiction conducting the election shall designate a suitable location where the
38.3 election judges can meet on election day to receive and count ballots. The location must
38.4 be open for public observation of the counting of ballots. The governing body of the
38.5 jurisdiction conducting the election shall appoint election judges as provided in Minnesota
38.6 Statutes, sections 204B.19 to 204B.21. For state elections, the county auditor shall appoint
38.7 election judges for mail ballot precincts and shall apportion the cost of the election judges
38.8 among the precincts voting by mail in that election. The county auditor may delegate

38.9 the authority to appoint election judges for precincts voting by mail in state elections to
38.10 the municipal clerk. During the day of the election at least two election judges must be
38.11 present at the office of the official conducting the election to accept mail ballots delivered
38.12 in person and to process persons registering on election day. Additional judges may be
38.13 appointed as needed. If the ballots are to be counted by hand and there are more than
38.14 two questions or one office to be voted on, at least one judge must be appointed for the
38.15 counting of ballots for every 500 persons from whom ballots are expected to be returned.

38.16 Subp. 10. **Receiving and counting ballots.** On or before election day, the election
38.17 judges shall receive from the county auditor, municipal clerk, or school district clerk,
38.18 returned ballots and applications for absentee ballots, records of replacement ballots, and
38.19 the list of voters sent a second mailing of the ballot. The judges shall arrange to receive
38.20 from the election official any additional ballots received in the mail or returned by a voter
38.21 prior to 8:00 p.m. on election day. Ballots must be transported to the location where ballot
38.22 processing and counting will occur in a sealed transfer case by two or more election
38.23 judges. During the receiving and counting of ballots, the ballots must at all times remain
38.24 in the custody of two or more election judges of different major political parties, unless the
38.25 election is exempt from this requirement pursuant to Minnesota Statutes, section 205.075,
38.26 subdivision 4, or 205A.10, subdivision 2.

39.1 The secretary of state must provide a sample notice with a list of the possible reasons
39.2 that a mail ballot may be rejected. The election official must keep a record of the date
39.3 that the voter's ballot was rejected, the date the replacement ballot was issued to the voter,
39.4 and the reason that the previous ballot was rejected. Rejected envelopes must be kept in a
39.5 separate sealed container.

39.6 Subp. 11. **Challenges.** Challengers appointed under Minnesota Statutes, section
39.7 204C.07 may be present while the election judges are examining and accepting or rejecting
39.8 the return envelopes. Challenges must be made and determined as provided in Minnesota
39.9 Statutes, section 204C.13, subdivision 6.

39.10 Subp. 12. **Costs.** The governing body authorizing mail balloting shall pay the costs
39.11 of the mailing. Costs of mailing include postage costs and the costs of printing required
39.12 envelopes, instructions, affidavits, and mailing labels. Other expenses must be paid as
39.13 provided in Minnesota Statutes, section 204B.32.

39.14 Subp. 13. **Alternate forms.** The secretary of state may authorize the alternate use of
39.15 envelopes and other forms related to mail elections.

39.16 **REPEALER.** Minnesota Rules, part 8210.0730, subpart 2, is repealed.

39.17 **EFFECTIVE DATE.** These rules are effective for the 2012 state primary and any
39.18 elections held thereafter.
