

1.1 **Department of Natural Resources**1.2 **Adopted Permanent Game and Fish Rules: Northern Pike and Border Waters**1.3 **6262.0575 WATERS WITH RESTRICTIONS ON TAKING FISH.**

1.5 Subp. 3. **Conservation lakes.** While on or fishing in the following waters, the
 1.6 possession limit for sunfish is five, the possession limit for crappie is five, the possession
 1.7 limit for yellow perch is ten, the possession limit for walleye is two, and the possession
 1.8 limit for largemouth bass is one. A person's possession limit may not include more than
 1.9 one northern pike over 30 inches in length. The possession limit for northern pike is three.

1.14 Subp. 8. **Annie Battle Lake including inlets and outlets.** While on or fishing in the
 1.15 following waters, the daily and possession limit for sunfish is five and for black crappie
 1.16 is five. All black crappie in possession must be 11 inches or greater in length. All black
 1.17 crappie less than 11 inches in length must be immediately returned to the water. Angling
 1.18 for northern pike and largemouth bass is limited to catch and release only, whereby any
 1.19 northern pike or largemouth bass caught must be immediately returned to the water.
 1.20 Catch and release angling for northern pike and largemouth bass is legal during the open
 1.21 season for these species in inland waters. It is unlawful for anyone to have in possession,
 1.22 regardless of where taken, any northern pike or largemouth bass while on or fishing in
 1.23 the following waters. A person may not possess a motorized ice auger or electronic
 1.24 fish finding devices while on or fishing in the following waters. Electronic fish finding

2.1 devices include depth finders; fish finders; underwater videos or cameras; sonars; global
2.2 positioning systems; and temperature, oxygen, and pH meters.

2.15 Subp. 9. **Largemouth bass and northern pike catch and release and spearing**
2.16 **ban regulations.** While on or fishing in the following waters, angling for largemouth bass
2.17 and northern pike is limited to catch and release only, whereby any largemouth bass and
2.18 northern pike caught must be immediately returned to the water. Catch and release angling
2.19 for largemouth bass and northern pike is legal during the open season for these species in
2.20 inland waters. It is unlawful for anyone to have in possession, regardless of where taken,
2.21 any largemouth bass or northern pike while on or fishing in these waters. Spearing is
2.22 prohibited from December 1 to the last Sunday in February.

2.25 Subp. 10. **Black Bass Lake.** While on or angling in the following waters, the daily
2.26 and possession limit for sunfish is five and angling for northern pike and largemouth
2.27 bass is limited to catch and release only, whereby any northern pike or largemouth bass
2.28 caught must be immediately returned to the water. A person may not possess a motorized
2.29 ice auger or electronic fish finding devices while on or fishing in the following waters.

3.1 Electronic fish finding devices include depth finders; fish finders; underwater videos or
 3.2 cameras; sonars; global positioning systems; and temperature, oxygen, and pH meters.

3.5 Subp. 11. **Sunfish and crappie possession limits and catch and release fishing for**
 3.6 **northern pike and largemouth bass.** While a person is on or fishing in the following
 3.7 waters, the daily and possession limit for sunfish is ten and for crappie is five and fishing
 3.8 for northern pike and largemouth bass is limited to catch and release only, whereby any
 3.9 northern pike or largemouth bass caught must be immediately returned to the water.
 3.10 Catch and release fishing for northern pike and largemouth bass is legal during the open
 3.11 season for these species in inland waters. It is unlawful for anyone to have in possession,
 3.12 regardless of where taken, any northern pike or largemouth bass while on or fishing in
 3.13 the following waters.

3.17 Subp. 12. **Rochester Area Lakes regulations.**

3.18 A. The Rochester Area Lakes are the five waters listed in item C. Daily and
 3.19 possession limits provided in item B apply to the five waters listed in item C as a whole.

3.20 B. While a person is on or fishing in the Rochester Area Lakes:

3.21 (1) the daily and possession limit for sunfish, black crappie, white crappie,
 3.22 and yellow perch in aggregate is ten, of which not more than five may be black crappie or
 3.23 white crappie in aggregate;

3.24 (2) the daily and possession limit for largemouth bass and smallmouth bass
 3.25 in aggregate is one; and

4.1 (3) the daily and possession limit for northern pike is one.

4.14 angling in the following waters, angling is limited for all species to catch and release only,
4.15 whereby any species that are caught must be immediately returned to the water.
