1.4 **7861.0210 DEFINITIONS.**

1.6 Subp. 2b. **Bingo board.** "Bingo board" means a disposable sealed bingo placard that
1.7 is used as a bingo number selection device, containing 75 randomly placed bingo letter
1.8 and number combinations, using each of the numbers 1 through 75, under numbered seals.

1.10 ~~Subp. 10a. **CEO.** "CEO" means the person who has authority for an organization's~~
1.11 ~~management and operations according to the organization's bylaws, and:~~

1.12 ~~A. who has paid all dues to the organization;~~

1.13 ~~B. who is 18 years of age or older;~~

1.14 ~~C. who has voting rights on all organization issues;~~

1.15 ~~D. who has equal rights and responsibilities of attendance at the regularly~~
1.16 ~~scheduled meetings of the organization; and~~

1.17 ~~E. whose name and membership origination date appear with the CEO's~~
1.18 ~~knowledge and consent on a list of members of the organization.~~

1.19 Subp. ~~10b.~~ 10a. **Chance ticket.** "Chance ticket" means one of a predetermined
1.20 number of paper pull-tab tickets contained in a chance ticket display attached or adjacent
1.21 to the game flare which corresponds to the number of qualifying winning tickets in
1.22 a multiple chance game.

2.1 Subp. ~~10e.~~ 10b. **Chance ticket display.** "Chance ticket display" means the
2.2 tamper-resistant sealed, perforated, or covered display containing the chance tickets in
2.3 a multiple chance game.

2.4 [For text of subps 11 to 34, see M.R.]

2.5 Subp. 35. **Manufacturer's seal.** "Manufacturer's seal" means the sticker placed by
2.6 the manufacturer on the outside of the box or container of pull-tabs, tipboards, raffle
2.7 boards, or bingo boards but inside the shrink-wrap, ensuring that the game has not been
2.8 opened or tampered with before delivery to the organization.

2.10 Subp. 36a. **Multiple chance game.** "Multiple chance game" means a pull-tab game
2.11 in which qualifying winning tickets provide an option to the player to forfeit the qualifying
2.12 winning ticket in exchange for a chance ticket in the chance ticket display that provides a
2.13 chance to win a prize of lesser, equal, or greater value than the originally purchased ticket.

2.14 Subp. 37. **Multiple seal game.** "Multiple seal game" means a pull-tab or tipboard
2.15 game in which select tickets are redeemed by players for a prize amount under a seal
2.16 number matching the pull-tab ticket presented by the player or under a seal as determined
2.17 by the player.

2.19 Subp. 43a. **Raffle board.** "Raffle board" means a board containing spaces, each of
2.20 which serves as a certificate of participation for a player purchasing a chance in the raffle.

2.21 A. Raffle boards with stubs must contain uniform, detachable stubs that when
2.22 removed are placed in a container for the random drawing of a raffle winner.

2.23 B. Raffle boards without stubs may only use a board-approved alternative
2.24 method of selecting a raffle winner.

3.1 Subp. 44. **Random number generator.** "Random number generator" means a device
3.2 that has an automated method of selecting game symbols or producing game outcomes
3.3 based on a preset number of chances available for random selection.

3.5 B. The random number generator and random selection process must be
3.6 impervious to electromagnetic interference, electrostatic interference, radio frequency
3.7 interference, and other influences from outside the system or device that may affect the
3.8 game outcome. Recognized statistical tests used to determine whether or not the random
3.9 values produced by the random number generator pass the desired confidence level of
3.10 99 percent include:

4.5 Subp. 4. **Attachments to organization license application.** The organization must
4.6 attach the following to the application:

4.8 B. a copy of a charter of the parent organization, if chartered;

4.9 C. a membership list, signed by the organization's chief executive officer, with
4.10 the first and last names of at least 15 active members as defined in Minnesota Statutes,
4.11 section 349.12, subdivision 2, and date of membership;

4.12 D. an affidavit of the chief executive officer and treasurer, in a format prescribed
4.13 by the board;

4.14 E. for a 501(c)(3) organization or 501(c)(4) festival organization that chooses to
4.15 make lawful purpose contributions to itself, a copy of the organization's annual report on
4.16 income and expenses provided to the Internal Revenue Service, or in a format prescribed
4.17 by the board; and

4.18 F. a copy of the organization's by-laws, signed by the organization's chief
4.19 executive officer.

4.23 Subp. 3. **Education requirements.**

5.1 A. To qualify for a continuing license the gambling manager must complete a
5.2 continuing education class or complete the seminar required for initial gambling manager
5.3 licensure by the end of each calendar year as required by Minnesota Statutes, section
5.4 349.167, subdivision 4.

5.5 B. Proof of identification is required for persons taking a gambling manager
5.6 examination. Attendees at board-authorized seminars and continuing education
5.7 classes must be prepared to present as proof of identification a valid driver's license or
5.8 identification card issued by Minnesota, or a state or province of Canada contiguous to
5.9 Minnesota, that contains the person's photograph and date of birth.

5.11 **7861.0260 CONDUCT OF LAWFUL GAMBLING.**

5.13 Subp. 4. **Prizes awarded; records required.**

5.14 [For text of items A to J, see M.R.]

5.15 Subp. 5. **Prize receipts required.**

5.16 A. When a prize is awarded, the organization must complete a prize receipt in a
5.17 format prescribed by the board for the following:

5.18 [For text of subitems (1) and (2), see M.R.]

5.19 (3) a winning paper pull-tab or tipboard ticket valued at \$100 or more, or
5.20 for any prize for redeeming the last ticket sold in a paper pull-tab or tipboard game for
5.21 which the distributor has modified the flare to contain a last sale prize of \$20 or more. The
5.22 winning ticket, and winning seal tab if any, must be stapled to the prize receipt;

5.23 (4) cashing out an electronic linked bingo device with \$600 or more
5.24 in credits;

6.1 (5) cashing out an electronic pull-tab device with \$600 or more in credits;
6.2 and

6.3 (6) a paddlewheel prize valued at \$100 or more, and the winning ticket
6.4 must be stapled to the prize receipt.

6.5 B. A prize receipt must include at a minimum the following, in a legible
6.6 format and in ink:

6.7 [For text of subitems (1) to (4), see M.R.]

6.8 (5) the date and time the prize was won or, for electronic pull-tabs and
6.9 electronic linked bingo, the date and time credits of \$600 or more were cashed out;

6.10 [For text of subitems (6) to (8), see M.R.]

6.11 [For text of subp 6, see M.R.]

6.12 Subp. 7. **Return of defective paper pull-tab or tipboard game and raffle boards**
6.13 **to distributor or revenue.**

6.14 A. If, before being put into play, a paper pull-tab or tipboard game or raffle
6.15 board is determined not to be manufactured according to the standards in part 7864.0230,
6.16 the organization must return the game to the distributor. The game or raffle board must
6.17 be returned within seven business days of determining that the standards, including the
6.18 following, were not met:

6.19 (1) serial number or form number of the tickets or raffle board does not
6.20 match the serial number or form number on the flare or raffle board stubs;

6.21 (2) all tickets in a deal or raffle board stubs do not have the same serial
6.22 number in a deal;

6.23 (3) a pull-tab or tipboard game has the same serial number and form number
6.24 as another pull-tab or tipboard game manufactured by that manufacturer, or a raffle board

7.1 has the same serial number and form number as another raffle board manufactured by that
7.2 manufacturer, in the organization's inventory;

7.3 (4) geographic outline of the state of Minnesota as required by Minnesota
7.4 Statutes, section 349.163, subdivision 5, does not appear on the raffle board or on the
7.5 flare for that game;

7.6 (5) bar code required by Minnesota Statutes, section 349.163, subdivision
7.7 5, does not appear on the raffle board or flare for that game;

7.8 (6) prize amount on a pull-tab or tipboard ticket does not correspond to the
7.9 prize amount listed on the flare;

7.10 (7) pull-tab or tipboard ticket price does not correspond to the price listed
7.11 on the flare; or

7.12 (8) a game or raffle board was received from a distributor with the
7.13 manufacturer's seal broken.

7.14 B. If, during the play of a paper pull-tab or tipboard game or raffle board, the
7.15 game or board is determined not to be manufactured according to the standards in part
7.16 7864.0230, the organization must immediately remove the game or raffle board from play
7.17 and report it as a played game on the tax return.

7.18 (1) The organization must return the game or raffle board to the distributor
7.19 with documentation that the game does not meet the standards, including but not limited
7.20 to item A, subitems (4) to (7).

7.21 (2) For a game or raffle board not manufactured in compliance with item
7.22 A, subitem (1), (2), or (3), the organization must surrender the game or raffle board to the
7.23 commissioner of revenue.

7.24 C. If, after a paper pull-tab or tipboard game or raffle board is removed from
7.25 play, the game or raffle board is determined not to be manufactured according to the

8.1 standards in part 7864.0230, the organization must report the game or raffle board as
8.2 played on the tax return.

8.3 (1) The organization must return the game or raffle board to the distributor
8.4 with documentation that the game or raffle board does not meet the standards, including
8.5 but not limited to applicable standards in item A, subitems (4) to (7).

8.6 (2) For a game or raffle board not manufactured in compliance with item
8.7 A, subitem (1), (2), or (3), the organization must surrender the game or raffle board to the
8.8 commissioner of revenue.

8.9 D. The organization must keep any game or raffle board that is returned by
8.10 the distributor as a played game.

8.11 [For text of subp 8, see M.R.]

8.12 Subp. 8a. **Return of defective bingo boards.** Within seven business days of
8.13 determining that a bingo board was not manufactured according to part 7864.0230, the
8.14 organization must return the bingo board to the distributor with documentation that the
8.15 bingo board does not meet the standards.

8.16 [For text of subps 9 to 11, see M.R.]

8.17 **7861.0270 BINGO.**

8.18 [For text of subps 1 and 2, see M.R.]

8.19 Subp. 3. **Bingo equipment to be used.** An organization must comply with the
8.20 following for the conduct of bingo.

8.21 [For text of item A, see M.R.]

8.22 B. If a bingo board is used, the bingo board must be available for inspection and
8.23 be inspected by at least one player before a bingo occasion begins to determine that the
8.24 placard seals have not been altered or tampered with, and are free from defects.

9.1 C. Video cameras and monitors may be used.

9.2 D. An organization must maintain in sound working condition all equipment
9.3 used in the conduct of a bingo game.

9.4 E. Linked bingo paper sheets or facsimiles of linked bingo paper sheets must
9.5 not be included as part of a packet or package. All linked bingo paper sheets or facsimiles
9.6 of linked bingo paper sheets must be sold as a separate item.

9.7 F. An organization must not reserve bingo cards, bingo paper, or an electronic
9.8 bingo device for any person.

9.9 G. An organization must not use sets of bingo paper sheets or packets containing
9.10 identical faces during a single bingo game, except that identical faces may occur on sealed
9.11 bingo paper sheet faces during a breakopen bingo game. Identical faces may not occur
9.12 on facsimiles of sealed bingo paper sheet faces used with an electronic bingo device
9.13 during a breakopen bingo game.

9.14 H. Sealed paper sheets or facsimiles of sealed paper sheets must be used for
9.15 any bingo game for which, prior to the selection of the first bingo number, a person could
9.16 determine whether a particular bingo face is more likely to win the game than another
9.17 bingo face or more likely to win a higher alternative prize.

9.18 I. An organization or its employees or agents must not:

9.19 (1) duplicate or make copies of bingo hard cards or bingo paper;

9.20 (2) cut bingo paper sheets (case paper);

9.21 (3) separate or cut packets (collated paper); or

9.22 (4) break open any part of a bingo board, including seals, or otherwise alter
9.23 or tamper with a bingo board prior to the start of a game.

10.1 J. An organization with gross bingo receipts exceeding \$150,000 in its last fiscal
10.2 year, after any coupon discounts have been applied by the organization, may not use bingo
10.3 hard cards. This restriction does not apply to the use of Braille bingo hard cards.

10.4 K. An organization may permit a player who is legally blind to bring and use a
10.5 Braille or large print hard card. A Braille hard card must contain the letters and numbers
10.6 required by part 7861.0210, subpart 3, in a format that can be verified by sight by a person
10.7 who is not able to read Braille. An organization may disallow the use of a Braille or large
10.8 print hard card that does not comply with requirements for bingo hard cards or linked
10.9 bingo paper. For the use of a personal Braille or large print hard card, an organization
10.10 must charge a person who is visually impaired the same price charged for a bingo hard
10.11 card or bingo paper sheet face. Large print hard cards may not be used to participate in
10.12 electronic linked bingo games.

10.13 [For text of subps 3a to 5, see M.R.]

10.14 Subp. 6. **Beginning a bingo game.** A bingo game begins with the first letter and
10.15 number called.

10.16 A. Before the start of a bingo game, the bingo pattern or bingo game
10.17 requirement must be described and verbally announced to the players. In games where
10.18 players fill in the numbers on bingo paper sheet faces or facsimiles used with an electronic
10.19 bingo device, the numbers must correspond to the appropriate columns on a bingo paper
10.20 sheet face and the required pattern. Only the numbers 1 to 15 may be placed in the "B"
10.21 column, 16 to 30 in the "I" column, 31 to 45 in the "N" column, 46 to 60 in the "G"
10.22 column, and 61 to 75 in the "O" column. A bingo pattern or bingo game requirement may
10.23 not be completed with fewer than three bingo numbers having been drawn.

10.24 [For text of items B to D, see M.R.]

10.25 E. If a bingo board is used, the caller must do the following:

11.1 (1) sequentially open one seal on the bingo board, starting with the number
11.2 1; and

11.3 (2) immediately announce the letter and number revealed.

11.4 No additional windows may be opened after a winning bingo has been called and
11.5 verified, unless the game is a continuation game.

11.6 F. For bingo conducted with a bingo board, the caller must make sure that at
11.7 least two players are able to see the selected letter and number during the game.

11.8 G. If the bingo caller discovers a wrong number has been called, the caller must:

11.9 (1) announce that a wrong number has been called;

11.10 (2) call the correct number; and

11.11 (3) correct the flashboard, if used, and continue the game.

11.12 H. The letter and number selected must be called before the next bingo number
11.13 is selected, except when conducting a bingo game where the selected letter and number
11.14 do not pertain to the pattern being played.

11.15 I. In a bingo game with a pattern that does not require all available bingo
11.16 numbers, the caller must verbally state before the game begins that selected bingo numbers
11.17 not pertaining to the pattern will not be called.

11.18 [For text of subps 7 and 8, see M.R.]

11.19 Subp. 9. **Breakopen bingo game.** In addition to other requirements contained in this
11.20 part, a breakopen bingo game must also comply with the following.

11.21 [For text of items A to C, see M.R.]

11.22 D. If using a bingo board, the board or placard must be in view of players and
11.23 seals must be opened in numerical order or as indicated on the board or placard.

12.1 E. Sealed paper or facsimiles of sealed paper may be sold throughout the bingo
12.2 occasion. However, no sealed paper or facsimiles of sealed paper for the game may be
12.3 sold after the organization has resumed calling bingo numbers for the breakopen game.

12.4 F. After the predetermined quantity of bingo numbers has been called and
12.5 posted and immediately before the selection of the next bingo number, the caller must ask
12.6 if any player has completed the designated pattern or bingo game requirement.

12.7 (1) All players who complete the pattern or bingo game requirement within
12.8 the predetermined quantity of bingo numbers called are considered winners, regardless
12.9 of the last number called.

12.10 (2) If a player or players declare bingo based on the predetermined quantity
12.11 of numbers selected and the bingo is verified, the player or players must be awarded
12.12 the designated prize and the game ends.

12.13 (3) If no bingo is declared and verified, the organization must resume
12.14 calling bingo numbers until one or more players declare bingo, the bingo is verified, and
12.15 the designated prize or consolation prize is awarded.

12.16 G. Except for progressive breakopen bingo games, a breakopen bingo game
12.17 must be played at a bingo occasion until the game is completed.

12.18 H. An organization may allow players to trade in sealed paper. The organization
12.19 must account for the trade-in of sealed paper in the following manner.

12.20 (1) If a trade-in sealed paper is used, the organization must use two sets of
12.21 sealed paper for each game. One set, known as the "original set," must be a different color
12.22 than the second set, known as the "trade-in set."

12.23 (2) All sealed paper in the original set must be sold for the same price. All
12.24 sealed paper in the trade-in set must be sold for the same price as other sealed paper
12.25 in the trade-in set.

13.1 (3) After purchasing sealed paper from the original set, players may
13.2 continue to purchase sealed paper from the original set. Players may trade in sealed paper
13.3 from the original set for sealed paper from the trade-in set.

13.4 I. An electronic bingo device may be used with facsimiles of sealed bingo paper
13.5 for a breakopen bingo game. The organization may not allow trade-ins of facsimiles of
13.6 sealed bingo paper.

13.7 Subp. 10. **Linked bingo game.** In addition to other requirements in this part and
13.8 in conjunction with a licensed linked bingo game provider under parts 7863.0250 and
13.9 7863.0260, an organization must also comply with the following for the conduct of a
13.10 linked bingo game.

13.11 [For text of items A to I, see M.R.]

13.12 Subp. 11. **Bingo records and reports.** Bingo records and reports must be completed
13.13 in ink by the organization, and kept for 3-1/2 years following the end of the month in
13.14 which the occasion was conducted and reported on the tax return. Each organization using
13.15 bingo paper must maintain inventory records in a format prescribed by the board. Any
13.16 changes or amendments made to bingo records and reports must contain the initials, in
13.17 ink, of the person making the changes or amendments. With the exception of completed
13.18 prize receipt forms, coupons, and unplayed bingo boards, records and reports may be
13.19 maintained or converted and stored in an electronic format. Upon request, records and
13.20 reports must be made available in paper format to the board, the commissioner of revenue,
13.21 the commissioner of public safety, or their agents.

13.22 [For text of subps 12 to 21, see M.R.]

13.23 **7861.0280 PAPER PULL-TABS.**

13.24 Subpart 1. **Paper pull-tab restrictions.** In addition to the restrictions and
13.25 requirements in part 7861.0260, the following apply to the conduct of paper pull-tabs.

14.1 A. The pull-tab seller must not assist players in the selecting or opening of
14.2 purchased paper pull-tabs or in the selection of a chance ticket in a multiple chance game.

14.3 B. For multiple seal and multiple chance games, the seller must not allow a
14.4 player to physically touch the flare or chance ticket display. Once the player has selected a
14.5 seal or chance ticket, the pull-tab seller must open that seal or section of the chance ticket
14.6 display containing the chance ticket and hand the chance ticket to the player.

14.7 C. An organization must not award a prize for paper pull-tab tickets that were
14.8 sold by another organization.

14.9 D. An organization must not transfer games in play from one permitted
14.10 premises to another.

14.11 E. At a leased permitted premises, an organization must not transfer paper
14.12 pull-tab games in play between a booth and bar operation.

14.13 F. If an organization owns the permitted premises, the organization may transfer
14.14 paper pull-tab games in play between its booth and bar operation.

14.15 [For text of subp 1a, see M.R.]

14.16 Subp. 2. **Posting of information and paper pull-tab flare.** In addition to the
14.17 information required by part 7861.0260, subpart 2, an organization must post the flare for
14.18 each deal of paper pull-tabs in play.

14.19 [For text of items A to F, see M.R.]

14.20 G. If a multiple chance game is played, the chance ticket display must be
14.21 prominently visible when the game is in play.

14.22 [For text of subp 3, see M.R.]

15.1 Subp. 3a. **Operation of a multiple chance paper pull-tab game.** In addition to
15.2 the requirements of subpart 3, the following pertains to the conduct of multiple chance
15.3 paper pull-tab games.

15.4 A. The chance ticket display containing the chance tickets must be prominently
15.5 visible when the game is in play.

15.6 B. For multiple chance games, forfeiting a qualifying winning ticket for a
15.7 chance ticket is not a consideration.

15.8 C. When a qualifying winning ticket is presented to the pull-tab seller:

15.9 (1) the player must indicate in ink on the qualifying winning ticket whether
15.10 the player elects to:

15.11 (a) forfeit the qualifying winning ticket for a chance ticket; or

15.12 (b) redeem the prize indicated on the qualifying winning ticket;

15.13 (2) if the player chooses to forfeit the qualifying winning ticket, the player
15.14 may choose a chance ticket contained in the chance ticket display adjacent to the game
15.15 flare. The seller may not choose the chance ticket;

15.16 (3) the seller must open that section of the chance ticket display surrounding
15.17 the selected chance ticket and hand the chance ticket to the player; and

15.18 (4) the seller must staple the forfeited qualifying ticket to the chance ticket,
15.19 along with a prize receipt if required, and retain in the game's records for 3-1/2 years.

15.20 D. When the seller is away from the point of sale or the site is closed for
15.21 business, the chance ticket display must be secured.

15.22 E. The organization must immediately close a deal when there is compromised
15.23 security of the multiple chance game, tickets, flare, or chance ticket display.

16.1 F. Any chance tickets remaining in the chance ticket display at the close of the
16.2 game must remain sealed in the chance ticket display and be maintained with the game's
16.3 records for 3-1/2 years.

16.4 [For text of subps 4 to 6, see M.R.]

16.5 Subp. 7. **Use of a paper pull-tab dispensing device.** If a paper pull-tab dispensing
16.6 device is used, the organization must comply with the following.

16.7 [For text of item A, see M.R.]

16.8 B. An organization may not install or operate a paper pull-tab dispensing
16.9 device at a permitted premises that does not have a valid license for on-premises sales
16.10 of intoxicating liquor or 3.2 percent malt beverages, except as allowed by Minnesota
16.11 Statutes, section 349.151, subdivision 4b.

16.12 [For text of items C to L, see M.R.]

16.13 [For text of subps 8 to 10, see M.R.]

16.14 Subp. 11. **Paper pull-tab records and reports.**

16.15 [For text of items A and B, see M.R.]

16.16 C. With the exception of completed prize receipt forms, unsold and winning
16.17 tickets, chance tickets, and chance ticket displays containing any unopened chance tickets,
16.18 an organization may maintain or convert and store records and reports in an electronic
16.19 format.

16.20 [For text of items D and E, see M.R.]

16.21 F. For each deal of paper pull-tabs the organization must keep the flare, with
16.22 the bar code attached, and all redeemed and unsold pull-tabs separated by game serial
16.23 number. Commingled deals of paper pull-tabs that were commingled while in play must

17.1 be separated by game serial number after being removed from play. The organization must
17.2 not open any unsold or defective paper pull-tabs or chance tickets or chance ticket displays.

17.3 [For text of items G to J, see M.R.]

17.4 Subp. 12. **Disposal of paper pull-tab games and records.** The following items
17.5 apply to the disposal and destruction of paper games and records.

17.6 A. The organization must keep played paper pull-tab games, flares, prize pool
