FINAL ORDER ON REVIEW OF RESUBMITTED RULES UNDER MINN. STAT. § 14.16, SUBD. 2 AND MINN. R. 1400.2240, SUBP. 4

This matter came on for review by Chief Administrative Law Judge Jenny Starr pursuant to Minn. Stat. § 14.16, subd. 2 (2022) and Minn. R. 1400.2240, subp. 4 (2023). The proposed rules concern the Board of Cosmetologist Examiners' (Board) rules relating to education, licensing, and practice of cosmetologists and other licensed professionals in the beauty industry.

By Order dated July 31, 2023, the Chief Administrative Law Judge approved the Board's proposed rules as to legality but ordered the Board to amend its proposed Order Adopting Rules to comply with Minn. R. 1400.2090 (2021).¹

On August 7, 2023, the Board resubmitted its proposed Order Adopting Rules. The Board identified in its Order Adopting Rules the changes made to the proposed rules and indicated when the Board adopted the current version of the proposed rules as required by Minn. R. 1400.2090.

The Chief Administrative Law Judge finds that all defects and procedural errors identified in the prior orders have now been corrected. Therefore, based upon a review of the Board's submissions and the rulemaking record,

IT IS HEREBY ORDERED THAT:

The Board may proceed with publishing the notice of rule adoption in the *State Register* pursuant to Minn. Stat. § 14.18 (2022) and Minn. R. 1400.2240, subp. 10 (2023).
