This matter came before Administrative Law Judge Christa L. Moseng upon the application of the Minnesota Department of Natural Resources (Department) for a legal review under Minn. Stat. § 14.386 (2022).

On December 26, 2023, the Department filed documents with the Office of Administrative Hearings seeking review and approval of the above-entitled rules under Minn. Stat. § 14.386 and Minn. R. 1400.2400 (2023).

Based upon a review of the written submissions by the Department of Natural Resources,

## IT IS HEREBY DETERMINED THAT:

- 1. The rules were adopted in compliance with the procedural requirements of Minnesota Statutes, Chapter 14 (2022), and Minnesota Rules, Chapter 1400 (2023).
- 2. According to Minn. Stat. § 14.388, subd. 1(3), and Minn. Laws 2023, ch. 60, art. 4 §§ 98, subds. 1 and 2, and 103 (a), the Department of Natural Resources has the statutory authority to adopt these proposed rules using the exempt rulemaking process.
