This matter came before Administrative Law Judge Christa L. Moseng upon the application of the Minnesota Board of Cosmetologist Examiners (Board) for a legal review under Minn. Stat. § 14.386 (2022).

On June 25, 2024, the Board filed documents with the Office of Administrative Hearings seeking review and approval of the above-entitled rules under Minn. Stat. § 14.386 and Minn. R. 1400.2400 (2023).

Based upon a review of the written submissions by the Board, and for the reasons set out in the Memorandum which follows below,


IT IS HEREBY DETERMINED THAT:
