ORDER ON REVIEW
OF RULES UNDER
MINN. STAT. § 14.388
AND MINN. R. 1400.2400

This matter came before Administrative Law Judge Ann C. O'Reilly upon the request of the Minnesota Department of Commerce (Department) for a legal review of the above-entitled rules under Minn. Stat. § 14.388 (2022) and Minn. R. 1400.2400 (2023).

On May 20, 2024, the Department filed documents with the Office of Administrative Hearings seeking review and approval of the above-entitled rules under Minn. Stat. § 14.388 and Minn. R. 1400.2400.

On May 13, 2024, the Department served a Notice of Submission of Rules Proposed for Adoption Without a Public Hearing (Notice): (1) by U.S. mail on 69 subscribers listed on its agency rulemaking list; and (2) by email on 108 subscribers listed on its agency rulemaking list.

The deadline for filing comments expired at the end of the day on May 28, 2024. No written comments were received. The rulemaking record closed at the expiration of the comment period.

Based upon a review of the written submissions by the Department,

IT IS HEREBY DETERMINED THAT:

- 1. The Department has the statutory authority to adopt the rules under Minn. Stat. §§ 80A.82 and 80C.18 (2022).
- 2. The proposed amendments to Minn. R. 2860.1200, subp. 4, 2860.2200, and 2860.2500, subp. 1, incorporate specific changes made to statutes in 1991 Minn Laws ch. 233, §§ 45, 46, and 47 (amending Minn. Stat. §§ 80C.04, subd. 1, 80C.07, and 80C.08, subd. 1), and require no interpretation of law.
- 3. The proposed amendments to Minn. R. 2876.4050, subp. 2, 2876.4061, subp. 2, and 2876.4117, subps. 1, 4 change references to "Part II" to "Part 2", consistent with changes to the United States Securities and Exchange Commission (SEC) Form ADV made in 2010. These changes that do not alter the sense, meaning, or effect of the rules.

- 4. Accordingly, the Department may use the good cause exemption process for amending the rules set forth in Minn. Stat. §§ 14.386 and 14.388, subd. 1(3) and (4), and Minn. R. 1400.2400.
- 5. The rule amendments comply with the procedural requirements of Minn. Stat. §§ 14.388, and Minn. R. 1400.2100 A, D, E, F, G and 1400.2400 (2023).
- 6. The Department has complied with all procedural requirements of law and rule necessary to proceed with good cause exempt rulemaking.

IT IS HEREBY ORDERED THAT:

The proposed exempt rule amendments are **APPROVED.**
